Your Committee on Intrastate Commerce, to which was referred
S.B. No. 2201, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO BOARDS,"

begs leave to report as follows:

The purpose of this measure is to rename the State Board of
Chiropractic Examiners, Board of Dental Examiners, Board of
Examiners in Optometry, and Board of Veterinary Examiners as the
Hawaii Board of Chiropractic, Board of Dentistry and Dental
Hygienists, Hawaii Board of Optometry, and Hawaii Board of
Veterinary Medicine, respectively, to more accurately reflect
their scope and duties.

The Oahu County Committee on Legislative Priorities of the
Democratic Party of Hawaii and numerous concerned individuals
supported the measure. The Professional and Vocational Licensing
Division of the Department of Commerce and Consumer Affairs, Board
of Dental Examiners, and Hawaii Dental Hygienists' Association
submitted comments.

Your Committee has amended this measure by:

- (1) Renaming the Board of Dental Examiners as the Board of
Dentistry;



- (2) Changing its effective date to July 1, 3000, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Intrastate Commerce that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 2201, S.D. 1, as amended herein, and recommends that it pass Second Reading in the form attached hereto as S.B. No. 2201, S.D. 1, H.D. 1, and be referred to your Committee on Consumer Protection & Commerce.
