Your Committee on Veterans, Military, & International Affairs, & Culture and the Arts, to which was referred S.B. No. 2887, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO INTERNATIONAL AFFAIRS,"

begs leave to report as follows:

The purpose of this measure is to acknowledge the many social, cultural, and economic ties that Taiwan has with Hawaii, as well as the numerous contributions that Taiwan has made to Hawaii, by appropriating funds for events recognizing the twentyfifth anniversary of the sister-state relationship between Hawaii and Taiwan.

The Department of Business, Economic Development and Tourism and Oahu County Committee on Legislative Priorities of the Democratic Party of Hawaii testified in support of this measure.

Your Committee has amended this measure by changing its effective date to June 15, 1215, to facilitate further discussion.

As affirmed by the record of votes of the members of your Committee on Veterans, Military, & International Affairs, & Culture and the Arts that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No.




