Your Committee on Finance, to which was referred S.C.R. No. 19, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE AMENDMENT OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT KAHALA, HONOLULU, OAHU, FOR THE SEAWALL AND STEPS, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON, "

The purpose of this measure is to authorize the amendment of a term, non-exclusive easement covering a portion of state submerged lands at Kahala, Honolulu, Oahu, for the seawall and steps, and for use, repair, and maintenance of the existing improvements constructed thereon.
