The purpose and intent of this measure is to request the  
United States Congress to make permanent the authority of the  
Native Hawaiian Health Care Improvement Act, with all of the  
funding resources necessary to effectuate its stated policy of  
raising the health status of Native Hawaiians to the highest  
possible health level.

Your Committee received written comments in support of this  
measure from the University of Hawaii System, Hawaiian Civic Club  
of Honolulu, and Oahu County Committee on Legislative Priorities  
of the Democratic Party of Hawai'i.

Written comments in opposition were received from the Center  
for Hawaiian Sovereignty Studies.


Your Committee finds that this measure will help to provide
