The purpose and intent of this measure is to authorize the
Board of Land and Natural Resources to issue a term, non-exclusive
easement covering a portion of state submerged lands fronting
property located in Spreckelsville, Wailuku, Maui, for the
existing seawall and boulder revetment and for the use, repair,
and maintenance of the existing improvements.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources.

Your Committee finds that this measure expresses the
requisite legislative approval so that an easement may be issued
for the use of state submerged lands.

Committee on Ways and Means that is attached to this report, your



Committee concurs with the intent and purpose of S.C.R. No. 80, S.D. 1, and recommends its adoption.


