RELATING TO NONPROFIT CORPORATIONS.

CPC/JUD, FIN

Amends the Hawaii Nonprofit Corporations Act to: clarify that a public benefit corporation may not purchase its memberships; clarify that the term "director" only includes those who have the authority to vote as a member of a board; clarify that a corporation with members may provide for appointment by some other person, or designation, of some of its directors; and allow the attorney general more time to review a proposed sale of substantially all of the assets of a corporation, other than in the regular course of its activities. DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:
