RELATING TO ENERGY.

EDB/EEP, FIN

Authorizes the Hawaii Technology Development Corporation to provide 50% matching grants to Hawaii awardees of alternative energy research grants from the Office of Naval Research. Makes appropriations.

DECISION MAKING TO FOLLOW


