RELATING TO EDUCATION.

EDN/HED, FIN

Requires the Department of Education to: (1) develop and implement a statewide computer science curricula plan for public schools; and (2) permit students to fulfill some graduation requirements through computer science coursework. Appropriates moneys to the Department of Education. Requires the University of Hawaii to permit applicants to fulfill certain admission requirements through computer science coursework. (SD2)

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.


