Status

RELATING TO ZERO-EMISSION VEHICLES.
Requires rental motor vehicle lessors with more than two hundred light duty passenger vehicles, to expedite the incorporation of at least fifty per cent of zero-emission vehicles into the lessor's fleet by 2030. Requires all rental motor vehicle lessors to report a list of the make, model, license plate number, and fuel type of each rental motor vehicle in the lessor's fleet to the Director of Commerce and Consumer Affairs. Effective 7/1/2050. (SD2)


