PROPOSING AN AMENDMENT TO ARTICLE X, SECTION 6, OF HED, JUD, FIN  
THE HAWAII STATE CONSTITUTION, TO MODIFY THE  
APPOINTMENT PROCESS FOR THE BOARD OF REGENTS OF  
THE UNIVERSITY OF HAWAII.  
Proposes an amendment to article X, section 6, of the Hawaii State  
Constitution to modify the appointment process for the board of  
regents of the University of Hawaii. Repeals reference to the candidate  
advisory council for the board of regents of the University of Hawaii.

DECISION MAKING TO FOLLOW


