SB 2145 Status & Testimony	RELATING TO VACANCIES. Amends the deadlines for filing nomination papers, nominations, and notification to the chief election officer with respect to a vacancy in the state senate.	JDC
SB 2180 Status & Testimony	RELATING TO LESSER INCLUDED OFFENSES. Clarifies the definition of an included offense to expressly include offenses charged via felony complaint.	JDC
SB 2344 Status & Testimony	RELATING TO AUTOMATIC RESTRAINING ORDERS. Automatically imposes a restraining order upon parties filing for annulment, divorce, or separation to preserve the financial assets of the parties and their dependents.	JDC
SB 2582 Status & Testimony	RELATING TO EXTENDED TERMS OF IMPRISONMENT. Adds certain cases of negligent homicide to the felonies that may be subject to an extended term of imprisonment.	JDC
SB 2666 Status & Testimony	RELATING TO SUSTAINABLE DEVELOPMENT GOALS. Codifies sustainable development goals based on the United Nations' Global Goal five, gender equality.	JDC, WAM
SB 2671 Status & Testimony	RELATING TO SUSTAINABLE DEVELOPMENT GOALS. Codifies sustainable development goals based on the United Nations' Global Goal ten, reducing inequalities.	JDC, WAM
SB 2677 Status & Testimony	RELATING TO SUSTAINABLE DEVELOPMENT GOALS. Codifies sustainable development goals based on the United Nations' Global Goal sixteen, relating to peace, justice, and strong institutions.	JDC, WAM
