HB 1646, HD1 (HSCR775-18) Status & Testimony	RELATING TO MEMBERS OF CONGRESS. Provides that when a candidate other than the incumbent is elected to the office of United States senator, and the incumbent vacates the office prior to the expiration of the incumbent's term, the Governor must temporarily appoint the member-elect to immediately fill the vacancy for the unexpired term. HB 1770, HD1 (HSCR776-18) Status & Testimony	MAKING AN APPROPRIATION TO THE DEPARTMENT OF THE PROSECUTING ATTORNEY OF THE CITY AND COUNTY OF HONOLULU. Appropriates funds to the Department of the Prosecuting Attorney of the City and County of Honolulu for the career criminal prosecution unit. (HB1770 HD1)	JDC, WAM
HB 1774, HD1 (HSCR777-18) Status & Testimony	RELATING TO COLLECTION OF RESTITUTION FOR CRIME VICTIMS. Establishes standards and procedures for withholding income to pay restitution orders. Appropriates funds to the Department of the Attorney General for enhancing restitution collection. (HB1774 HD1)	JDC, WAM
HB 2051, HD1 (HSCR1037-18) Status & Testimony	RELATING TO THE WEED AND SEED STRATEGY. Appropriates funds for grants to maintain the weed and seed strategy, which is a collaborative effort to reclaim, restore, and rebuild communities. (HB2051 HD1)	JDC, WAM
HB 2418, HD1 (HSCR1038-18) Status & Testimony	RELATING TO FUNDS USED FOR THE SETTLEMENT OF CLAIMS. Authorizes the Department of Education to expend previously appropriated funds to satisfy the settlement of class counsel attorney's fees related to a class action lawsuit against the State. <p>HB 1667, HD1 (HSCR442-18) Status & Testimony</p>	<p>RELATING TO PROBATION. Makes a housekeeping amendment to clarify that eligibility for probation does not apply to certain drug paraphernalia violations that have been decriminalized. (HB1667 HD1)</p>	<p>JDC</p>
<p>HB 1850, HD1 (HSCR883-18) Status & Testimony</p>	<p>RELATING TO PORNOGRAPHY. Clarifies that the offense of promoting pornography for minors does not apply to a legal guardian of a minor. (HB1850 HD1)</p>	<p>JDC</p>
<p>HB 1851, HD2 (HSCR1066-18) Status & Testimony</p>	<p>RELATING TO PORNOGRAPHY. Defines "in loco parentis" for purposes of exemption under Hawaii's obscenity laws. (HB1851 HD2)</p>	<p>JDC</p>
<p>HB 1852, HD1 (HSCR884-18) Status & Testimony</p>	<p>RELATING TO PORNOGRAPHY. Clarifies that the prurient interest referenced in the definition of "pornographic for minors" does not relate specifically to the minor. (HB1852 HD1)</p>	<p>JDC</p>
<p>HB 2134, HD1 (HSCR893-18) Status & Testimony</p>	<p>RELATING TO VIOLATION OF PRIVACY. Amends the offense of violation of privacy in the first degree to prohibit threats or acts to disclose an image or video. Enhances the penalty if the person or persons entitled to privacy or the depicted person is a minor. Requires that any recording or image made or disclosed be sealed and remain confidential. <p>HB 2455, HD1 (HSCR873-18) Status & Testimony</p>	<p>MAKING AN APPROPRIATION TO THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM FOR THE 2018 GANNENMONO CELEBRATION. Makes an emergency appropriation to the Department of Business, Economic Development, and Tourism for the 2018 gannenmono celebration. (HB2455 HD1)</p>	<p>JDC, WAM</p>
