RELATING TO LAW ENFORCEMENT.

LAB/PBS, FIN

Establishes one full-time equivalent lieutenant position in the Kona unit of the sheriff division within the department of public safety. Appropriates funds for the initial six-month hiring period and for one-time costs for the purchase of position-related uniforms and equipment. Effective 7/1/2050. (SD1)

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.


