<u>HB 1977, HD2</u> <u>(HSCR995-18)</u> <u>Status & Testimony</u>	RELATING TO FLOOD MITIGATION. Requires the Hawaii Emergency Management Agency to develop strategic regional flood plans. (HB1977 HD1)	PSM/WTL, WAM
<u>HB 2259, HD1</u> <u>(HSCR1021-18)</u> <u>Status & Testimony</u>	RELATING TO MARINE EVENTS. Requires the Department of Land and Natural Resources to allow applications for marine event permits up to one year in advance and to adopt rules to mitigate hazards posed by vessels, thrill craft, drones, and other means used by spectators to observe or record marine events. Requires a report to the 2019 Legislature. (HB2259 HD1)	WTL/PSM
<u>HB 2539, HD1</u> <u>(HSCR792-18)</u> <u>Status & Testimony</u>	RELATING TO PLANNED COMMUNITIES. Requires the counties to designate an agency to inform the public and hold a hearing when lands included in a community master plan are proposed for sale and intended to be used for a purpose other than as proposed in the master plan. (HB2539 HD1)	PSM/WTL, WAM
