Executive Profile

Retired major of the Honolulu Police Department, Narcotics/Vice Division. Currently the Hawaii Law Enforcement Coordinator (LEC) for the Western States information Network (WSIN). WSIN is one of six regional projects under the federally funded Regional Information Sharing System (RISS). RISS is managed through the Bureau of Justice Assistance Program and funded through congressional appropriation.

The Western States Information Network's mission is to assist local, state, federal, and tribal criminal justice partners by providing adaptive solutions and services that facilitate information sharing, support criminal investigations, and promote officer safety.

WSIN Hawaii office is located at the Hawaii High Intensity Drug Trafficking (HIDTA) program within their Investigative Support Center. Also within the same office floor is the Honolulu Police Department Narcotics/Vice Division and 12 Federal and State HIDTA Drug Investigative Task Forces.

- Plans and coordinates all necessary liaison functions which are required for the establishment, maintenance, and improvement of a viable criminal intelligence information sharing program for Hawaii WSIN law enforcement member agencies.
- Meets with and visits local chiefs of police, sheriffs, district attorneys, task force commanders, and operative officers and provides orientation and other training and liaison to explain WSIN's role in the exchange of intelligence information and other federally funded services.

The board develops a yearly drug threat assessment for the state of Hawaii and through joint federal, state and local enforcement and intelligence task forces, addresses those threats through enforcement strategies. The HIDTA also has a demand reduction component.
