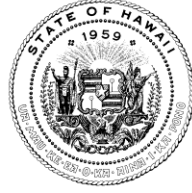

Good afternoon Chair Tokuda, Vice Chair English and members of the Committee on Labor. I am Allicyn Tasaka, Executive Director of the Workforce Development Council (WDC) testifying in strong support of Michael Kamiya's confirmation to the WDC for a term to expire on June 30, 2020 (GM 568). Mr. Kamiya would fill a slot reserved for a workforce private sector member on the Council.

The WDC is an attached agency to the Department of Labor and Industrial Relations and advises the Governor and Legislature on workforce development to support economic development and employment opportunities for employers and employees.

The WDC is responsible for the administrative oversight and implementation of a federally mandated initiative, the Workforce Innovation and Opportunity Act of 2014 or WIOA. WDC is tasked with strategic planning and developing the infrastructure for a seamless common intake and referral system at the American Job Centers (or One-Stop Centers) so job seekers and employers can maneuver through the workforce system efficiently and receive employment, education, training and support services throughout the State. It's a "no wrong door" approach to workforce development.

Mr. Kamiya is Sales Director of Kamiya Gold, Inc., which is his family's papaya farm in Hauula. He oversees all sales aspects and distribution of fresh papayas and works directly with

customers and vendors to ensure customer satisfaction. He also oversees accounting and bookkeeping responsibilities, and manages employees for production and sales distribution.

Mr. Kamiya also has experience with customer service in the printing industry having worked at Hagadone Printing Company for 11 years, as well as marketing and public relations background with Bright Light Marketing Group.

Mr. Kamiya serves as a member of the Employer Engagement committee where his background will serve this committee well as he is part of sub-group to develop a marketing and branding strategy directed at educating and public awareness of the State's workforce services to employers and businesses. He shared with the committee members that his company has hired the homeless and ex-offenders. These are a few of the groups with barriers to employment that the federal law has targeted to assist.

Also, Mr. Kamiya is a third-generation young farmer operating a longtime family business. He brings a Generation Y diversity and youthful perspective to the WDC.

I respectfully urge you to confirm Mr. Kamiya as a member of the Workforce Development Council where he would be able to share his small business knowledge and skills of the agriculture industry to benefit the future of Hawaii's workforce.
