Dear Senator Baker:

I am honored to support the reappointment of Dr. Katharyn Daub to the Hawaii State Board of Nursing. I have known Dr. Daub as one of the outstanding members of the International Transcultural Nursing Society and worked with her closely as a Consultant for the development of the Doctor of Nursing Practice (DNP) program at UH Hilo School of Nursing. I have been a lecturer for this program since it opened.

Dr. Daub has extensive knowledge of the Hawaiian people and spent much of her professional career serving the diverse population of the state. Through her visionary leadership, UHH School of Nursing has become the first school in the country with a transcultural nursing focus and graduates of this program are prepared in culturally competent care. This focus is particularly significant to the diverse and underserved racial and ethnic populations of Hawaii. Later, culturally competent care has been mandated by national stakeholders such as the American Association of Colleges of Nursing, National League for Nursing and the Department of Health and Human Services for all nursing educational programs and practitioners. The Office of Minority Health identified culturally and linguistically appropriate care as key to eliminating population health disparities.

As an advocate for improving access to health care by underserved populations in Hawaii County, Dr. Daub collaborated with stakeholders and community leaders from her local community, statewide and nationwide to establish the DNP program to graduate doctorally-prepared nurses who will assume the role of primary health care providers. Graduates of this program will impact access to quality care and improve the population health in underserved rural areas of Hawaii County and the state.

Dr. Daub was inducted as a Transcultural Nursing Scholar (TNS), an international organization of experts engaged in advancing culturally competent care and health equity particularly for vulnerable racial/ethnic and poor populations. As a Transcultural Nursing Scholar, Dr. Daub's scholarship and leadership in nursing education, research and practice are validated by her peers nationally and globally.

I observed first hand Dr. Daub's capacity to forge multidisciplinary and multisectoral partnerships to gain support for the school's initiatives such as the creation of the DNP program. She has the breadth of knowledge of nursing and health care as well as the depth of understanding of the local and national contexts of policies and regulations impacting nursing and health care. She has a vast network of professional and community connections that are critical to policy development, implementation and evaluation. She is widely respected by her colleagues, alumni, students and community members. Her overall positive attributes enable

her to reach diverse individuals and groups, which are significant to effective collaboration and continued mutual engagement. In addition, her expertise in distance learning will be significant in designing educational modules for implementation of the State Board's initiatives and in promoting wide dissemination of policies and regulations from the Board. These qualities and capacities make her ideal to be a State Board Member.
