The Department of Land and Natural Resources (Department) supports Governor's Message 671, nominating Mr. Charles Ehrhorn to the Island Burial Council, Island of O'ahu expiring June 30, 2019.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. The Councils determine whether to preserve in place or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Mr. Ehrhorn is a resident of Honolulu and a graduate of Punahou School. He has a B.A. in Architecture (University of Oregon) and a Master of Regional Planning (Cornell). Mr. Ehrhorn brings with him a comprehensive background in land planning, site planning and urban design (Campbell Estate). He is a consultant with C&J Land Planning, LLC, where he provides land and site planning and design for a variety of clients including Avalon Development, James Campbell Company, LLC and Helbert Hastert & Fee Planners. More importantly, Mr. Ehrhorn previously served on the Oʻahu Burial Council where he showed great leadership and won the respect of his fellow members.

Senate confirmation will ensure that Mr. Ehrhorn's esteemed knowledge and perspective emerges during the deliberations of the O'ahu Island Burial Council until June 30, 2019.
