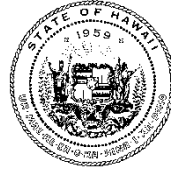

Mr. Amemiya serves as Senior Vice President of Island Holdings, the parent company of Island Insurance, has been a member of the Stadium Authority since 2015. At Island Holdings which also owns Atlas Insurance Agency, IC International and Tradewind Capital Group, he is responsible for the company's risk management practices in addition to handling legal and regulatory compliance. Previously, Mr. Amemiya served as the Executive Administrator and Secretary of the Board of Regents for the University of Hawaii System.

Mr. Amemiya's extensive professional career includes serving as the Executive Director of the Hawaii High School Athletic Association (HHSAA) for nearly 12 years where he led the Save the Sports fundraising campaign, created the two classification (large/small school) state championship format, and more than doubled the amount of state championships held annually. He also was an attorney with Paul, Johnson, Park & Niles and Bays, Deaver, Hiatt, Kawachika & Lezak law firms.

Mr. Amemiya's professional background and involvement in Hawaii's sports community are an asset to the Stadium Authority and the State of Hawaii.
