TESTIMONY ON HOUSE BILL 1834, RELATING TO EMERGENCIES

Before the House Committee on PUBLIC SAFETY

Aloha Chair Takayama, Vice-Chair Gates, and the Members of the Committee.

HB 1834 appropriates \$100,000 to the Department of Defense for the installation of new outdoor sirens in the Salt Lake area of Honolulu. The Hawaii Emergency Management Agency (HI-EMA) offers the following comments:

- Much of the siren coverage in the Salt Lake area was being provided by 7 each US
 Army outdoor sirens located on Tripler Army Hospital, Aliamanu Military Housing, and
 Fort Shafter Flats areas. The Army was unable to maintain their fleet of siren equipment
 and turned them off in 2015.
- The State has conducted a site visit to the Salt Lake area to supplement the single siren located at Salt Lake District Park. This initial assessment shows the need to add 4 additional sirens to effectively cover the entire Salt Lake area. Since each siren costs approximately \$100,000 the amount identified by the HB 1834 would be insufficient.
- The ongoing Statewide Siren Modernization CIP Project which is part of the administration's budget is based on the need to upgrade existing sirens which are not logistically supportable, and the requirement to add sirens in areas where siren coverage is lacking.
- Since the state modernization project did not include upgrading or adding sirens in the Salt Lake area, these additional sirens will need to be added to the ongoing project.
- Funding for the modernization project is done in annual partial increments each biennium. Priority of effort remains on tsunami inundation zones, followed by nontsunami zones.
- It should be emphasized that the outdoor siren system is only one part of a three-part
 public alert/notification system that also includes the wireless emergency alert system
 (iPhone/cell) and the emergency alert system (TV and radio broadcast).
