Testimony in STRONG SUPPORT

On behalf of the Alzheimer's Association, Aloha Chapter, we STRONGLY SUPPORT HB 1916 HD2 SD1 that requires the Executive Office on Aging to implement and update the State Plan on Alzheimer's Disease and related dementias with a necessary appropriation to do such.

Alzheimer's Disease and related dementias has become an urgent public health issue in America and Hawaii.

- The burden is large as there are approximately 5.5 million people in America, or 1 in 10 Americans aged 65 and older; with about 28,000 in Hawaii living with the disease. By 2025 the burden grows larger as it is projected that 35,000 Hawaii residents will have the disease.
- There is a major impact on the community as there are approximately 66,000 unpaid family caregivers of the disease in Hawaii. These caregivers provide an estimated 20 hours per week of care and 75 million hours per year. The Medicaid costs for caring for Hawaii residents in 2017 is estimated at \$196 million.
- In Hawaii, the Medicaid costs to care for people with Alzheimer's are expected to amount to \$207 million in 2018. This cost is expected to grow by 35.4% percent over the next seven years (by 2025).
- It is the sixth leading cause of death in the nation. 1 in 3 Hawaii kupuna will die from the disease. The number of people affected will continue to rise as the baby boomers grow older.
- Intervention is possible, but largely has not happened. The issues were identified in the Hawaii Alzheimer's Desease and Related Dementias State Plan released by the Department of Health in 2014.

Unfortunately, the State Plan has been sitting on the shelf for four years The next step is to implement the Plan by translating the recommendations into actual policies and see that it is carried out. Hawaii will need to enact legislation and develop regulations to improve dementia capability. The last step focuses on executing the programs and enforcement of policies outlined in the State Plan and mandated through legislative and regulatory change.

We urge you to pass this bill. Doing so will allow the Executive Office on Aging to enact legislation, develop regulations, and execute programs. The alternative is to do nothing and wait to the absolute last minute when the sheer number of people with dementia and Alzheimer's overwhelms Hawaii.

Good morning, my name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") on Legislative Priorities of the Democratic Party of Hawaii ("DPH"). Thank you for the opportunity to provide written testimony on **HB1916 HD2 SD1** relating to Alzheimer's Disease and Related Dementias; State Plan Updates; Executive Office on Aging; and an appropriation.

(Platform of the DPH, P. 7, Lines 382-384 (2016)).

As **HB1916 HD2 SD1** requires the executive office on aging to biennially update the state plan on Alzheimer's disease and related dementias, include an implementation work plan for each goal in the state plan, and include information on progress made toward the goals of the state plan on Alzheimer's disease and related dementias in its

annual report to the legislature; and appropriates funds, it is the position of the OCC Legislative Priorities Committee to support this measure.

Alzheimer's patients and their caregivers in Hawaii need help. Hawaii dementia/Alzheimer's patients are often unable to speak up for themselves. Their caregivers are generally trying to battle the endless avalanche of caregiving (in addition to normal family and work issues), so they are also often not able to speak up. Local cultures in Hawaii are often inclined to keep talk of illnesses like these "in the family" and are in need of outreach...they may not even know what resources are already available to them! And of course, we have all heard of the impending "Silver Tsunami" for Hawaii.. these issues are only going to increase. HB 1916 can help get Hawaii started.

Why I personally am advocating for this bill:

Alzheimer's affects not just one patient, but whole families, generations. My father and all of his siblings were afflicted with Alzheimer's or dementia. He was forced to retire early due to the disease, and has now passed away. My maternal grandmother currently has dementia and is being cared for by my mom. My mother had to retire early to take care of both my dad and her mom...she has

been the primary caregiver for my dad and/or my grandmother since around 1989. That's like a 29 year jail sentence, of dedicated caregiving.

I want it to be easier for me and my family if/when I get Alzheimer's. I know there will come a time that I will have to take care of my mom, and I anticipate I will also have dementia, because of its prevalence in my family. This bill is just an early step in a long road to making Hawaii ready for when these things happen.

Thank you for the opportunity to testify in support of HB1916, H.D. 2, S.D.1. My name is Lyn Moku. I am testifying as a family caregiver and an advocate for our Kupuna and family caregivers.

The Hawaii 2025: State Plan on Alzheimer's Disease & Related Dementias dated December 2013 was the result of a group of community stakeholders collaborating since 2011 to identify challenges and barriers and seek solutions for the ever-increasing threat of Alzheimer's disease and related dementias in Hawaii. The Hawaii Executive Office on Aging provided staff support and coordination and was committed to continue to prioritize the implementation of Hawaii's first plan. The plan was released by the Executive Office on Aging and endorsed by Governor Abercrombie and former Executive of Aging director Wesley Lum. It is a good plan, but it needs to be implemented and progress reported.

In addition to appropriating funds to update the State Plan, HB1916, H.D. 2, S.D. 1 directs the Executive Office on aging to prepare an update of the State Plan on Alzheimer's disease and related dementias no less frequently than once per fiscal biennium, rather than every year – and to report progress made toward the goals of the State Plan in its existing annual report to the Legislature. By easing the burden on the Executive Office on Aging to prepare annual reports, more effort can be expended to reach the goals of the Plan. The progress made will ultimately ease the burden on people with Alzheimer's disease and related dementias, families, caregivers, and our society.

It is important, as stated in this bill, that the Executive Office on Aging solicit input from tasks forces and working groups formed to address Alzheimer's disease and related dementias, families affected by Alzheimer's disease and related dementias, and members of the medical community. This collaboration and inclusion of all stakeholders is critical to the success and sustainability of the State Plan.

As a caregiver and legal guardian for my mother who was diagnosed with Alzheimer's disease I know how devastating dementia and Alzheimer's disease can be for the person, their families and friends, and for family and professional caregivers. The financial, emotional, mental and physical cost to care for someone with this disease is more than most of us can afford. There are not enough services to meet the needs of our growing aging population. Awareness, education and training programs needed to be expanded. We need to work together now to address the health and financial issues that are already affecting each one of us – and the State of Hawaii.

The Executive Office on Aging is the designated lead agency in the coordination of a statewide system of aging and caregiver support services in the State of Hawaii, as authorized by federal and state laws. We need the support of the Executive Office on Aging, the State Legislature and the Governor to address the growing needs of people throughout the state affected by Alzheimer's disease and related dementias. Please support H.B. 1916, H.D.2, S.D.1. Thank you.

Although we currently have many worthy and important issues to address in the state, we can not continue to neglect the needs of families affected by Alzheimer's disease or related dementias. The current number of individuals affected will only continue to rise as the baby boomers continue to age. The increase in individuals affected will continue to take a toll on the family and on our community as we are left to pay hefty costs for the care of individuals with dementia.
