RELATING TO FILIPINO VETERANS BURIAL ASSISTANCE

House Bill No. 1944 establishes the Filipino-American Veterans of World War II Burial Assistance Program; establishes the Filipino-American Veterans of World War II Burial Assistance Program Special Fund; and provides an unspecified general fund and special fund appropriations. The measure further provides that the fund is to be administered by the Office of Veterans Services, into which shall be deposited appropriations by the Legislature, and for which funds shall be used for operating expenses of and burial grants provided by the burial assistance program.

While the Department of Budget and Finance does not take any position on the establishment of the Filipino-American Veterans of World War II Burial Assistance Program, as a matter of general policy, the department does not support the creation of special funds which do not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges

made upon the users or beneficiaries of the program or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. With regards to House Bill No. 1944, it does not appear that the special fund meets the criteria of Section 37-52.3, HRS.

Good morning, Chair LoPresti, Vice Chair Fukumoto, and members of the Committee:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony **in support** of the concepts in House Bill 1944.

This measure appropriates funds and establishes a special fund if authorized by governing administrative rules for burial grants to qualifying Filipino veterans to provide funeral and burial services and transportation of their remains to the Philippines. Eligible Filipino veterans have earned the right to be buried in a National or State Veterans' Cemetery. This is the same entitlement provided to eligible military members and veterans of the United States Armed Forces. Through Act 105, Sessions Laws of Hawaii 2017, the legislature with approval by the Governor appropriated initial funding for this measure. With coordination with the Hawaii State Attorney General's Office and public hearings throughout the State in 2017, a new Hawaii Administrative Rules Section has been created and is awaiting final approval for publishing. Once published, the appropriated funding can be utilized to assist eligible WWII Filipino Veterans.

The OVS supports the intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

Thank you for this opportunity to provide testimony on behalf of Hawaii's Veterans and their families.

Re: H.B. No. 1944

The Hawai‘i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai‘i’s laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state funded services. The HCRC carries out the Hawai‘i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

H.B. No. 1944 establishes a stable and dedicated funding source to provide for burial grants for Filipino-American veterans of World War II, to cover funeral and burial costs, including the cost of returning their remains to the Philippines for burial. This follows the 2017 enactment of H.B. No. 1420 as Act 105, which provided for a one-time appropriation for the same purpose.

The HCRC strongly supports H.B. No. 1944. This program is one small way that Hawai‘i can join the United States in efforts to pay a debt of gratitude and justice, attempting to remedy a history of injustice, broken promises, and discriminatory treatment suffered by a now dwindling generation of heroic Filipino Veterans who served under US command, were promised citizenship and veteran’s benefits, and to this day continue to suffer the consequences of broken promises and belated remedies.

During WWII, members of the Philippine Armed Forces served in the US Armed Forces in the war against Japan. They were among a broader class of non-citizens serving in the US Armed Forces who were offered

naturalization as part of the 1942 enactment of the Second War Powers Act, which waived a number of usual naturalization requirements, including residence in the United States and literacy and education testing in English. The cut-off date for application was set at December 31, 1946.

The US authorized Vice Consul George H. Ennis in August 1945 to naturalize Filipino servicemen pursuant to the law. However, the applicability of the law to Filipino servicemen was questioned, and then Attorney General Tom Clark revoked Ennis' authority to naturalize in September 26, 1945. Eligible Filipino servicemen were then only able to naturalize from August through December, 1946. As a result, only about 4,000 out of more than 250,000 Filipino servicemen applied for and were granted naturalization during those few short months.

With the enactment of the Rescission Act in 1946, these Filipino Veterans who served under US Command were singled out and denied full and equal veterans status and benefits given to others.

This injustice spawned a host of litigated cases on behalf of Filipino Veterans, from the 1960s through the 1980s. Then, in 1990 Congress incorporated provisions for special naturalization for Filipino Veterans in the 1990 Immigration Act, followed by piecemeal legislation providing for limited benefits for Filipino Veterans, but not equity and full veterans benefits.

Many of those Filipino Veterans who naturalized since 1990 have waited for years for relative visas to become available, so their petitions to be reunited with their adult children in the United States can be approved and visas issued. Fewer and fewer remain with us, waiting, as those who fought under US command in WWII are now aged well into their 90s.

The HCRC strongly supports H.B. No. 1944, which provides for those who wish to return to the Philippines to be buried and reunited with their families in death, too late to be reunited in life.

The Hawaii Filipino Lawyers Association (HFLA) appreciates the opportunity to submit this testimony in strong **SUPPORT** for H.B. 1944, which would provide a stable non-lapsing funding source to provide financial assistance for the burial and funeral costs for Filipino-American veterans who served in World War II.

Such stable funding is not only critical to lighten the heavy financial burden of transporting a veteran's remains to the Philippines – estimated to cost \$5,000 - \$12,000. It also serves as a symbolic gesture to help remedy a solemn injustice experienced by these brave and loyal servicemen - now in their 90s - as well as their families.

Promised citizenship and veterans' benefits in return for their service, these Philippine Nationals put their lives on the line in the US Armed Forces. Not until *after* these Filipino veterans made great sacrifices to serve our country, did we see legislation and a series of political decisions that stripped away the benefits earned and promises made by our federal government – measures that some have regarded as racist and discriminatory.

Although there have been a few legislative and policy gains to make good on America's commitment to these servicemen, these efforts have been slow-in-coming, burdensome to pursue, and falls far too short of what's been pledged and deserved.

It's been heart-breaking for our organization to learn about the sacrifices these veterans have made based on a well-founded expectation that the relevant petitions and visas needed to reunify families in the United States would be provided for, granted, and approved. Instead, they are aging here, alone, far from home and the family that would otherwise care for them.

We believe that passage of this bill will help rectify the indignity of this history; recognize the sacrifices made by these veterans and their families; and highlight the compassion with which our Aloha State understands their collective experience – which has too easily been forgotten on the national level. This measure is long overdue; and sadly, much too late for so many.

The purposes of the HFLA are: to promote participation in the legal community by Filipino lawyers; to represent and to advocate the interests of Filipino lawyers and their communities; to foster the exchange of ideas and information among and between HFLA members and other members of the legal profession, the Judiciary and the legal community; to encourage and promote the professional growth of the HFLA membership; to facilitate client referrals and to broaden professional opportunities for Filipino lawyers and law students.
