Re: H.B. 2007, H.D. 1, S.D. 1, Relating to Taxation

The Department of Taxation (Department) appreciates the intent of H.B. 2007, H.D. 1, S.D. 1, and offers the following comments for your consideration.

H.B. 2007, H.D. 1, S.D. 1, adds helicopters to the definition of qualifying aircraft for the aircraft service and maintenance facility exemption from the general excise tax. It does this by amending Hawaii Revised Statutes (HRS) section 237-24.9 to remove language limiting the definition of aircraft only to those craft operating with two or more jet engines. The measure has a defective effective date of July 1, 2030.

The Department notes that the Senate Committee on Transportation and Energy amended this measure by revising the definition of "aircraft," to remove language limiting the definition to craft operating with two or more jet engines. The previous version of this measure, H.B. 2007, H.D. 1, kept the original "two or more jet engines" language in the definition's first subsection and added another subsection to the definition to specifically include helicopters.

If the Committee wishes to advance this measure, the Department notes that it will be able to administer it for taxable years beginning after December 31, 2018. Thank you for the opportunity to provide comments.

My concern is with helicopters.

Helicopters are a valued component of our tourism industry. They also have been a source of endless complaints from communities that lie in their flight paths, and there should be no doubt that noise can constitute both a nuisance and a health hazard, especially in otherwise tranquil rural areas.

Helicopter companies are now asking the Legislature for more favorable treatment with respect to the general excise tax. There is no suggestion of economic hardship; there is no suggestion that new facilities will be attracted to Hawai'i; and there is no suggestion that the industry would use its savings to better accommodate those who live in their fly-over country. The exemption will simply add to the companies' bottom line, and reduce much needed revenue for the State.

The history of helicopters in Hawai'i is laid out in SR 109 and SCR 183 (introduced by Senator Kahele) and is eye-opening. How can our residents be asked to tolerate the status quo when it has been 14 years since the Federal Aviation Administration and National Park Service asked for comments on an Air Tour Management Plan Environmental Assessment, and seven years since a preliminary draft Air Tour Management Plan for Hawai'i Volcanoes National Park was published, without further action. That is an outrage.

I don't think it would be unfair to say that tax giveaways should be reserved for good corporate citizens. Perhaps the helicopter tour industry's cooperation with SR 109 and SCR 183 should be evaluated before HB 2007, HD 1, SD 1 is given any further consideration.

Moreover, as you struggle to balance your budget, one must ask whether the added profits for these companies' owners could be better utilized in meeting the multiple needs that Hawai'i faces. To me, the answer is that our transportation, education, social service needs, etc., should be a higher priority.

I urge a No vote on HB 2007, HD 1, SD 1.

SUBJECT: GENERAL EXCISE, Exemption for Aircraft Repair and Maintenance

BILL NUMBER: HB 2007, HD-1, SD-1

INTRODUCED BY: Senate Committee on Transportation & Energy

EXECUTIVE SUMMARY: The stated purpose of the bill is to create equity among the types of available aircraft by broadening the exemption for aircraft repairs and maintenance to encompass all aircraft. The current structure leaves the impression that big business skates by where small business is left behind.

SYNOPSIS: Amends the definition of "aircraft" in section 237-24.9(b), HRS, to include a helicopter. The current definition requires an aircraft to have two jet engines.

EFFECTIVE DATE: July 1, 2030.

STAFF COMMENTS: Back in 1997, Continental Airlines was considering building a \$24 million jet maintenance hangar close to the Honolulu International Airport. To lure the project away from Guam and Saipan, our lawmakers at the time offered incentives, including a GET exemption. The exemption applied to servicing and maintenance of aircraft, or from the construction of an aircraft service and maintenance facility. But "aircraft," as used in the exemption statute, is restricted to aircraft with two or more jet engines. Small carriers with propeller planes don't qualify, raising some questions about whether this exemption helps the industry fairly.

This bill modifies the exemption so that it applies across the board; the current structure leaves the impression that big business skates by where small business is left behind.

We strongly **oppose** bill HB2007 in its current form! Tour Helicopters are in the sightseeing business and operate exclusively in Hawaii. They do not provide transportation as a form of business to transport people from one point to another, and should NOT be classified with transportation aircraft! 
