## H.B. 2215, H.D. 1 RELATING TO BICYCLES

Senate Committee on Transportation and Energy

The Department of Transportation **supports** H.B. 2215, H.D. 1 that will require the driver of a vehicle overtaking a bicyclist to allow at least a three-foot separation between the driver's vehicle and the bicyclist.

According to Hawaii State data, there were a total of twelve bicycle related fatalities from 2014 to 2017. Five out of the twelve fatalities involved a motorist overtaking a bicyclist.

This bill can help encourage drivers to provide a safe distance between their vehicle and the bicycle rider.

SUBJECT: House Bill No. 2215, HD1 Relating to Bicycles

The Department of Transportation Services supports House Bill No. 2215, HD1, which is consistent with our efforts to promote bicycling as a valid and safe mode of transportation. While we have been vigorously implementing bicycle facilities on Oahu, ultimately most bicyclists will find themselves sharing the travel lane with motor vehicles at some point. This bill will raise awareness with motorists and quantify what a safe passing distance is.

Currently, 30 states and the District of Columbia have safe passing laws in place. Our City policy with TheBus is for drivers to give 7 to 8 feet clearance when passing a bicyclist because of the large size vehicles. This bill, which requires 3 feet of passing distance, is a reasonable requirement for motorists which will ultimately make Hawaii a more bicycle-friendly place.

Thank you for the opportunity to offer testimony in **support of HB2215 HD1**, which requires a three-foot minimum safe passing distance when a motorist passes and overtakes a bicyclist.

The Hawai'i Public Health Institute (HIPHI) supports and promotes policy efforts to create a healthy Hawai'i. HIPHI weaves silos into working relationships as an effective network, ensuring that we come together across sectors to advance collaboration and innovation in public health and work towards making Hawai'i the healthiest place to live.

The passage of HB2215 HD1 will make our roads safer for all users by codifying a clear minimum safe passing distance, consistent with national standards and the Hawaii Driver's Manual. ### **Testimony Strongly Supporting HB2215**

Aloha Transportation and Energy Chair Inouye, Vice Chair Espero, and esteemed members of the Committee on Transportation and Energy,

Hawaii Bicycling League **strongly supports HB2215**, which would clarify in the existing Safe Passing law, Hawaii Revised Statutes 291C-43, that 3 feet is the minimum safe distance that a motorist should provide when overtaking a bicyclist.

HB2215 will make our roads safer for cycling and for all road users by codifying a clear minimum safe passing distance, consistent with national standards and the Hawaii Driver's Manual. This codification of the recognized minimum safe passing distance will increase driver awareness of safe passing and result in safer passing practices. This is crucial to help prevent more injuries and deaths on our roads.

- 30 cyclists have been killed on Hawaii's roads in 10 years (2005-2014)
- 44% of all cyclist fatalities result from being struck from behind or sideswiped (national data)
- 12% of cyclists "felt threatened for personal safety" the <u>last time</u> they rode and "someone drove too close to me" was the primary reason (national data)

Safely sharing our roads requires clear and agreed upon ground rules. No driver wants to hit a cyclist, and some just don't understand what a safe passing distance is. The Safe Passing 3 Foot bill will make it clear to all drivers that 3 feet is the minimum safe passing distance.

Twenty-six states and Washington DC have amended their Safe Passing laws to include 3 feet as the minimum distance when overtaking a bicyclist. Police, cities, states, and nonprofits in these states are using signage, enforcement, and awareness campaigns to make sure their Safe Passing laws make their streets safer.

### Comments:

I've lived in Kaneohe for three years and cycle 2000-3000 miles annually. The cycling conditions here are among the most dangerous of any place I have cycled in the USA. Cyclists should feel safe using municipal roads for transportation and/or exercise, but most who live here do not feel safe. I know many cyclists who simply won't ride here out of fear of collisions with cars. Many drivers see no need to shift over at all while passing cyclists even when there is no shoulder. I have been passed at what I consider an unsafe distance on almost every ride. At times I have hailed d9wn police cars and even called 911 after egregious near death confrontations from drivers passing within inches of me. Please protect me and my family who are all cyclists by making close passage illegal.

The Sustainable Transportation Coalition of Hawai'i (STCH) **strongly supports HB2215**, which would amend Hawaii Revised Statutes 291C-43 to include 3 feet as the minimum safe distance that a motorist must provide when overtaking a bicyclist.

STCH is a coalition of stakeholders with the mission of serving as an advocate and education resource to "advance the energy, economic, and environmental security of Hawai'i by promoting and supporting the adoption of practices that improve mobility, reduce travel demand, increase the utilization of energy efficient modes of travel, and reduce the use of petroleum for transportation".

Bicycling is a key component to sustainable transportation in Hawai'i. Bicycling is an ideal transportation mode in terms of sustainability; it requires no petroleum, it is very low-cost relative to other modes, it requires minimal space for parking, and it integrates well with transit.

Unfortunately, U.S. Census data for 2016 show that only 1.0% of Hawai'i commuters use a bike as their primary mode. While the reasons more people don't bicycle are many, concern about safety is a major factor. A report by the U.S. Department of Transportation National Highway Traffic Safety Administration found that 12% of cyclists "felt threatened for personal safety" the <u>last time</u> they bicycled and "someone drove too close to me" was the primary reason. Also it would reduce pedestrian fatalities as making it easier to bicycle would encourage people to bicycle instead of using their cars, thus lowering the amount of cars on the road and the probability of auto related fatalities.

In addition to my own testimony, I wish to include Hawaii Bicycling League's testimony, all of which I agree with. From Hawaii Bicylcling League:

"[I] strongly supports HB2215, which would clarify in the existing Safe Passing law, Hawaii RevisedStatutes 291C-43, that 3 feet is the minimum safe distance that a motorist should provide when overtaking a bicyclist.

HB2215 will make our roads safer for cycling and for all road users by codifying a clear minimum safe passing distance, consistent with national standards and the Hawaii Driver's Manual. This codification of the recognized minimum safe passing distance will increase driver awareness of safe passing and result in safer passing practices.

This is crucial to help prevent more injuries and deaths on our roads.

- •30 cyclists have been killed on Hawaii's roads in 10 years (2005-2014)
- •44% of all cyclist fatalities result from being struck from behind or sideswiped (national data)
- •12% of cyclists "felt threatened for personal safety" the last time they rode and "someonedrove too close to me" was the primary reason (national data)

Safely sharing our roads requires clear and agreed upon ground rules. No driver wants to hit a cyclist, and some just don't understand what a safe passing distance is. The Safe Passing 3 Foot bill will make it clear to all drivers that 3 feet is the minimum safe passing distance.

Twenty-six states and Washington DC have amended their Safe Passing laws to include 3 feet as the minimum distance when overtaking a bicyclist. Police, cities, states, and nonprofits in these states are using signage, enforcement, and awareness campaigns to make sure their Safe Passing laws make their streets safer."

This bill comes at a particularly apt time. This past weekend (2/3/2018) I was riding my bicycle on Alii Drive in Kailua Kona, I was *IN THE SHOULDER*. A driver wasn't paying attention, instead of looking for all road users the driver pulled off the road into the shoulder and "cut me off", I went over my handle bars, crashed and landed *ON MY HEAD*. I ended up in ER, thankfully I was wearing a helmet, and I survived. Please enact this law to make it safer for cyclists and to make drivers more aware. According to the officer if there was no damage sustained to the car, then it is not considered a traffic incident in Hawaii, as I understand it, that means there is *no legal consequences* for the driver, *even though he nearly killed me*.

On another occasion I had a driver threaten to kill me because I was riding in the road, at the posted speed limit (residential street 25 mph going downhill), keeping with the flow (e.g. not impeding traffic), keeping at a safe distance from the next vehicle, only to be unsafely passed, to then arrive at a traffic light and be verbally threatened with my life.

I have reported both of these events to the Hawaii County police in the last 12 months.

Additionally, when I ride, I ride with aloha, I share the road, I pull over to let traffic pass, yet I still have had drivers intentionally, drive close to "buzz" me, I have had drivers drive in the rumble strips on the sides of Queen Ka'ahumanu Hwy to intimidate me.

Too often when I am riding at the posted speed limit, with the flow of traffic, (e.g. keeping up with cars, not hindering flow), and there are no shoulders or bike lanes, I have had people pass me dangerously, just to prove a point, or because they are too impatient.

As a long-time daily commuter in various locations across the US, the 3-foot passing rule is a must-have item for cyclist safety! Unbeknownst to most drivers who do not regularly cycle, passing too close to a bicycle induces numerous risks. There's the "suction" that occurs when a vehicle zips by and pulls the cyclist along, often pulling them towards the very vehicle that is passing them. Then there's the fact that road debris and surface conditions, while of minor consequence to a car, can be very consequential to a cyclist. A small limb to a cyclist is like a full curb to a car. So, cyclists need some space to account for those hazards (especially here in HI) and the room and freedom to deviate from a strictly straight line. Another good thing about the 3-foot rule is it will encourage more people to cycle. Many people do not cycle regularly because the don't feel safe. If they are given a wider berth, they will feel safer and will be more likely to bike. Aloha, I am writing in support of HB2215. I am senior staff at UH Mal, noa, and have been a cyclist on O'ahu since 2003. Three years ago I moved into town from Waimanalo so I could commute by bike instead of car. I now commute to work by bike every day. I've been a strong supporter of alternative modes of transportation, both for health and environmental reasons.

On my daily 3-mile commute to UHM, I witness a lot of dangerous behavior committed by automobile drivers. Most drivers are conscientious, which I appreciate. But a small percentage, for example: drive 40MPH on 25MPH streets; drive in the bike lane, or weave in and out of the bike lane; blatantly run red lights; pass a cyclist with inches to spare.

Having a codified law protecting cyclist rights and safety is an important component to keeping our streets functional for all types of users. Within my network of friends and colleagues, I know of at least 3 people who have been hit by a vehicle while on a bike and riding legally. The most egregious of these collisions were committed by vehicles overtaking cyclists riding in sharrows (shared use lanes) and "buzzing" the cyclist to threaten them off the roads and establish car superiority. This type of behavior threatens our sense of aloha and community, and a law establishing a 3-foot passing rule will help law enforcement discourage this type of behavior.

I'm testifying in support of HB2215 HD1.

I'm 59 years old, soon to be 60, and a lifelong resident of Oahu. I'm also an avid bicyclist and ride 4 to 5 times a week (for exercise and recreation). During a typical week, I'll log 100+ miles on island roadways, mostly on Oahu's windward side (I live in Kaneohe).

One ride that I used to do frequently (once a week) but rarely do now (perhaps once every three months) is the route from Kaneohe to Kaaawa, whereby I'll follow Kahekili Hwy then continue northbound on Kamehameha Hwy to Kaaawa, a distance of about 14 miles from my home.

I mention that I rarely do this ride nowadays mostly because of the number of near misses I've experienced from vehicles passing me along the way. Sometimes I wonder if these near misses are intentional acts of intimidation by drivers. I also sometimes wonder if they're a result of distraction. I can't say for sure.

However, what I can say for sure is how traumatizing it is to be buzzed by a vehicle, sometimes a VERY large one, traveling much faster than I am. And when I am traveling on my bike, I take care to ride visibly (I employ flashing lights fore and and aft and wear a bright-colored cycling jersey), humbly (I ride on roadway shoulders, whenever available), and predictably (I avoid weaving in and out of traffic and ride in a manner so that drivers have a good idea of my intended path of progress).

If HB2215 passes and becomes a law of the land, I realize that my safety while riding a bike is still not assured. However, passage of the bill will undoubtedly improve the likelihood of my safety as well as the safety of the many other bicycle riders like me.

So again, I stand in strong support of the passage of this bill.

Thank you for this opportunity to testify in SUPPORT of HB2215 that includes bicycles into the three feet passing law. We support this bill because it will make it safer for both cyclists and drivers. It codifies the expectation of allowing 3 feet of space when overtaking a cyclist from the left. No longer is there question, this bill clarifies the standard space for safety. Passage of this bill also creates the opportunity for education and outreach in regard to roadway safety.

At Blue Zone Projects, we support healthy lifestyle habits. Biking is most certainly a healthy and fun way to travel our beautiful islands. More people will be inclined to bike if they feel safer on the road. Safety is achieved through clear laws that are supported by educational outreach. Many cyclists feel unsafe because of car proximity. As the counties work to improve bike plans and implement complete streets, it is necessary to address rider safety as well. When these elements are addressed in unison, education and advocacy become highly effective and relevant.

From 2005-2014 there were 30 cyclists killed on our roadways almost half of those were from being struck from behind or side swiped. Through this bill and through partnered advocacy and education we can work to lower those numbers across the state. Motorists do not want to strike cyclists, nor do cyclists want to get hit. This measure helps to address both of those concerns.

On a personal note, I support this legislation as an avid cyclist and survivor from recently being struck by a vehicle while on my bicycle. What was intended to be a nice Saturday morning ride, resulted in me being struck by a vehicle, knocked unconscious and rushed to Queens trauma center. While I'm lucky to be alive today, the next cyclist hit by a car may not be as lucky. Passing this bill will be a step forward to ensure greater safety for all who utilize our roads.

Again, I sincerely appreciate the Committee taking the time to discuss the merit of this bill.

## **Testimony Strongly Supporting HB2215**

The Maui Bicycling League, a chapter of the Hawaii Bicycling League, gives its support for the Safe Passing bill **HB2215**, which would clarify in the existing Safe Passing law, Hawaii Revised Statutes 291C-43, that 3 feet is the minimum safe distance that a motorist should provide when overtaking a bicyclist.

HB2215 will make our roads safer for cycling and for all road users by codifying a clear minimum safe passing distance, consistent with national standards and the Hawaii Driver's Manual. This codification of the recognized minimum safe passing distance will increase driver awareness of safe passing and result in safer passing practices. This is crucial to help prevent more injuries and deaths on our roads.

- 30 cyclists have been killed on Hawaii's roads in 10 years (2005-2014)
- 44% of all cyclist fatalities result from being struck from behind or sideswiped (national data)
- 12% of cyclists "felt threatened for personal safety" the <u>last time</u> they rode and "someone drove too close to me" was the primary reason (national data)

Safely sharing our roads requires clear and agreed upon ground rules. No driver wants to hit a cyclist, and some just don't understand what a safe passing distance is. The Safe Passing 3 Foot bill will make it clear to all drivers that 3 feet is the minimum safe passing distance.

Twenty-six states and Washington DC have amended their Safe Passing laws to include 3 feet as the minimum distance when overtaking a bicyclist. Police, cities, states, and nonprofits in these states are using signage, enforcement, and awareness campaigns to make sure their Safe Passing laws make their streets safer.

Hawaii State Legislature House Bill 2215 Testimony by Michael Moule, Kaua'i County resident March 14, 2018

I'm testifying in support of House Bill 2215. I strongly support the intent of this, although I have some recommended changes. This bill will increase safety for bicyclists and other road users, and will also reduce delays experienced by motorists who are following a slower-moving bicyclist. In the paragraphs below, I provide the reasons for my support of HB2215. My testimony is based on my experience working as a traffic and transportation engineer for more than 20 years, specializing in bicycle and pedestrian transportation and the interaction between various users on roadways.

The existing HRS 291C-43 already requires a driver of a vehicle to pass to the left of other vehicles (including bicycles) at a safe distance. However, it does not provide any definition of what this safe distance is with respect to a vehicle overtaking a bicyclist. I understand that police officers in Hawai'i have expressed concerns about the difficulty of enforcing the proposed changes to HRS 291C-43 to require a minimum separation of three feet. My testimony is that the existing law is very difficult to enforce since it does not provide a definition of a "safe distance" with respect to a motor vehicle overtaking a bicyclist. By providing a definition of a minimum amount of separation between a bicyclist and an overtaking vehicle, the proposed bill would make HRS 291C-43 easier to enforce and adjudicate. An increasing number of users, including motor vehicle drivers and bicyclists, are using cameras when traveling on streets and highways, so there is ever-increasing evidence in incidents and crashes involving a motorist and a bicyclist. This new law will make it easier to effectively use this evidence in police investigations and in courtrooms.

I have a few recommended changes to the language of the bill as follows:

- The addition of the words "or bicycle" to the title of HRS 291C-43 is not necessary. By definition (see HRS 291C-1), a bicycle is a vehicle. Adding "or bicycle" to the title of the statute is redundant.
- The words "or bicycles" do not need to be added to the first sentence of HRS 291C-43, as this is likewise redundant.
- I recommend editing the proposed new Subsection 2 of HRS 291C-43 as follows: "The driver of a motor vehicle passing or overtaking a bicycle bicyclist proceeding in the same direction shall allow at least three feet of separation between the right side of the overtaking driver's vehicle, including all mirrors or other protuberances, and the left side of the bicycle and the driver of the bicycle bicyclist, and shall not again drive to the right side of the roadway until safely clear of the overtaken bicycle." The reasons for these recommended changes are as follows:
  - The law should use "motor vehicle" due to the fact that "vehicle" by definition includes a bicycle. The bill as currently proposed would make it illegal for bicyclists to overtake other bicyclists with less than three feet of clearance. It is

- reasonable for bicyclists to overtake other bicyclists with less than three feet of clearance in some circumstances.
- The law should replace "bicyclist" with "bicycle" as "bicycle" is defined in HRS 291C, but "bicyclist" is not. In addition, it should be clearly stated that the overtaking vehicle must have three feet of clearance to both the bicycle and the bicyclist (properly described as "the driver of the bicycle."
- The law should refer to the "overtaking" driver's vehicle to provide clarity. There
  are two drivers involved in situations where a motor vehicle overtakes a bicycle,
  including the driver of the overtaking vehicle and the driver of the bicycle.
- I recommend including a change to HRS 291C-47 to allow drivers of vehicles to cross over double yellow centerlines or other markings that designate no-passing zones. I recommend adding a subsection (d) to HRS 291C-47, as follows: "(d) This section does not apply to the driver of a vehicle overtaking a bicyclist proceeding in the same direction and in the same lane when overtaking the bicyclist can be done safely and without interfering with, impeding, or endangering other traffic lawfully using the highway. This subsection does not authorize driving to the left side of the center of the roadway when prohibited under sections 291C-45 or 291C-46." Adding this language to HRS 291C-47 is as important if not more important than the proposed change to HRS 291C-43. This additional language is critical to encourage motorists to provide adequate clearance when overtaking bicyclists. On typical two-way, two-lane roadways, a motorist cannot safely overtake a bicyclist without crossing over the centerline of the roadway unless the roadway has a designated bicycle facility, usable paved shoulder, or a very wide travel lane. Such roadways often have no-passing zones near intersections, horizontal and vertical curves, bridges and other features. No-passing zones are designed specifically for the dynamics of one motor vehicle overtaking another motor vehicle, and do not consider the dynamics of a motor vehicle overtaking a slowermoving bicycle. There are many situations where a motorist can safely overtake a bicyclist in a no-passing zone that was designed for motor vehicles overtaking motor vehicles. There are hundreds of miles of two-lane roadways in Hawai'i that have continuous double yellow centerlines that create no passing zones. Under current law, a motorist traveling behind a slower bicyclist on a narrow, two-lane roadway with a double yellow centerline must either wait behind the bicyclist until there is room to overtake within the lane, or pass the bicyclist illegally (yet safely) by crossing the nopassing zone markings. On many roadways in all counties in Hawaii, the available room to overtake within the lane does not exist for long distances.
