Chair Evans, Vice Chair Keohokalole and members of the Committee.

Dear members of the committee I want to express my support for HB2324 an Administration bill relating to the Pacific International Space Center for Exploration Systems (PISCES).

In HRS 201-76 which transferred PISCES to DBEDT from the University of Hawaii, PISCES was administratively attached to the Office of Aerospace Development, an office under DBEDT, a principal department of the State of Hawaii. Since HRS Section 26-359a0 states that the administrative supervision of any board or commission should be established or placed within a principal department for administrative purposes, PISCES should be administratively attached to DBEDT. HB2324 addresses and corrects this technical flaw within HRS 201-76 and expressly places PISCES within DBEDT.

HB2324 also makes needed changes to the membership of the PISCES Board of Directors as defined in HRS 201-77(a). HRS 201-779a) designates the executive director of PISCES as an ex officio Board Member. Since the executive director of the space center is confirmed by the PISCES Board, which also sets the salaries and duties of the executive director, there is a built-in conflict of interest. The PISCES executive director should not be a member of the PISCES Board. HB2324 deletes the executive director as an ex officio Board member and adds the Chancellor of the University of Hawaii at Hilo or his/her designee. Since the PISCES program resides on the island of Hawaii, the Chancellor of the University of Hawaii at Hilo would provide the island of Hawaii academia's perspective to the Board. The deletion of the PISCES executive director from the Board and the addition of the University of Hawaii at Hilo Chancellor has the effect of eliminating the built-in conflict of interest, and of holding the number of PISCES Board seats at nine, maintaining an odd number and the fiveperson quorum.
