Chair Evans and Members of the Committee:

The Department of the Attorney General provides the following comments.

This bill establishes a new Hawaii Innovation and Technology Authority (Authority) headed by a board of directors.

This bill does not include the powers, duties, and functions of this new Authority. We recommend that such powers, duties, and functions of the Authority as the Legislature deems appropriate be inserted.

In addition, page 3, lines 4-10, of this bill provides that the members of the board of directors "shall be appointed by the governor, senate president, and speaker of the house of representatives for a term of four years; provided that membership on the board shall not exceed eight consecutive years; provided further that each member shall hold office until the member's successor is appointed and qualified." (Emphasis added).

First, "appointed by the senate president and speaker of the house" is inexact, as the rest of the bill makes clear that the Governor shall appoint the members, albeit some of the members shall be appointed by the Governor from names submitted by the Senate President and Speaker of the House.

Second, providing for a term of four years, not to exceed eight consecutive years, is unnecessary, as section 26-34, Hawaii Revised Statutes (HRS), already contains these provisions.

Third, the holdover wording of this bill is not in conformance with section 26-34, HRS, which provides:

(b) Any member of a board or commission whose term has expired and who is not disqualified for membership under subsection (a) may continue in office as a holdover member until a successor is <u>nominated and appointed</u>; . . . (Emphasis added).

Because section 26-34, HRS, contains the holdover provision in subsection (b), additional holdover wording is not necessary.

To avoid a conflict between statutes and unnecessary verbiage, we recommend that page 3, lines 4-10, of this bill be amended to read as follows:

(1) The members shall be appointed by the governor as provided in section 26-34.

As part of HTDC's vision to create 80,000 new innovation jobs in Hawaii earning \$80,000 or more by 2030, HTDC supports initiatives aimed at promoting technology and innovation jobs. HTDC appreciates the intent of the bill to provide more support for technology commercialization through coherent policies and priorities relating to innovation and technology.

HTDC comments that coherent policies and priorities should be a common goal for all stakeholders in the innovation sector. Good morning. My name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on House Bill No. 2709, relating to the Hawaii Innovation and Technology Authority with which to grow Hawaii's innovation and technology industry. The OCC Legislative Priorities Committee is in favor of House Bill No. 2709 and support its passage.

House Bill No. 2709, is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it creates the Hawaii Innovation and Technology Authority to

grow Hawaii's innovation and technology industry to be placed under the Department of Business, Economic Development, and Tourism for administrative purposes.

Specifically, the DPH Platform states, "We believe in efforts to build and retain a qualified workforce in Hawai'i . . . As the party of working men and women in Hawai'i, we work to protect labor rights and social security; to ensure fair labor practices, a living wage for all workers, equal pay for equal work and fair taxation; we encourage legislation to raise the minimum wage and paid family and sick leave; to protect employees' rights to organize and bargain collectively with their employers; to oppose the outsourcing of Hawaii's jobs; to promote employment opportunities and sustainable growth; to assist the economically disadvantaged and advocate for sound trade and economic policies; and build our workforce for jobs in emerging technologies, in green industries, in renovation and in green construction, so that their jobs are not dependent on ever-expanding real estate development. (Platform of the DPH, P. 3, Lines 119, 122-129 (2016)).

We recognize that the responsible use and development of technology in all its manifestations offers immense potential for our community, government, including institutions of higher education and business sectors. We encourage synergistic research, development, commercialization and educational programs to promote technological proficiency and innovation. In particular, we support Science, Technology, Engineering and Math (STEM) initiatives in our public, private and charter schools as these prepare the next generation to address the needs of our State. We also support programs that facilitate incubator, i.e. start-up, opportunities for new and promising technologies, and encourage the local retention of our intellectual resources. (Platform of the DPH, P. 3, Lines 149-156 (2016)).

Given that House Bill No. 2709 it creates a Hawaii Innovation and Technology Authority to grow Hawaii's innovation and technology industry to be placed under the Department of Business, Economic Development, and Tourism for administrative purposes; it is the position of the OCC Legislative Priorities Committee to support this measure.
