TESTIMONY TO THE HOUSE COMMITTEES ON PUBLIC SAFETY AND VETERANS, AND MILITARYAND INTERNATIONAL AFFAIRS AND CULTURE AND THE ARTS

House Concurrent Resolution 97/House Resolution 82 – Requesting the Hawaii Emergency Management Agency to Conduct a Systemic, Transparent, and Data-Driven Assessment to Determine Where Any New Warning Sirens are Needed in the State, Based on Hazard Risks, Population Density, Vulnerable Populations, and Other Relevant Criteria

The Disability and Communication Access Board (DCAB) supports the intent of HCR 97/HR 82 and provides comments. This measure requests the Hawaii Emergency Management Agency to conduct a systemic, transparent, and data-driven assessment to determine where any new warning sirens are needed in the state, based on hazard risks, population density, vulnerable populations, and other relevant criteria.

DCAB is requesting two amendments to the resolutions:

- 1. A definition is not mentioned regarding "vulnerable populations." DCAB believes it is important that if this means "people with disabilities (as defined under the Americans with Disabilities Act)" and "others with access and functional needs" (as defined by the Federal Emergency Management Agency), then please change the wording to indicate that; and
- 2. Warning sirens cannot be heard by everyone, so we recommend adding that any area designated for a new siren also needs to have text capabilities to send people in that area a text alert at the same time the sirens are sounded, for equal access.

The sirens are crucial to protect the public, including people with disabilities and access and functional needs. They also ensure that everyone in the community will receive the alert about disasters that may impact the areas in which they live in a timely manner.
