Chair Nishimoto and Members of the Committee:

The Department of the Attorney General ("the Department") appreciates the intent of the bill and submits comments.

The purpose of this bill is to add knowingly making a false statement to a county inspector a crime within the offense of unsworn falsification to authorities. The bill sets out the offense as follows:

A person commits the offense of unsworn falsification to authorities if, with an intent to mislead a public servant in the performance of the public servant's duty, the person: . . . (b) Knowingly makes a false statement, in oral, written, printed, or electronic form, to a county inspector in the course of the inspector's investigation to ascertain compliance with any ordinance, rule, or regulation.

The Department notes the unusually narrow focus of the proposed offense. The offense appears intended to only address an issue related to enforcement by county inspectors. But such a limitation could imply that it would be acceptable to make false statements to a state inspector or investigator. This narrow issue might be more appropriately addressed by a specific county through its own ordinances.

If the Committee would like to address the issue of false statements to inspectors, the Department respectfully suggests that it consider broadening the scope of the offense to include false statements made to state and county inspectors or investigators. The offense could prohibit false statements made to a public servant

engaged in criminal, civil, or administrative enforcement activity. "Public servant" is broadly defined in section 710-1000, HRS, to mean any officer or employee of any branch of government. The proposed paragraph (b) on page 1 of the bill, starting at line 12, could read:

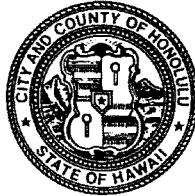
Knowingly makes a false statement, in oral, written, printed, or electronic form, to a public servant engaged in criminal, civil, or administrative enforcement activity pursuant to the public servant's investigative or inspection authority.

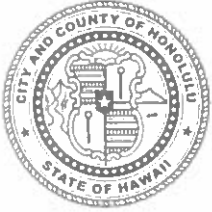
BIA-HAWAII **supports** S.B.2092, SD 1, which amends Chapter 710-1063 HRS By adding "Knowingly making a false statement to a county inspector a crime within the offense of unsworn falsification to authorities." Pursuant to this section, unsworn falsification to authorities is a misdemeanor.

We understand that this bill is in response to the "Monster Homes" problem that has recently been identified as a problem in the City and County of Honolulu. The proliferation of "Monster Homes" is a direct result of the lack of available housing at all price points on Oahu. "Monster Homes," which are differentiated from "Multi-Generational Homes," are essentially large structures being operated as illegal apartment buildings in residentially-zoned areas.

The City is presently in the process of developing amendments to the Land Use Ordinance (LUO) to address these unauthorized uses in residential zoned communities. Under the present LUO, no more than five (5) unrelated people are allowed to live in a single family residence. When inspectors visit these "Monster Homes," many of which have more than 10 bedrooms and equal number of bathrooms, the responses from the existing tenants are that they are all related.

We understand that the proposed bill is intended to provide inspectors with more authority to penalize tenants who are making false statements.

We are in support of S.B. 2092, SD 1, and appreciate the opportunity to express our views on the matter.

Thank you for the opportunity to submit testimony on Senate Bill No. 2092 SD 1, Relating to Offenses Against Public Administration. The purpose of this Bill is to establish knowingly making a false statement to a county inspector as a crime within the offense of unsworn falsification to authorities.

As Councilmember for many areas in Honolulu's urban core, I have witnessed the proliferation of large residential homes in neighborhoods such as Palolo, Manoa, and Kaimuki. I have also received calls from neighbors expressing their concerns in regards to the limited number of on-street parking, water and sewer capacity, storm drainage, and the overall size of the structure with multiple floors and rooms.


The Council recently adopted Bill 110 (2017), CD2, FD1, which places a moratorium on the issuance of permits for large residential structures. The Bill also includes provisions for stricter enforcement of the Land Use Ordinance on large residential structures; post-construction inspections on large detached dwellings; and the convening of a multi-agency enforcement team to strictly enforce the City ordinances.

In many cases, the dwellings are modified beyond the extent of the building permit or the purpose of the modifications, and oftentimes, post inspections confirm the concerns of the neighbors. Senate Bill 2092 SD 1 would provide the City's Department of Planning and Permitting the necessary resources to enforce the provisions of Bill 110.



Therefore, I support Senate Bill 2092 SD 1, and its intention to positively impact the wellbeing and quality of residential neighborhoods.
