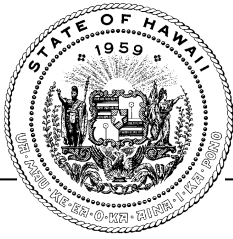

Senate Bill 2334, Senate Draft 2 proposes to require the State and counties to incorporate evaluations, predictions, and recommendations pertaining to climate change hazards and mitigation into their respective multi-hazard mitigation plans. **The Department of Land and Natural Resources supports this measure and provides the following comment.**

In December 2017, the Hawaii Climate Change Mitigation and Adaptation Commission accepted the Hawaii Sea Level Rise Vulnerability and Adaptation Report (SLR Report). Recommendation 3 of the SLR Report includes a number of potential actions that are consistent with this measure such as, "Adopt Higher Flood Standards to Account for Sea Level Rise," "Consider Adopting V Zone Standards in the Coastal A Zone," "Provide Technical and Financial Support to a Statewide Community Rating System Program," "Encourage Property Owners at Risk to Coastal Flooding to Purchase Flood Insurance," "Incorporate Sea Level Rise into State and County Hazard Mitigation Plans," and "Develop Pre-disaster Recovery Frameworks at State and County Levels that Incorporate Opportunities to Adapt to Sea Level Rise Through Disaster Recovery."

Chair Lee, Vice Chair Lowen, and Members of the House Committee on Energy and Environmental Protection.

SB 2334, SD2 requires the State and counties to incorporate predictions of sea level rise and other climate change hazards and mitigation opportunities into applicable plans, strategies, and mapping, in order to increase the State's resiliency and ability to respond to natural disasters.

The Office of Planning (OP) supports SB 2334, SD2, and respectfully offers the following comments on this measure:

1. The State and counties shall incorporate the findings of the "Hawaii Sea Level Rise Vulnerability and Adaptation Report 2017" prepared by the Hawaii climate change mitigation and adaptation commission, into the State plan and State functional plans, county general plans and county development or community plans, besides their respective multi-hazard mitigation plans, in order to increase the State's resiliency and ability to respond to natural disasters. It is not sufficient enough for the State and each county to incorporate the findings of the "Hawaii Sea Level Rise Vulnerability and Adaptation Report" only into their respective multi-hazard mitigation plans. Therefore, OP recommends amendments to Page 2, Lines 4-11 to read as follows:

**"§ 226-\_\_\_\_\_ Climate change hazards and mitigation planning; required.**  
**The State and each county shall incorporate evaluations, predictions, and recommendations pertaining to climate change hazards and mitigation into their respective multi-hazard mitigation plans, the State plan and State functional plans, county general plans and county development or community plans. Those plans, at a minimum, shall incorporate the findings of the "Hawaii Sea Level Rise Vulnerability and**

Adaptation Report” prepared by the Hawaii climate change mitigation and adaptation commission.

The Office of Hawaiian Affairs (OHA) **SUPPORTS** SB2334 SD2, which would require the state and the counties to address climate change hazards and mitigation in their hazard mitigation plans, and to include sea level rise adaptation strategies in other state and county plans and maps.

OHA has long sought to promote the resiliency and health of our islands' lands and natural and cultural resources. OHA's strategic priorities include 'Āina (Land & Water), which represents our commitment to maintain Native Hawaiians' connection to the past and a viable land base; by Native Hawaiian participation in and benefit from the responsible stewardship of Ka Pae 'Āina O Hawai'i. In line with this priority, OHA's strategic results specifically seek to preserve cultural and natural resources and historic properties.

As a member of the Hawai'i Climate Change Mitigation and Adaptation Commission established by Act 32 (Reg. Sess. 2016), OHA currently assists with direction, facilitation, coordination and planning among state and county agencies, federal agencies, and other partners on climate change mitigation (reduction of greenhouse gases) and climate change resiliency strategies, including, but not limited to, sea level rise adaptation, water and agricultural security, and natural resource conservation. OHA understands that the impacts of climate change – such as coastal flooding and erosion and impacts to terrestrial and marine ecosystems – will affect the built and natural environment, as well as the livelihoods and food security of Native Hawaiians. Understanding the extent of these changes and their impacts and planning early adaptation and mitigation actions is essential to protecting the communities and natural resources of Ka Pae 'Āina O Hawai'i.

**OHA accordingly appreciates and supports the intent of this measure, and believes that the contemplated climate change hazard and mitigation planning will reaffirm and reinforce our efforts to ensure the resiliency and sustainable stewardship of our islands**

Accordingly, OHA urges the Committee to **PASS** SB2334 SD1. Mahalo nui for the opportunity to testify on this measure.

Chair Lee, Vice-Chair Lowen, and Members of the Committee:

Aloha - I am Brigadier General Moses Kaiwi, Interim Administrator of the Hawaii Emergency Management Agency and am submitting the following comments **in support** of SB 2334 SD2:

- The Stafford Act requires states and counties to submit Hazard Mitigation Plans to the Federal Emergency Management Agency (FEMA) at least every five years to be eligible for certain types of disaster assistance, including public assistance and hazard mitigation grant program funding after a presidentially declared disaster.
- These plans identify the natural hazards that affect each jurisdiction and through combined efforts of affected stakeholders (e.g. state and county planners, university professors, scientists, community organization, and others) lay out mitigation strategies and projects to reduce the long-term impacts of these hazards. HI-EMA oversees this planning with the support of the State Hazard Mitigation Forum.
- Sea level rise and climate change have been among the top hazards considered in the development of these hazard mitigation plans and FEMA mitigation plan guidance already requires their inclusion. Climate Change Effects are addressed in chapter 18 of the current *State of Hawaii Hazard Mitigation Plan* that has been in effect since 2013.

The recent sea level rise vulnerability/adaptation report commissioned by the state's Interagency Climate Adaptation Commission will be a major consideration in the state hazard mitigation plan update, which is due in October of 2018. This report also includes potential actions that are consistent with the intent of SB 2334 SD2, such as the incorporation of sea level rise into state and county hazard mitigation plans.

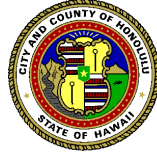

Dear Chair Lee, Vice Chair Lowen, and Committee Members:

The City and County of Honolulu Office of Climate Change, Sustainability and Resiliency **supports the intent** of Senate Bill 2334 SD2, which mandates the integration of climate change considerations in state and county planning efforts, including the Multi-Hazard Pre-Disaster Mitigation Plan.

The City has already begun to include sea level rise and other climate change considerations into its long range policy plans. We have also been requesting that climate change impacts be defined for major land use proposals. The City also established via City Charter our permanent Office of Climate Change, Sustainability and Resiliency which has quickly built capacity to coordinate policies and departmental action to plan for and address climate change impacts.

While we support the concept of proactive actions such as modeling for mapping purposes and participation in the community rating system called for in this bill, we are concerned that this Bill mandates City actions without funding to carry them out. These are not one-time costs, but reflect an ongoing commitment. These activities are not currently in the City's budget and we request that Senate Bill No. 2334 SD2 include permanent funding to assist the City and other counties in this work.

Aloha Chair Lee, Vice-Chair Lowen, and Committee Members:

The **HAWAI'I REEF AND OCEAN COALITION – HIROC**– was formed last year by coral reef scientists, educators, local Hawai'i environmental organizations, elected officials, and others to address a crisis facing Hawaii's coral reefs and ocean. We are currently asking the Legislature to pass a handful of very important bills to save our coral reefs – they are bills relating to sunscreens, plus bills on cesspools; Styrofoam; plastic marine debris; and sea level rise.

**HIROC supports SB 2334 SD2.** It is one of several bills we back for addressing the challenges Hawai'i faces now and into the future in an era of sea level rise, increased frequency and intensity of storm events, and other climate change impacts.

This bill provides the legislative mandate needed to implement recommendation 3.7, **Develop pre-disaster recovery frameworks at state and county levels that incorporate opportunities to adapt to sea level rise through disaster recovery**, from the Hawai'i Sea Level Rise Vulnerability and Adaptation Report (the Report) prepared by the Hawai'i Climate Change Mitigation and Adaptation Committee.

As stated in the Report:

“Disasters can provide opportunities to adapt to sea level rise. Chair Lee, Vice Chair Lowen and members of the committee:

**The Hawai'i Shore and Beach Preservation Association (HSBPA) supports the intent of Senate Bill 2334.**

SB2334 requires the State and counties to incorporate predictions of sea level rise and other climate change hazards and mitigation opportunities into applicable plans, strategies, and mapping. The purpose of this Act is to require the State and counties to incorporate predictions of sea level rise and other climate change hazards and mitigation opportunities into applicable plans, strategies, and mapping, in order to increase our State's resiliency and ability to properly respond to natural disasters.

Hawai'i's beaches have become increasingly threatened by coastal erosion. According to the United States Geological Service (USGS) National Assessment of Shoreline Change for the Hawaiian Islands, 70% of Hawai'i's beaches are eroding and 13 miles of beach have been lost over the last century. Beach erosion effects shoreline access, recreation and cultural activities, coastal environments, and our economy. Beaches are the backbone of Hawai'i's \$15 Billion tourism industry and are central to Hawai'i's unique culture and lifestyle. With sea-level rise and chronic coastal erosion, the state is challenged to find effective and efficient ways to preserve and maintain our naturally occurring sand beaches. We believe the proposed legislation will help support the long-term preservation and protection of our coastal resources in addition to developing hazard mitigation plans that incorporate and address some of the pressing climate change impacts such as sea-level rise.

HSBPA supports SB2334 in the effort to incorporate modern scientific information on climate change as part of State and County plans and policies. The HSBPA supports further development of a full suite of coastal management options needed to address the challenging conditions forecast for the future of Hawai'i. Hawai'i's hazard mitigation plans are an important part of Hawai'i's disaster preparedness, incorporating climate change impacts and science is not only appropriate but necessary to obtain comprehensive mitigation plans that are adaptive and relevant to the current hazard threats.
