- 3 Division supports SB270 to protect the physical and psychological wellbeing of minors against
- 4 exposure to harm caused by Sexual Orientation Change Efforts (SOCE; also known as
- 5 "Conversion Therapy"). According to the American Psychological Association (APA), there is
- 6 insufficient research evidence to demonstrate the efficacy of SOCE. There is also no evidence
- 7 that providing SOCE therapies to children or adolescents has an impact on Adult sexual
- 8 orientation.
- 9 The APA found SOCE therapies tend to do more harm than good. Not only do children and
- adolescents get misinformation, they also are at risk of increased self-stigma and psychological
- distress. Children and adolescents who participate in these types of therapies are given
- inaccurate scientific information regarding sexual orientation. These types of therapies also
- often use fear based techniques and have the potential to increase stigma. Participants also often
- report an increase in distress and depression especially when such "therapies" do not work.
- SOCE participants report negative consequences of SOCE therapies such as, anger, anxiety,
- depression, guilt, hopelessness, loss of social support, relationship problems with significant
- others and families, social isolation, suicidal thoughts, self-hatred, and sexual dysfunction. As
- such, these types of coercive therapies are contrary to current clinical and professional standards.
- 19 These types of therapies violate current clinical practice by not protecting the client's autonomy

1	and by ignoring scientific information on sexual orientation. Although some opponents of this
2	bill have tried to suggest that there is disagreement among researchers about the evidence in this
3	area, they have referenced publications by anti-gay organizations only. All the major
4	organizations of professionals involved in treating children have issued statements opposing
5	Sexual Orientation Change therapy, including the American Psychological Association, the
6	American Medical Association, the American Academy of Pediatrics, the American Psychiatric
7	Association, and the National Association of Social Workers.
8	The bill does not hinder mental health providers, clergy or parents from counseling youth or
9	offering a range of other, more standard clinical psychological services to lesbian, gay, bisexual,
10	and transgender (LGBT) children and adolescents. The bill regulates the services being provided
11	to LGBT children and adolescents to provide them protections against being exposed to harm
12	through SOCE therapies that might be chosen for them by adults. The bill is in line with APA
13	practice standards and the Department of Health standard of providing evidence based services.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

The Department of Commerce and Consumer Affairs ("Department") appreciates the opportunity to testify on S.B. 270, Relating to Minors. My name is Daria Loy-Goto, and I am the Complaints and Enforcement Officer for the Department's Regulated Industries Complaints Office ("RICO"). RICO takes no position on the bill, but offers the following comments and requests clarification.

S.B. 270 creates a new chapter in Title 25 that prohibits licensed persons who provide professional counseling, including but not limited to physicians specializing in the practice of psychiatry, physician assistant, psychologist, social worker, mental health counselor, marriage and family therapist, or a person who performs counseling as part of the person's professional training for any of these professions, from engaging in or sexual orientation change efforts involving persons under eighteen years of age.

The bill also prohibits licensed persons who provide professional counseling from offering sexual orientation change efforts in advertisements.

RICO requests clarification on what constitutes "professional counseling" at page 2, lines 4-10, and page 2 lines 16-17, and recommends that all license types to be included under this definition be specifically identified.

Also, RICO notes that the phrase "efforts to change behaviors" at page 3, line 4 is vague and may be broadly construed.

Chair Baker and Members of the Committee:

The Hawaii State Teachers Association supports SB 270, relating to minors.

Conversion therapy, often called "ex-gay" therapy, has no place in our society. It involves a rejection of a child's sexual or gender identity. Minors who experience rejection based on their sexual orientation face serious health risks. In a study published in the medical journal *Pediatrics*, lesbian, gay, and bisexual young adults who reported higher levels of rejection during adolescence were 8.4 times more likely to report having attempted suicide, 5.9 times more likely to report high levels of depression, 3.4 times more likely to use illegal drugs, and 3.4 times more likely to report having engaged in unprotected sexual intercourse compared with their peers.

Numerous medical, psychological, and mental health organizations have condemned conversion therapy as unscientific and developmentally dangerous, including the American Psychological Association. In the education world, HSTA helped pass a 2015 National Education Association Convention Item opposing conversion therapy, NBI 86, that states, "NEA will disseminate to educators through existing publications current information regarding the damaging effects of anti-gay conversion/reparative therapies." Thus, teachers, too, understand the harm caused by conversion therapy, which undermines childhood development. We believe this practice is tantamount to child abuse and should be banned statewide.

To protect our keiki from discriminatory pseudo-psychology, the Hawaii State Teachers Association asks your committee to **support** this bill.

The Hawaii Section of the American College of Obstetricians and Gynecologists (HI ACOG) strongly supports SB 270, which would prohibit licensed professional counselors from engaging in or advertising sexual orientation change efforts to minors. As a Section of the Nation's leading group of physicians dedicated to improving health care for women, HI ACOG represents more than 200 obstetrician/gynecologist physicians in our state.

ACOG states that "reparative therapy aimed to change sexual orientation by provoking guilt and anxiety to shame those who do not identify as heterosexual is **ineffective and harmful**." In addition, we agree with the recent policy statement released by the American Academy of Child and Adolescent Psychiatry (AACAP) which states "the American Academy of Child and Adolescent Psychiatry finds no evidence to support the application of any 'therapeutic intervention' operating under the premise that a specific sexual orientation, gender identity, and/or gender expression is pathological. Furthermore, based on the scientific evidence, the AACAP asserts that such 'conversion therapies' (or other interventions imposed with the intent of promoting a particular sexual orientation and/or gender as a preferred outcome) lack scientific credibility and clinical utility. Additionally, **there is evidence that such interventions are harmful**."²

"Conversion therapy" is opposed by most of the mainstream medical and mental health organizations, including the American Academy of Pediatrics, the American College of Physicians, the American Psychiatric Association, the American Psychological Association, the American Medical Association to name a few.

Increasingly more states are taking action to protect LGBTQ youth from this harmful practice, including California, Connecticut, Illinois, Nevada, New Jersey, New Mexico, New York, Oregon, Rhode Island, Vermont, and the District of Columbia. It is high time Hawaii joined this list.

For these reasons, we urge you to protect Hawaii's youth and pass this critical bill. Thank you for the opportunity to testify.

The League provides comments on SB270, which would prohibit persons licensed to provide professional counseling from engaging in, attempting to engage in, or advertising sexual orientation change efforts on behalf of persons under 18 years of age.

Conversion therapy is a highly controversial practice of seeking to change, through therapy, an LGBTQ individual's sexual preference, orientation, or expression to heterosexuality. It is currently banned in 9 states and numerous municipalities throughout the US.

The League recognizes that representatives of some Christian institutions and affiliated organizations and individuals, cite religious, free speech, and parental rights as reasons to vigorously oppose such a ban. We are also aware that supporters raise evidence of harmful outcomes associated with conversion therapy and professional standards of care.

The League believes that all U.S. residents including minors should have access to a basic level of quality of care. We seriously doubt whether conversion therapy meets the standard of mental health care for either adults or adolescents. The medical literature does not see this as safe, and in fact most of the literature finds it to be harmful. We support having health care that is generally accepted by practitioners as safe and efficacious.

Hawaii Family Forum is a non-profit, pro-family education organization committed to preserving and strengthening families in Hawaii, representing a network of various Christian Churches and various faith-based groups. We oppose this bill because we believe that this bill violates the right of parents to choose their child's therapy, provide appropriate and professional health care services, and practice their religion in accordance to their faith.

It is incomprehensible that on one hand faith-based parents would have the right to seek professional counseling for a child with impulse control disorders like kleptomania, compulsive gambling, addiction to drugs or pornography, and then on the other hand be prohibited from accessing licensed health professionals who are trained to help their son or daughter dealing with **unwanted** same-sex attraction issues.

If a young person is experiencing conflict between his or her sincerely held religious beliefs and same-sex attractions, this law could also prevent their minister, who may also be a trained and licensed counselor or therapist, from providing care. Aloha Chair Baker, Vice Chair Tokuda and fellow committee members,

I am writing in STRONG SUPPORT for Senate Bill 270 on behalf of the LGBT Caucus of the Democratic Party of Hawai'i. SB 270 persons licensed to provide professional counseling from engaging in, attempting to engage in, or advertising sexual orientation change efforts on persons under 18 years of age.

This so called conversion therapy or as it is also known as in the counseling field "sexual orientation change effort", is the false idea that one can change their sexual orientation through therapy/counseling. The facts are quiet clear that your sexual orientation, gender identity and/or gender expression is part of your genetic make-up and no amount of coercive therapy/counseling can change them.

Here are the side effects from conversion therapy:

Depression, guilt, helplessness, hopelessness, shame, social withdrawal, suicidality, substance abuse, stress, disappointment, self-blame, decreased self-esteem and authenticity to others, hostility and blame toward parents, increased self-hatred, feelings of anger and betrayal, loss of friends and potential romantic partners, problems in sexual and emotional intimacy, sexual dysfunction, high-risk sexual behaviors, a feeling of being dehumanized and untrue to self, a loss of faith, and a sense of having wasted time and resources.

President Barack Obama and the Democratic Party of Hawai'i (2014 DPH Platform pg. 4-5 lines 221-224 https://hidems.files.wordpress.com/2015/06/2014_platform.pdf) along with the American Psychological Association, American Counseling Association, American Academy of Pediatrics, American School Counselor Association, and the National Association of Social Workers have all come out against conversion therapy. California, Illinois, New Jersey, Oregon and the District of Columbia have all passed laws banning this barbaric practice.

A New Jersey jury, under their state's law, went so far as finding the Jewish conversion therapy organization, JONAH, guilty of consumer fraud for promising to be able to change its client's sexual urges and determined its commercial practices to be unconscionable. The Supreme Court agreed with the jury's determination and upheld New Jersey's law.

The LGBT Caucus would also like to clear up some misconceptions that have come to light from the opposition to banning conversion therapy proposed by Senate Bill 270.

The inference that this bill interferes with parents' rights to raise their kids:

The State of Hawai'i has a lot of laws on the books that "interfere" with the way parents raise their kids from mandating seatbelts for all and booster seats for minors under 70 lbs; requiring life saving vaccinations; getting an education; requiring members of Christian Scientists to get their children life saving medical treatment; and outlawing child abuse. Every leading professional medical and mental health associations have rejected conversion therapy as unnecessary, ineffective, and dangerous. So to inflict conversion therapy on minors is child abuse.

That somehow this bill stop therapist from helping minors that are struggling with their sexual orientation; gender identity; and/or gender expression:

This bill does not bar anyone from seeking therapy with regards to their sexual orientation; gender identity; and/or gender expression, plain and simple. It does bar therapists from putting their patients in danger by exposing them the disavowed conversion therapy.

Conversion therapy is nothing but coercion, forcing the will of the parents for the minor to reject who they are and how they were born. That is not the role of a therapist, especially when dealing with minors. The false idea behind conversion therapy is that there can be a guaranteed set predetermined outcome from the therapy sessions – changing a person's sexual orientation, gender identity and/or gender expression.

That this bill is unconstitutional on religious grounds and will have "unintended consequences":

The legal language found in this bill mirrors to what appears in the laws of California, Illinois, New Jersey, Oregon and District of Columbia. Which has been challenged in court, all the way up to the Supreme Court in fact and the Supreme Court has rejected all challenges. It should be noted that NONE of those laws have religious exemptions and they have passed constitutional muster. This is because priests, pastors and other persons of the cloth, as long as they are doing their ministerial duties, have constitutional protection.

It is when those few priests, pastors and other persons of the cloth, that are licensed therapists, decide to hang a shingle and offer therapy that they would fall under the jurisdiction of this law. Much like those pastors that advocate for the death of President Obama from the pulpit, not one has been arrested. Even though it is against federal law to threaten the life of the President of the United States, they have constitutional protection.

As we pointed out earlier, New Jersey was able to sue JONAH a therapy group with religious ties because it was outside of their ministerial duties. The group with religious ties hung up a therapy shingle and said they could convert gays to straight, which they could not do. As for "unintended consequences", this seems to be to go to phrase by the opposition to anything that would bring justice and equality to the LGBT community. They used that phrase constantly during the battle for marriage equality and to this day there has not been one "unintended consequence" by bringing marriage equality to the Aloha State.

That somehow this bill will bring out unlicensed therapists:

We already have laws on the books to handle unlicensed therapists. If the opposition is really concerned about unlicensed therapists then they should advocate for a stronger punishment be placed on the books.

There is a direct correlation between being a member of the LGBT community and drug abuse:

This is false, there is no study that shows a correlation between being a member of the LGBT community and drug abuse. There is however a direct link between a member of the LGBT community going through conversion therapy and drug abuse, suicide and the complete list of other adverse side effects that we listed in our main testimony.

What Are Some Examples of Conversion Therapy?

In the past, some mental health professionals resorted to extreme measures such as institutionalization, castration, and electroconvulsive shock therapy to try to stop people from being lesbian, gay, bisexual, or transgender (LGBT). Today, while some counselors still use physical treatments like aversive conditioning, the techniques most commonly used include a variety of behavioral, cognitive, psychoanalytic, and other practices that try to change or reduce same-sex attraction or alter a person's gender identity. While these contemporary versions of conversion therapy are less shocking and extreme than some of those more frequently used in the past, they are equally devoid of scientific validity and pose serious dangers to patients—especially to minors, who are often forced to undergo them by their parents or legal guardians, and who are at especially high risk of being harmed.

According to a 2009 report of the American Psychological Association, the techniques therapists have used to try to change sexual orientation and gender identity include inducing nausea, vomiting, or paralysis while showing the patient homoerotic images; providing electric shocks; having the individual snap an elastic band around the wrist when aroused by same-sex erotic images or thoughts; using shame to create aversion to same-sex attractions; orgasmic reconditioning; and satiation therapy. Other techniques include trying to make patients' behavior more stereotypically feminine or masculine, teaching heterosexual dating skills, using hypnosis to try to redirect desires and arousal, and other techniques—all based on the scientifically discredited premise that being LGBT is a defect or disorder.

The current practice guidelines for the National Association for Research & Therapy of Homosexuality (NARTH), which is a group of therapists who endorse and practice conversion therapy in the United States, encourage its members to consider techniques that include hypnosis, behavior and cognitive therapies, sex therapies, and psychotropic medication, among others.

Honorable Chair Baker and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 400 members. On behalf of our members, we offer this testimony in strong support of Senate Bill 270, relating to minors.

Conversion therapy, often called "ex-gay" therapy, is child abuse and, as such, has no place in our society. Just a few years ago, our state recognized same-sex marriage. Yet, the consecration of this most basic of freedoms is a small step toward eradicating institutionalized bias toward LGBT citizens, whose sexuality is often seen as a discretionary act, rather than an essential aspect of their identities. Today, more than ever, the science is clear: sexual orientation is not a choice, but a biological fact, only the expression of which is socially determined.

Conversion therapy involves a rejection of a child's sexual or gender identity. Minors who experience rejection based on their sexual orientation face especially serious health risks. In one study, lesbian, gay, and bisexual young adults who reported higher levels of rejection during adolescence were 8.4 times more likely to report having attempted suicide, 5.9 times more likely to report high levels of depression, 3.4 times more likely to use illegal drugs, and 3.4 times more likely to report having engaged in unprotected sexual intercourse compared with their peers. This is documented by Caitlin Ryan et al. in their article entitled "Family Rejection as a Predictor of Negative Health Outcomes in White and Latino Lesbian, Gay, and Bisexual Young Adults," (2009) 123 *Pediatrics* 346.

Numerous medical, psychological, and mental health organizations have condemned conversion therapy as problematic, unscientific, and developmentally dangerous. The American Psychological Association convened a Task Force on Appropriate Therapeutic Responses to

Sexual Orientation. The task force conducted a systematic review of peer-reviewed journal literature on sexual orientation change efforts and issued a report in 2009. The task force concluded that sexual orientation change efforts can pose critical health risks to lesbian, gay, and bisexual people, including confusion, depression, guilt, helplessness, hopelessness, shame, social withdrawal, suicidality, substance abuse, stress, disappointment, self-blame, decreased self-esteem and authenticity to others, increased self-hatred, hostility and blame toward parents, feelings of anger and betrayal, loss of friends and potential romantic partners, problems in sexual and emotional intimacy, sexual dysfunction, high-risk sexual behaviors, a feeling of being dehumanized and untrue to self, a loss of faith, and a sense of having wasted time and resources.

The American Psychological Association issued a resolution on Appropriate Affirmative Responses to Sexual Orientation Distress and Change Efforts in 2009, which states: "[T]he [American Psychological Association] advises parents, guardians, young people, and their families to avoid sexual orientation change efforts that portray homosexuality as a mental illness or developmental disorder and to seek psychotherapy, social support, and educational services that provide accurate information on sexual orientation and sexuality, increase family and school support, and reduce rejection of sexual minority youth."

The American Psychiatric Association published a position statement in March of 2000 in which it stated: "Psychotherapeutic modalities to convert or 'repair' homosexuality are based on developmental theories whose scientific validity is questionable. Furthermore, anecdotal reports of 'cures' are counterbalanced by anecdotal claims of psychological harm. In the last four decades, 'reparative' therapists have not produced any rigorous scientific research to substantiate their claims of cure. Until there is such research available, [the American Psychiatric Association] recommends that ethical practitioners refrain from attempts to change individuals' sexual orientation, keeping in mind the medical dictum to first, do no harm. The potential risks of reparative therapy are great, including depression, anxiety and self-destructive behavior, since therapist alignment with societal prejudices against homosexuality may reinforce self-hatred already experienced by the patient. Many patients who have undergone reparative therapy relate that they were inaccurately told that homosexuals are lonely, unhappy individuals who never achieve acceptance or satisfaction. The possibility that the person might achieve happiness and satisfying interpersonal relationships as a gay man or lesbian is not presented, nor are alternative approaches to dealing with the effects of societal stigmatization discussed. Therefore, the American Psychiatric Association opposes any psychiatric treatment such as reparative or conversion therapy which is based upon the assumption that homosexuality per se is a mental disorder or based upon the a priori assumption that a patient should change his or her sexual homosexual orientation."

The American School Counselor Association's position statement on professional school counselors and lesbian, gay, bisexual, transgender, and questioning (LGBTQ) youth states: "It is not the role of the professional school counselor to attempt to change a student's sexual

orientation/gender identity but instead to provide support to LGBTQ students to promote student achievement and personal well-being. Recognizing that sexual orientation is not an illness and does not require treatment, professional school counselors may provide individual student planning or responsive services to LGBTQ students to promote self-acceptance, deal with social acceptance, understand issues related to coming out, including issues that families may face when a student goes through this process and identify appropriate community resources."

The American Academy of Pediatrics in 1993 published an article in its journal, *Pediatrics*, stating: "Therapy directed at specifically changing sexual orientation is contraindicated, since it can provoke guilt and anxiety while having little or no potential for achieving changes in orientation."

The American Medical Association Council on Scientific Affairs prepared a report in 1994 in which it stated: "Aversion therapy (a behavioral or medical intervention which pairs unwanted behavior, in this case, homosexual behavior, with unpleasant sensations or aversive consequences) is no longer recommended for gay men and lesbians. Through psychotherapy, gay men and lesbians can become comfortable with their sexual orientation and understand the societal response to it."

The National Association of Social Workers prepared a 1997 policy statement in which it stated: "Social stigmatization of lesbian, gay, and bisexual people is widespread and is a primary motivating factor in leading some people to seek sexual orientation changes. Sexual orientation conversion therapies assume that homosexual orientation is both pathological and freely chosen. No data demonstrates that reparative or conversion therapies are effective, and, in fact, they may be harmful."

The American Counseling Association Governing Council issued a position statement in April of 1999, and in it the council states: "We oppose 'the promotion of "reparative therapy" as a "cure" for individuals who are homosexual'."

The American Psychoanalytic Association issued a position statement in June 2012 on attempts to change sexual orientation, gender, identity, or gender expression, and in it the association states: "As with any societal prejudice, bias against individuals based on actual or perceived sexual orientation, gender identity or gender expression negatively affects mental health, contributing to an enduring sense of stigma and pervasive self-criticism through the internalization of such prejudice; and psychoanalytic technique does not encompass purposeful attempts to 'convert,' 'repair,' change or shift an individual's sexual orientation, gender identity or gender expression. Such directed efforts are against fundamental principles of psychoanalytic treatment and often result in substantial psychological pain by reinforcing damaging internalized attitudes."

The American Academy of Child and Adolescent Psychiatry in 2012 published an article in its journal, *Journal of the American Academy of Child and Adolescent Psychiatry*, stating: "Clinicians should be aware that there is no evidence that sexual orientation can be altered through therapy, and that attempts to do so may be harmful. There is no empirical evidence adult homosexuality can be prevented if gender nonconforming children are influenced to be more gender conforming. Indeed, there is no medically valid basis for attempting to prevent homosexuality, which is not an illness. On the contrary, such efforts may encourage family rejection and undermine self-esteem, connectedness and caring, important protective factors against suicidal ideation and attempts. Given that there is no evidence that efforts to alter sexual orientation are effective, beneficial or necessary, and the possibility that they carry the risk of significant harm, such interventions are contraindicated."

The Pan American Health Organization, a regional office of the World Health Organization, issued a statement in May of 2012 and in it the organization states: "These supposed conversion therapies constitute a violation of the ethical principles of health care and violate human rights that are protected by international and regional agreements." The organization also noted that reparative therapies "lack medical justification and represent a serious threat to the health and well-being of affected people."

Finally, it is imperative to note that this measure in no way impacts the right of religious organizations to offer conversion counseling or "ex-gay" programs on their own grounds or under the supervision of churches. Rather, this bill merely prevents certified professional counselors from doing so, protecting the public from those who would misuse their professional status to perpetrate medically inaccurate and psychologically hazardous practices—bullying and discrimination—on our keiki.

On behalf of the nearly 600 registered members of the Young Progressives Demanding Action (YPDA) Hawai?i, I would like to express strong support for SB270.

Conversion therapy is unethical. Not only has the American Psychological Association determined that the "results of scientifically valid research indicate that it is unlikely that individuals will be able to reduce same-sex attractions or increase other-sex sexual attractions through [conversion therapy]," but it has also shown that children experiencing the parental rejection associated with such therapy are more than eight times as likely to commit suicide, nearly six times more likely to report high levels of depression, more than three times as likely to use drugs and more than three times as likely to be at high risk for HIV and other STDs.

Conversion therapy is wrong. Sexual orientation is not a choice, it is a part of a persons' identity. To arbitrarily decide that an integral part of another human being's identity is wrong based on religious or so-called "moral" reasons is a cruel violation of that human being's self-determination. Self-determination is a human right. What's more, these are children. And forcing conversion therapy on them is tantamount to predation. Conversion therapists are taking advantage of vulnerable children who are struggling with their identities in an often hostile society. There is nothing moral about violating human rights and taking advantage of children to push an organized religious creed or social agenda. We must outlaw this harmful, unethical, immoral practice in Hawai?i.

Dear Chairperson Baker and Vice Chairperson Tokuda:

I write to you in support of SB 270, "Relating to Minors."

The National Center for Lesbian Rights (NCLR) is a national nonprofit legal organization dedicated to protecting and advancing the civil rights of lesbian, gay, bisexual, and transgender (LGBT) people and their families. NCLR's youth project was founded in 1993 specifically to address the mistreatment of LGBT youth in the mental health system. As part of the #BornPerfect campaign, we support a network of survivors of these dangerous and discredited practices through the process of telling what can be deeply retraumatizing stories. We have seen firsthand the devastating impact on parents and families when they are misled by state-licensed professionals who give them false information that therapy can change a child's sexual orientation or gender identity. Tragically, based on our direct experience as well as that of others who serve this young population, all the children subjected to these dangerous practices are harmed, but not all of them survive.

Modern science recognizes that being LGBT is not a disorder. In 2009, the American Psychological Association reviewed all the empirical and expert clinical data on decades of conversion therapy treatments and concluded that there is no scientific evidence that such efforts are effective, and significant evidence that they are harmful—especially for children—and linked to dramatically increased rates of depression, substance abuse, risky sexual behavior, isolation, and even suicide. Because these practices have no scientific basis, provide no benefits, and carry such high risks, every one of the nation's leading medical and mental health associations have issued policy statements condemning them. In October 2015, the Substance Abuse and Mental Health Services Administration published a report from the nation's foremost experts on LGBTQ youth mental health, describing these practices as ineffective and inappropriate and calling for their end.

NCLR has helped defend laws like SB 270 before the Third and Ninth Federal Circuit Courts, both of which have concluded that these regulations are legally beyond dispute. This past May, the U.S. Supreme Court declined to review a law just like this one for a fourth time. The courts have made it clear that these regulations are constitutionally sound. This bill does not affect the free speech of doctors or the ability of minors to seek any type of medically sound therapeutic treatment. Like all other laws that protect the public against ineffective and unsafe treatment by licensed professionals, it will only ensure that state-licensed mental health providers cannot subject minor patients to dangerous, ineffective, and discredited practices—and cannot defraud and mislead loving parents who would never knowingly place their children at risk of such serious harms, and who count on the law to regulate medical professionals to prevent them from harming their children.

Working closely with survivors of conversion therapy, I know all too well that this is truly a matter of life and death. We have lost too many along the way to finally ending these practices for good. The tragic death by suicide of Leelah Alcorn, a transgender teenage girl who said that undergoing conversion therapy made her feel more isolated and rejected, has been a wake-up call to much of the country that we need to act now to protect our children from an industry that profits from their pain. SB 270 would protect the most vulnerable among us from being told that who they are is wrong and protect families from the terrible pain of discovering that they have been defrauded by trusted professionals who abuse their state licenses to tell children that they were born anything but perfect.

I respectfully request that the Committee adopt a favorable report for SB 270 as expeditiously as possible.

On behalf of Hawaii Children's Action Network (HCAN), we are writing to support SB 270, which would prohibit licensed mental health professions from practicing conversion therapy on minors.

Hawaii's children should never be subjected to harmful practices by their trusted mental health professionals. Sexual orientation change efforts ("SOCE"), commonly known as conversion therapy, has been shown to cause lasting harm to young people, and the nation's leading mental health organizations, including but not limited to the American Psychological Association and the National Association of Social Workers, have condemned the practice.¹ SOCE and family rejection of lesbian, gay, bisexual, and transgender (LGBT) youth has been linked to anxiety, depression, and suicide. Those who practice SOCE on minors base their practice on the assumption that sexual orientation is a choice, and that homosexuality is a disorder that can and should be "cured." The medical consensus is that this is untrue, and the practice of conversion therapy violates best practices in mental health.

In addition to potentially causing serious negative health outcomes for young people, SOCE is ineffective in changing a person's sexual orientation. Those who advertise that they can change a person's sexual orientation through therapy may be acting in violation of Hawaii's consumer protection laws. In 2015, a New Jersey trial court found that an organization claiming to have the ability to "convert" people from gay to straight acted in violation of the state's consumer protection laws. Laws banning SOCE, on the other hand, have been upheld in several jurisdictions, and the United States Supreme Court has declined review of federal rulings upholding these bans. SB 270, if passed into law, would almost certainly withstand any similar constitutional challenge.

For these reasons, HCAN respectfully requests your Committee to support this measure.

HCAN is committed to building a unified voice advocating for Hawaii's children by improving their safety, health, and education.

Testimony IN SUPPORT OF SB270 RELATING TO MINORS

The Hawaii Psychological Association (HPA) supports SB270 which seeks to protect the physical and psychological wellbeing of minors against exposure to harm caused by Sexual Orientation Change Efforts (SOCE; also known as "Conversion Therapy"). According to the American Psychological Association (APA), there is insufficient research evidence to demonstrate the efficacy of SOCE. There is also no evidence that providing SOCE therapies to children or adolescents has an impact on their Adult sexual orientation or on adult gender identity.

The APA found SOCE therapies tend to do more harm than good. Not only do children and adolescents get misinformation, they also are at risk of increased self-stigma and psychological distress. Children and adolescents who participate in these types of interventions are given inaccurate scientific information regarding sexual orientation and gender identity. These types of therapies also often use fear based techniques and have the potential to increase stigma. Participants also often report an increase in distress and depression especially when such "therapies" do not work. SOCE participants report negative consequences of SOCE interventions such as, anger, anxiety, depression, guilt, hopelessness, loss of social support, relationship problems with significant others and families, social isolation, suicidal thoughts, self-hatred, and sexual dysfunction. As such, these types of coercive techniques are contrary to current clinical and professional standards. These types of interventions violate current clinical practice by not protecting the client's autonomy and by ignoring scientific information on sexual orientation and gender identity.

Although some opponents of this bill have tried to suggest that there is disagreement among researchers about the evidence in this area, they have referenced publications by anti-gay

organizations only. All the major organizations of professionals involved in treating children have issued statements opposing Sexual Orientation Change therapy, including the American Psychological Association, the American Medical Association, the American Academy of Pediatrics, the American Psychiatric Association, and the National Association of Social Workers. This consensus of professional opinion is very well documented in a 2015 publication by the Federal Substance Abuse and Mental Health Services Administration (SAMHSA; Substance Abuse and Mental Health Services Administration, Ending Conversion Therapy: Supporting and Affirming LGBTQ Youth. HHS Publication No. (SMA) 15-4928. Rockville, MD: Substance Abuse and Mental Health Services Administration, 2015. The bill does not hinder mental health providers, clergy or parents from counseling youth or offering a range of other, more standard clinical psychological services to lesbian, gay, bisexual, and transgender (LGBT) children and adolescents. The bill regulates the services being provided to LGBT children and adolescents to provide them protections against being exposed to harm through SOCE therapies that might be chosen for them by adults. The bill is in line with APA practice standards.

The Human Rights Campaign (HRC), on behalf of its members and supporters in Hawaii, thanks you for the opportunity to submit testimony on Senate Bill (SB) 270, a vital measure that will protect young people in Hawaii from dangerous and discredited practices that falsely claim to change one's sexual orientation or gender identity or expression. We urge you to swiftly pass this important legislation.

The Human Rights Campaign is America's largest civil rights organization working to achieve lesbian, gay, bisexual, transgender, and queer (LGBTQ) equality. By inspiring and engaging all Americans, HRC strives to end discrimination against LGBTQ citizens and realize a nation that achieves fundamental fairness and equality for all. As an advocate for LGBTQ young people, HRC believes that no young person should be coerced or subjected to dangerous practices that lack legitimate medical purpose, such as conversion therapy.

Conversion therapy, sometimes called "sexual orientation change efforts" or "reparative therapy," refers to practices that seek to change an individual's sexual orientation or gender identity or expression. These practices are based on the false idea that being LGBTQ is a mental illness that needs to be cured, an idea which has been rejected by every major mental health group. Conversion therapy does not include therapies that provide acceptance, support, or understanding of LGBTQ identities; that facilitate coping, social support, or identity exploration; or that address unlawful conduct or unsafe sexual practices. This legislation enacts professional standards for state-licensed mental health providers to clarify that conversion therapy is not an acceptable or responsible professional practice when applied to young people under the age of eighteen.

There is no credible evidence that conversion therapy can change a person's sexual orientation or gender identity or expression, and it is abundantly clear that conversion therapy poses devastating health risks for LGBTQ youth. These practices can lead to

depression, decreased self-esteem, substance abuse, homelessness, and even suicidal behavior, and for this reason the nation's leading mental health organizations have roundly decried them. Unfortunately, due to discrimination against LGBTQ people and the fact that professional rules have not kept up with this widespread understanding, some licensed mental health professionals continue to engage in conversion therapy. A recent Williams Institute at UCLA School of Law report revealed that an estimated 20,000 LGBT minors in states without protections will be subjected to conversion therapy by a licensed healthcare professional if state officials fail to act. These protections simply cannot wait.

Research shows that young people experience conversion therapy as a form of family rejection, and LGBTQ youth who experience family rejection face increased health risks. In one study, such youth were 8.4 times more likely to report having attempted suicide, 5.9 times more likely to report high levels of depression, and 3.4 times more likely to use illegal drugs compared with peers who had not experienced such rejection. On the other hand, family acceptance has been shown to be an important protective factor that can help to prevent suicide behavior and mental health issues. Providers who engage in conversion therapy under state license can mislead families about the risks involved, leading to negative psychological outcomes and irreparable damage to family cohesiveness. This legislation is needed to protect families from these damaging practices.

Thank you for the opportunity to submit testimony in favor of this critical bill to protect LGBTQ youth.

Honorable Chairs and members of the Senate Committee on Consumer Protection & Health, I am Walter Yoshimitsu, **representing the Hawaii Catholic Conference**. The Hawaii Catholic Conference is the public policy voice for the Roman Catholic Church in the State of Hawaii, which under the leadership of Bishop Larry Silva, represents Roman Catholics in Hawaii.

We oppose this bill because it bans reparative therapy for minors, even if the minor themselves or the parents want the therapy. That is awfully invasive on the part of the legislature, which has no competence in this area. The wording in SB270 offers no exemption for clergy, religious or spiritual counselors who are licensed by the state, which we find problematic and a violation of religious freedom.

To make it abundantly clear, the Catholic Church is concerned for the whole person. And in the mind of the Church, the psychological sciences, in accord with Christian anthropology, are not considered separate from pastoral care, but rather integral to it. The care and dignity of the human person is the core foundation for what we believe as Catholics.

In 1995, the Pontifical Council for the Family issued a document, "The Truth and Meaning of Human Sexuality: Guidelines for Education in the Family." The document states that "[y]oung people need to be helped to distinguish between the concepts of what is normal and abnormal, between subjective guilt and objective disorder, avoiding what would arouse hostility." It also states that "if parents notice the appearance of this tendency or of related behavior in their children during childhood or adolescence, they should seek help from expert qualified persons to obtain all possible assistance."

This bill would keep patients, and their parents, from exercising their fundamental right to choose the therapy they feel best meets their needs. Their individual choice in therapy should be taken into consideration. Every patient deserves the right to get the help they need and secure a counselor that supports their counseling goals.

I am an obstetrician-gynecologist and I provide gynecologic and reproductive healthcare to children and adolescents. Childhood and adolescence are periods of rapid change during which young people are forming their identities and gaining an understanding of themselves with respect to gender identity and sexual orientation. It is imperative that we as a society support our young people in this process, regardless of the identities that they discover for themselves.

Reparative or conversion therapies employ guilt, anxiety, and shame as strategies to convince children and adolescents that certain sexual orientations or gender identities are pathologic. These interventions are not based on scientific evidence, and current evidence demonstrates that these therapies are harmful. Conversion therapy can be extremely dangerous and, in some cases, fatal. In 2009, the APA issued a report concluding that the reported risks of the practices include: depression, guilt, helplessness, hopelessness, shame, social withdrawal, suicidality, substance abuse, stress, disappointment, self-blame, decreased self-esteem and authenticity to others, increased self-hatred, hostility and blame toward parents, feelings of anger and betrayal, loss of friends and potential romantic partners, problems in sexual and emotional intimacy, sexual dysfunction, high-risk sexual behaviors, a feeling of being dehumanized and untrue to self, a loss of faith, and a sense of having wasted time and resources.

The risks are even greater for youth. Minors who experience family rejection based on their sexual orientation or gender identity face especially serious health risks. Research shows that lesbian, gay, and bisexual young adults who reported higher levels of family rejection during adolescence were more than eight times more likely to report having attempted suicide, more than five times more likely to report high levels of depression, more than three times more likely to use illegal drugs, and more than three times more likely to report having engaged in unprotected sexual intercourse compared with peers from families that reported no or low levels of family rejection.

I ask for your vote in support of SB270 to stand up to protect our children that can't stand up and protect themselves from this dangerous practice.

To Hawaii's Senate Committee for Consumer Protection and Health:

With the consent and support of my husband, Max Earl Hughey, Jr., I implore you to ban so-called conversion therapy, which has long been, and continues to be, a cruel euphemism for sanctioned programmatic torture.

In the 1970s, my husband, then a completely sexually inexperienced sixteen-year-old, came out to his Michigan Assemblies of God family, the single-most disastrous decision of his life. His parents were persuaded to commit him to a local sanitarium for a period of three months of religiously based "therapy," during which time he was daily strapped to a gurney, sobbing and screaming, savaged by caustic chemicals like Indoklon gas, and unremittingly shocked with electroconvulsive treatments—all for having done nothing but admit a same-sex attraction. One of the many horrific details of the procedure that so often goes undiscussed is its tacit terror. It is, in point of fact, a form of extraordinary rendition: subjects are typically taken off the grid for their "therapy" and gulaged from any chance of rescue or outside support; they're kept in a controlled state of secrecy, vulnerability, anxiety, and helpless dependency on their captors. In Max's case, not only were his parents prevented from monitoring his brutal reprogramming procedures, even sympathetic medical staff were threatened not to intervene on his behalf. Eventually, his involuntary screams during the procedure had become so uncomfortable for the staff to hear, a paralyzing agent was administered to his vocal cords to ensure he would remain unheard during and after the procedure. To this very day, now at age 63, he still has night terrors about being fully conscious but unable to scream while his brain felt like it was disintegrating into ash.

None of my own words can adequately capture with accuracy the *degree* of terror this innocent sixteen-year-old was forced to experience, nor the ineluctable lifelong consequences of it. An extremely bright, ethically grounded, and otherwise untroublesome "A" student--one who dutifully looked out for his disabled brother and tried to make sense of his own adolescence, just like any other teen—had his life, his health, and his family relationships destroyed in the name of therapy. After his sanitarium experience, Max soon broke ties with his family, lapsed into severe

depression, and for a time lived out of his car. After meeting a partner, Chip, who helped to lift him from this lowest point of his life, Max found the courage to go back to school, earned a prestigious scholarship to attend law school, and eventually landed a career as one of the youngest hospital administrators ever to have worked for an ivy league medical center. Just as he seemed to be putting the past behind him, those three months in the sanitarium found yet more ways to scourge his life. Because of the longterm effects of the chemicals he endured, along with the trauma of the experience, itself, Max succumbed to a rare intractable ulcer syndrome that led to a near fatal gastric bleed and incurred two major surgeries, the last of which removed two-thirds of his stomach. The primary and secondary consequences of these surgeries have resulted in more than thirty years of living with severe medical disability, physical discomfort, and daily pain management. Owing to the permanent postsurgical gastric syndrome that followed, he has been generally unable to eat solid food without becoming violently ill and going into shock. For a while, the subsequent damage to his pancreas made him a subject of curiosity for medical research: he had been one of merely a handful of insulin-resistant patients in the U.S. to be hooked up to a U500 insulin pump 24-hours a day. Throughout all of this, though, the emotional scars of his conversion experience have not lessened, nor have they been overshadowed by these ongoing physical and medical problems. Unalleviated by clinical trauma therapy, the post-traumatic stress remains shackled to him for life, manifesting in heart disease, chronic sleep deprivation, frequent somnambulance, aggressive Type 2 diabetes, and constant management of malnutrition and malabsorption, not to mention the very real triggers that continue to send him into sudden panic attacks.

In submitting this testimonial, Max and I realize we are fortunate to be alive in an era where our relationship is at last respected through the sanctity of civil marriage (for now, anyways). However, that this testimonial should warrant a trigger warning is more than just a painful irony. Hiding in plain sight, bigoted religion-based rendition techniques like conversion "therapy" continue to torture young people in the name of religious freedom and health, as if there were anything legitimately spiritual or medical about any of it. (In fact, some of its victims aren't even gay or bisexual!) As a nation, we cannot claim to be uncomfortably disturbed by the plight of minors forced to submit to torture, then at the same time sanction paralyzing them of the one defense they have left: an ability to cry out to us for help! Max and I beg you--BEG YOU!--not to let his happen to your children, your neighbors' children, your fellow parishioners' children, or anyone else. Conversion therapy is not merely a lie, it is a life sentence of trauma and misery. Confusing morality with wellness, it gives the false imprimatur of "therapy" to an inquisitor's brainwashing, all so that an ideological minority can feel more comfortable with a child who was merely born different.

You have a voice that can speak for the silenced, and the power to stand up to their abusers. Please use these to make compassion and justice your legacy. Work to ban conversion therapy from all U.S. territories. We've lost more than enough young people to senseless violence this past year.

The seriousness of our commitment to research, advocacy and ethical treatment of our clients based on the analysis we conduct for all populations best interest is in question with this Bill. I do find it hard to support something for the state of Hawaii that uses findings of a research study conducted without the data for the state of Hawaii as a base for Hawaii State Senate action. According to the APA (2009), "The task force concluded that the population that undergoes, [Sexual Orientation Change Efforts (SOCE)], tends to have strongly conservative religious views that lead them to seek to change their sexual orientation (APA, 2009)." These facts not presently produced in the introduction section of this Act insinuation that members of the National Association of Social Workers, (NASW) in Hawaii and other ethical professions are engaging in behavior that favors a bais to conservative views and not the Practitioner-Scholar model. A practice based on the personal views of the provider which overlooks the views of the client/patient violates just about all of our Principles and NASW Code of Ethics. We believe in the research we conduct to base our services on for the populations and communities views we live in and work alongside. Also under the section titled Social And Political Action, Section 6.04c, "Social workers should act to prevent and eliminate domination of, exploitation of, and discrimination against any person, group, or class on the basis of race, ethnicity, national origin, color, sex, sexual orientation, age, marital status, political belief, religion, and mental or physical disability (Buila and NASW, 2010)." If our research and task forces are correct as stated at the start of the introduction, then why would we willingly violation of our code of ethics. According to the APA, (2009) "The task force conducted a systematic review of the peer-reviewed journal literature on Sexual Orientation Change Efforts (SOCE). The Taskforce concluded that efforts to change sexual

orientation are unlikely to be successful and involve some risk of harm, contrary to the claims of SOCE practitioners and advocates, (APA, 2009)." Conducting conservative based practice in our community that is mostly liberal would not be meeting our clients where they are which would also violate our principles and Code of Ethics, which our association already have the power to correct. Medical, scientific, and government organizations in the United States and United Kingdom have expressed concern over conversion therapy practices as ineffectgive and consider it potentially seriously harmful. Various legal jurisdictions in Asia, Europe, and the Americas have passed laws against conversion therapy.

The American Psychiatic Association (APA) opposes psychiatric treatment "based upon the assumption that homosexuality *per se* is a mental disorder or based upon the a priori assumption that a patient should change his/her sexual homosexual orientation" and describes attempts to change sexual orientation by practitioners as unethical. United States Surgeon General David Satcher in 2001 issued a report stating that "there is no valid scientific evidence that sexual orientation can be changed".

An article in the Huffington Post in 2016 reported that, "Conversion therapy causes serious harms," NCLR Legal Director Shannon Minter told The Huffington Post. Testimony in Support of S.B. 270 with amendments

Aloha Senator Baker, Senator Tokuda, and Members of the Senate Committee on Commerce, Consumer Protection and Health,

I am submitting this testimony in support of prohibiting conversion therapy on minors that would include practices or treatments that seek to change an individual's sexual orientation or gender identity or gender expression. I am recommending amendments to this bill to seek prohibition of "conversion therapy" rather than "sexual orientation change efforts" because the term "sexual orientation change efforts" is the wrong term to use to also ban efforts to change gender identity and gender expression, and by trying to define this term as inclusive of efforts to change "gender identity, or gender expression" would only serve to confuse these terms for the public, providers, and in enforcement.

Sexual orientation and gender identity are two distinct aspects of human sexuality in our western framework, and conflating these two aspects under sexual orientation is incorrect and consistent with current definitions by health authorities, is not consistent with how Hawaii civil rights laws specifies these two terms as distinct, does not give appropriate and equal focus to transgender youth when gender identity change efforts are buried within the definition of sexual orientation change efforts, and does not recognize current efforts in states to simply ban "conversion therapy" and to define "conversion therapy to specify the types of practices being banned giving each practice appropriate delineation.

I am including here the link to the model legislation that was developed by the National Center on Lesbian Rights, an organization that is in the forefront of consultation to states on conversion therapy legislation. This model legislation provides easily adaptable language to correct SB 270. (See "Sample Legislation to Protect Youth from Conversion Therapy", at http://www.nclrights.org/wp-content/uploads/2015/10/SampleAntiConversionTherapyBill 2016-1.pdf. In this "Sample Legislation," you will also find more justification for prohibiting both sexual orientation and gender identity conversion therapy than is currently in SB 270 that could also be cited in SB 270. Also, another informative source on the definition of terms is found in the 2015 federal SAMHSA report, "Ending Conversion Therapy: Supporting and Affirming LGBTQ Youth" (see Executive Summary and Glossary in the Appendix) at: https://store.samhsa.gov/shin/content/SMA15-4928/SMA15-4928.pdf.

I am sorry for submitting this testimony late and hope you will consider the important points in this testimony that will help to accomplish the basic purpose of prohibiting conversion therapy to be practiced on minors.
