Purpose of Bill:	Proposes amendments to the Constitution of the State of Hawaii to advance the State's goal of providing a quality education for the children of Hawaii by authorizing the legislature to establish, as provided by law, a surcharge on residential investment property and visitor accommodations.

#### **Department's Position:**

The Department of Education supports the intent of this measure, yet respectfully defers to the Department of Taxation and the Department of Budget and Finance for implementation and fiscal impact analysis.

The Department has made every effort to wisely spend appropriations provided. However, funding has not kept pace with 2008 levels of state fiscal support, adjusted for inflation as measured by the Consumer Price Index.

Education is a key investment in the state's economic development and an investment in its local employee base capacity for all Hawaii industries. A funding increase will provide adequate student funding and teacher pay to support an equitable high quality instructional system with respectful 21st century learning environments through quality facilities.

Thank you for the opportunity to provide testimony on this measure.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. This is achieved through targeted work around three impact strategies: school design, student voice, and teacher collaboration. Thank you for the opportunity to testify in **opposition** to this measure. The purpose of this bill is to amend the Constitution of the State of Hawaii by authorizing the legislature to establish a surcharge on residential investment property and visitor accommodations.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I **oppose** this measure for the following reasons:

- 1. Although the Department of Education receives almost 20 percent of the entire budget of the State of Hawaii, administrators, teachers, students and advocates of this bill have legitimate reasons to demand more funding to provide quality education for our keiki. However, the proposed measure is flawed, which is why I implore the legislature to defer this bill.
- 2. Increasing costs of visitor-related programs like transportation, sewer and water, fire, police, and parks maintenance continue to be a challenge as the counties do not receive a fair share of the transient accommodations tax. To pay for these services, businesses and homeowners will continue to be burdened and face potential increases in real property taxes.
- 3. Real property taxes are counties' primary and largest source of revenue to fund county programs. The counties must account for the salary increases for all bargaining units this year, which we are obligated to fund. Raising property taxes is our only reasonable option to balance our budget.

- 4. In many mainland communities, local real estate taxes are used to support local schools. Communities identify local needs and tax residents accordingly. In Hawaii, a decision was made decades ago to establish a statewide school and healthcare system, which differs from most of the nation, and would be funded through state tax collections. If lawmakers and the governor believe schools are underfunded, you should accept responsibility and appropriately fund education without passing the buck and causing financial challenges for the counties.
- 5. The State has far more taxing authority than the counties and should be able to handle any increased need for funds. The premise that the counties should fund schools without having a greater say in the way monies are spent ignores the importance of a community's right to decision making.

For the foregoing reasons, I strongly **oppose** this measure.

Chair Kidani and Members of the Committee:

The Hawaii State Teachers Association **strongly** <u>supports SB 2922</u>, proposing amendments to Articles VIII and X of the Constitution of the State of Hawai'i to authorize the Legislature to establish a surcharge to increase funding for public education.

#### Let the people vote.

Today, we are not asking you to vote on increasing anyone's taxes. Rather, we are urging you to **champion democracy** by allowing the people of Hawai'i to decide whether or not to increase funding for public education.

Hawai'i *still* shortchanges its public schools. While our state's per-pupil spending of \$12,855 ranks 17th in the nation when compared to other states in raw dollars, comparison with school districts of similar size and demographics yields different results. Mainland districts with high costs of living are typically urban and averaged with rural districts experiencing lower costs of living in statewide analyses, a geographic and fiscal situation that is not applicable to the islands' single statewide school district.

When comparing school districts of similar size, Hawai'i ranked 227th in per-pupil funding *before* adjusting for cost of living, according to an analysis performed by Ballotpedia.org. Likewise, the Department of Business, Economic Development, and Tourism reported, in March of 2017, that Hawai'i's education expenditures, as s share of combined state and local government spending, is 27.3 percent, which ranks as the lowest in the nation. Hawaii's major private schools, in contrast, average \$15,173 in per-pupil spending. When Catholic schools, subsidized by the Roman Catholic Diocese, are removed, private school spending jumps to nearly \$19,173 dollars per student, sans endowment funds that further boost private school baselines. Punahou President Jim Scott revealed, in 2014, that the "real cost of our education per student is \$26,000," with the school's endowment standing then at \$235 million and fundraising operations generating an additional \$12-\$15 million each year. It is no wonder, then, that Hawai'i has one of the highest private school enrollment rates in the nation. According to U.S. Census Bureau data, for the 2016-2017 school year, approximately 20 percent of K-12 students on O'ahu attended private schools, with that number rising to 38 percent for students living in the urban core of Honolulu.

The islands also continue to suffer from a shortage of qualified teachers. According to the DOE's STRIVE HI accountability reports, for the 2017-2018 school year, the state saw 1,011 SATEP vacancies, up from 920 SATEP vacancies in 2016-2017, including a slight increase in SPED SATEP vacancies, from 290 in 2016-2017 to 311 in 2017-2018. SPED teacher attrition has led to a situation in which 1 out of every 6 SPED teachers have not completed a state-sanctioned teacher training program. Our teacher shortage problem is further clarified in the DOE's 2016-2017 Employment Report, which shows that teacher resignations increased from 781 in 2015-2016 to 850 in 2016-2017. Similarly in-state SATEP hires decreased from 404 to 387 over that time span, while out-of-state SATEP hires increased from 508 to 572. Teacher attrition is even worse in high-poverty areas. In the Nanakuli-Waianae Complex Area, for example, an astounding 18 out of 19 SPED teachers hired for the 2017-2018 school year do not have a special education license.

Moreover. In 2015, the DOE released a study entitled *Equitable Access to Excellent Educators*, which found that an average of 14.48 percent of teachers in low-poverty schools are inexperienced (haven't completed one full year of full-time teaching), unqualified (have not obtained full licensure in Hawai'i), or teaching out of their field of expertise. In high-poverty schools, however, the study noted that an average of 21.48 percent of teachers are inexperienced, unqualified, or out-of-field. In other

SUBJECT: REAL PROPERTY, TRANSIENT ACCOMMODATIONS, Education Surcharge on Residential Investment Properties and Visitor Accommodations

BILL NUMBER: SB 2922; HB 2608 (Similar)

INTRODUCED BY: SB by KIDANI, S. CHANG, ESPERO, GALUTERIA, HARIMOTO, K. RHOADS, K. KAHELE; HB by WOODSON, AQUINO, BROWER, CREAGAN, DECOITE, EVANS, GATES, ING, JOHANSON, KEOHOKALOLE, C. LEE, LOPRESTI, LOWEN, MORIKAWA, NISHIMOTO, SAN BUENAVENTURA, TODD, Nakamura, Nakashima, Yamashita

EXECUTIVE SUMMARY: Allows the legislature to impose a surcharge on real property tax for residential investment property, and on transient accommodations. We question why this type of increase is being sought given that the Department of Education already has a gargantuan share of the State budget but is still beset with such issues as frustrated teachers and students roasting in our classrooms. Limits should be written into the amendment or the voters should be apprised that they are voting only on granting power to the legislature to impose a state level real property tax surcharge, with no limitations on that power.

SYNOPSIS: Empowers the legislature to establish a surcharge on residential investment property valued at one million dollars or greater and visitor accommodations.

Residential investment property is defined as all real property including apartments and condominiums and appurtenances thereto, including buildings, structures, fences, and improvements erected on or affixed to such real property and any fixture which is erected on or affixed to the land, buildings, structures, fences, and improvements; and all machinery and other mechanical or other allied equipment and the foundations thereof, that are dedicated for residential use and that do not serve as the owner's primary residence.

Visitor accommodations are defined as any room, apartment, suite, single family dwelling, or time share unit furnished for less than one hundred eighty consecutive days for each letting in a hotel, apartment hotel, motel, condominium property regime, apartment, time share vacation property, cooperative apartment, dwelling unit, or rooming house that provides living quarters, sleeping, or housekeeping accommodations, or any other place in which lodgings are furnished to transients.

EFFECTIVE DATE: This amendment shall take effect upon compliance with article XVII, section 3, of the Constitution of the State of Hawaii.

STAFF COMMENTS: A tax increase of any magnitude in Hawaii's fragile economy will, no doubt, have a negative impact as costs soar due to higher taxes. As costs and overhead increase, employers must find ways to stay in business by either increasing prices to their customers or cut back on costs. This may take the form of reducing inventory, shortening business hours,

reducing employee hours, or even laying off workers. A tax increase of any magnitude would send many companies, especially smaller ones, out of business taking with them the jobs the community so desperately needs at this time.

While the teachers believe that they have not been given a fair shake at the negotiating table, that is an issue that should be resolved at the table and not by asking for tax increases or an earmarked source of funding. It is up to the teachers to ask for what money is available just like any other collective bargaining units. Although public employee union leaders complain about how the public employees should not be asked to bear the brunt of the downturn in the economy, they seem to ignore the fact that employees in the private sector have taken hits early and often, with many of them either working shorter hours or having taken pay cuts if they are working at all. A recent analysis of Bureau of Economic Analysis data done by the Grassroot Institute of Hawaii, [http://www.grassrootinstitute.org/2017/01/islanders-shouldnt-be-taxed-extra-for-teacher-bonuses/] for example, showed that Hawaii teachers make low wages and benefits, 42nd in the nation, but that Hawaii's private sector workers made the lowest wages and benefits nationally when adjusted for cost of living.

Teachers do have a legitimate complaint that should demand the attention of lawmakers and Board of Education members, namely that teachers are being asked to do more and more administrative work and are spending less and less time in the classroom. If nothing else, the funds that are being appropriated to the DOE are failing to reach the classroom because of the top-heavy administrative structure of the department that demands reports and schedules and evaluations to justify the role of administrators. The frustration of classroom teachers is that they spend too much time filling out forms and reports and not enough time in the actual classroom. Unfortunately, with more than \$1.5 billion in its budget and more than 20% of the general fund budget, teachers are frustrated, and kids are roasting in the schools. The department of education still cannot get it right. It needs to be able to spend its existing resources efficiently. Until it does, there is little justification for an increase of financial resources.

Also, it is troubling that there are no limits on the proposed tax. The current version of SB 686, implementing legislation designed for last year's version of this bill, would if approved impose a surcharge of \$7.50 per \$1,000 of property value on "residential investment" properties that are valued at \$2 million or more. But if the constitutional amendment is approved, there is no reason why legislators can't change the implementing legislation or come up with an entirely new bill. It could be the year the amendment is approved, or the next year, or the year after that. They could change it to impose the surcharge on all "residential investment" property regardless of value. They could change the surcharge rate. They could do all these things because the constitutional amendment gives the legislature this power.

In other words, once the amendment passes, the genie is out of the bottle. It may not even be under control of the members now in the legislature, because future legislators (note that this year is an election year) may have different ideas from current members. Re: HB 2608 Page 3

We need to ask ourselves if we want to or need to give the genie that much power. If we do, then we only have ourselves to blame for what happens when the genie does come out. If we don't, then we should either kill the constitutional amendment or write strict limits into it.

Honorable Chair Kidani and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 400 members. On behalf of our members, we offer this testimony <u>in strong support of</u> Senate Bill 2922, proposing amendments to Articles VIII and X of the Constitution of the State of Hawai'i to authorize the Legislature to establish a surcharge to increase funding for public education.

In comparison to school districts of similar size and demographic composition, Hawai'i, ranks 227th in per-pupil funding *before* adjusting for cost of living, at \$12,855 per child. Washington D.C., New York City, Boston, Pittsburgh, and Cincinnati school districts, for example, spend nearly twice as much as Hawai'i per pupil, at well over \$22,000 to over \$26,000 per student. Similarly, local private schools, discounting Catholic institutions, spend nearly \$19,173 dollars per student, with Punahou President Jim Scott revealing, in 2014, "The real cost of our education per student is \$26,000," owing to the school's then-total endowment of \$235 million and fundraising operations of \$12-\$15 million annually.

Moreover, for the 2017-2018 school year, the Hawai'i State Department of Education report 1,011 teacher vacancies. The number of new teachers hired who have not completed a state approved teacher education program has increased from 125 for the 2011-2012 school year to 294 for the 2016-2017 school year. Over the same period, the number of teacher resignations has increased from 624 in 2011-2012 to 850 in 2015-2016, while the total number of voluntary teacher separations has increased from 934 in 2011-2012 to 1,170 in 2016-2017. In short, hundreds of

teachers are leaving the workforce each year at an accelerating pace, while the DOE does not have enough trained and licensed teachers in waiting to fill the holes they leave. Accordingly, we must raise Hawai'i's last-in-the-nation teacher pay (adjusted for cost of living) as a means of addressing the problem. Studies have shown that as teacher pay increases, so, too, does student achievement. A Stanford University study found that "raising teacher wages by 10 percent reduces high school dropout rates by 3 percent to 4 percent," while a Florida study showed that pay raises reduced teacher attrition by as much as 25 percent for hard-to-fill subject areas, with children's learning growth gaining from more exposure to experienced educators. Recently, the Hawai'i State Teachers Association performed a study of teacher compensation in comparison with mainland peer districts. HSTA discovered that teachers' wages are \$4,000 to \$26,000 below that of their mainland peers. Put simply, to reduce teacher turnover, we must pay educators what they're worth.

We are also heartened by this measure's potential for making Hawai'i more affordable. Hawai'i residents face the highest housing costs in the nation, at more than twice the national average. Researchers who authored the National Low Income Housing Coalition's Out of Reach 2017 report found that a full-time worker would need to earn \$35.20/hour to afford a two-bedroom apartment at fair market value in our state, with Honolulu experiencing a 67 percent increase in fair market rent between 2005 and 2015. Average rent for a two-bedroom unit surpassed \$2,000 in recent years, with minimum wage workers needing to log 116 hours per week to afford a modest one-bedroom apartment at fair market value and 139 hours per week to afford a two-bedroom-a number that is equivalent to working 20 hours a day with no days off year-round. In the past three years alone, Honolulu rent has increased by more than 25 percent. While 46 percent of Hawai'i residents are renters (a number that does not include individuals and families renting outside of the regulated rental market), they earn an average wage of \$16.53/hour, scarcely enough to meet their basic needs. One out of every four households in Hawai'i report that they are "doubling up" or are three paychecks or less away from being homeless, per the Hawai'i Appleseed Center for Law and Economic Justice. Additionally, 54 percent of households are cost-burdened, meaning that they pay more than 30 percent of their income for housing costs, a number that rises to 83 percent of extremely low-income households.

We are in the midst of an affordable housing crisis. Our state's cost of housing has skyrocketed over the last decade, leaving many families searching for affordable alternatives, in shelters, or on the streets. For context, the median price of condominiums on O'ahu increased 6 percent in the summer of 2017 to a record \$425,000, while the median price for single-family homes increased by 3 percent to \$795,000, according to the Honolulu Board of Realtors, a number that they expect to increase by at least another 5 percent in 2018. Average fair market rent for two-bedroom apartments in *outlying* communities in the City and County of Honolulu now exceeds \$2,700, with the cost of a four-bedroom home in urban Honolulu now exceeding \$1.1 million. At least 46 percent of residences in Hawai'i are owner unoccupied, according to the National Low-

Income Housing Coalition, meaning that nearly 50 percent–and by some estimates over half–of Hawai'i's homes are likely investment properties.

Many of those properties, in turn, are owned by mainland and foreign buyers, whose real estate market speculation is a prime driver of Hawai'i's highest-in-the-nation cost of housing. According to a study released in May of 2016 by the Hawai'i Department of Business, Economic Development, and Tourism, there are "clear distinctions" between the average price of homes bought by local residents, mainlanders, and foreigners. Analyzing purchases made between 2008 and 2015, DBEDT found: "The average sale price was highest among foreign buyers. The average sale price of the total of 5,775 homes sold to foreign buyers from 2008 to 2015 was \$786,186, 28.3 percent higher than the average sale price to the mainlanders (\$612,770) and 64.7 percent higher than the average sale price to local buyers (\$477,460)." Experts at DBEDT now estimate that Hawai'i needs 66,000 new housing units by the year 2025 to keep up with demand, more than 80 percent of which is needed to meet the demand of people who qualify for affordable housing. Yet, for every 100 extremely low-income renters on O'ahu, there exist only 40 affordable rentals, according to the Urban Institute, of which only 11 are "naturally affordable," meaning they are affordable without federal subsidies.

We must ask ourselves: do we want to allow people who live outside of Hawai'i to use the islands as their private monopoly board or do we want to create a first-rate education system for our children? We submit that this constitutional amendment disincentivizes the rampant real estate speculation driving up our state's housing and rental prices and forces those most responsible for pricing families out of paradise to pay their fair share to improve our keiki's future.

All children deserve a chance at happiness and prosperity. Mahalo for the opportunity to testify <u>in support</u> of this bill.

Dear Chair Kidani and Members of the Committee,

The Special Education Advisory Council (SEAC), Hawaii's State Advisory Panel under the Individuals with Disabilities Education Act (IDEA), **strongly supports the intent** of S.B. 2922 to increase funding for public education in Hawaii.

Hawaii serves a smaller percentage of students with disabilities compared to the entire student population than the national average--10.6% compared to 13.0% for most states--which may indicate that we are not identifying and serving all students who are eligible for special education services. Those who are served have experienced lackluster progress and a growing achievement gap with their non-disabled peers. Hawaii also serves significantly fewer children in the general education classroom contrary to IDEA mandates for placement in the least restrictive environment.

To address these inequities will take additional resources, including higher teacher pay to attract more qualified teachers to the field, smaller class sizes to encourage greater inclusion and specialized services and supports to meet the unique learning needs of these students. An enhanced funding stream for public education would benefit ALL children in Hawaii, including those who are most vulnerable to academic failure.

I am Marcia Linville M.S., Education Caucus, State Central Committee member, Democratic Party of Hawaii, testifying in support of SB 2922.

I have been a librarian at the state, city, special, and federal levels for over 50 years. I have taught at both the school and college level, and been an education delegate to both China and Eastern Europe. I have also served as Board member for Hawaii Literacy, League of Women Voters, Hawaii Library Association, President of the Library Association of Hawaii, and for almost 20 years as Agency Council Head, Unit 13, DOE, HGEA. Every single one of the positions has been adversely impacted by the underfunding of the DOE.

From the inability to recruit and retain qualified teachers, school librarians, and special education staff, to lack of supplies, heat abatement, unrepaired facilities, and to the many problems you have heard of from teachers, students, parents and general public for the last 50 years, inadequate funding has been cited as a major factor. Decades long evasion of this probem has resulted in a two class system of education, as those who can afford to send their children to private school do so, and seventy two per cent of our public schools become Title One schools and more and more educational services are reduced or removed.

SB 2922 provides a partial solution to those problems. Money won't fix all the problems of the DOE, but you can't fix the problems without money. Many solutions have been suggested for obtaining additional funding for your children's schools. None of them have proved both acceptable and adequate.

SB 2922 will adversely impact only those properties valued at over one million dollars, affecting only a small but influential population. I believe the general public will feel that this small, influential population, which is largely out of state, can afford the additional investment in it's future work force, since they will otherwise find it necessary to hire from out of state, further complicating our limited and expensive housing situation.

Dear Chair Kidani, Vice Chair Kahele, and members of the Committee:

Thank you for the opportunity to testify in SUPPORT of **SB 2922**, which proposes amendments to the Constitution of the State of Hawaii to advance the State's goal of providing a quality education for the children of Hawaii by authorizing the legislature to establish, as provided by law, a surcharge on residential investment property and visitor accommodations.

Hawai'i is the only state in the nation that doesn't use property taxes to help fund our schools. We also have the lowest property taxes in the nation, according to the Tax Foundation. Our effective rate is 0.28 percent of home value, which is almost ten times lower than the rate in states like New Jersey, Illinois and New Hampshire.

Such low property taxes make it easier for out-of-state investors to purchase properties in Hawai'i and leave them vacant for much of the year, which drives up home prices and reduces the amount of housing available to local residents.

Meanwhile, our state's public school performance was graded a D-plus for K-12 achievement, C-plus for Chance-for-Success, and a C overall by Education Week. To improve these grades, our schools will need more funding.

SB 2922 would put a question on the ballot for the public to vote to amend a specific section of the Constitution that would allow a state surcharge on investment properties valued at over a million dollars, and excluding owner-occupied homes. This bill would also add a surcharge to visitor accommodations to help fund our public schools.

For the reasons outlined above, the proposed ballot question deserves to be put before the public for a vote. We appreciate your consideration of this testimony.

I have just participated in a social and emotional learning professional sevelopment event which has confirmed my beliefs from many years of teaching, about the importance of supporting the social and emotional needs of our students so that they may succeed in the 21 Century. With the positives of a technologically driven society come the negatives, one being the lack of opportunities to build face to face relationships with others and to develop citizens who are true community contributors. It is easy to see these "negatives" from observing the increasing violence in which the perpetrators seem to be people who have lost that sense of community and compassion; that human connection.

Studies have been showing for many years that before any deep learning can occur, a person needs to feel safe, have skills to work with others, to persist through "thick and thin"; to feel intellectually safe. Unfortunately, time is needed in order to build these positive relationships and trust between teachers and students. My name is Candace Chun and I've been a teacher for 35 years with the Hawaii Department of Education. I am from the Central District on Oahu. I am submitting testimony in support of SB2922 to increase funding for public schools.

Every dollar invested in our community's public schools supports the work we are doing to prepare our youth for meeting the needs of our community and being successful in the 21st century. For instance, I teach the health professions, and it is crucial for us to have knowledgeable instructors in order for students to receive the best education so that they can pursue those careers. Currently, we have a critical shortage of teachers. I've seen this problem grow worse over the years, and there just are not enough qualified teachers in our classrooms. Ask the students and they are not considering a career in teaching. Just within our school, the turnover rate is so high, many are being recruited from the mainland or lack any experience. Many are uncertified, so our students are being very shortchanged with their education.

A positive vote will help reduce class sizes, which have gotten larger, especially in the high schools, where they are packing 36 students or more in advanced classes. Some of this is due to offering seven periods, and not hiring enough teachers, so our load is greater. Unbelievably, I started off last year with 210 students and 204 this year at Mililani High School. This lessens the time I can give to every student; rather, I am struggling to get grading, lesson planning, and actually I looking carefully at student work. Many teachers are so frustrated with their current workload, expectations, and stress, including myself.

A vote for these measures is a vote for lower class sizes that allow teachers to connect with their students, see how we can assist them with their learning needs, and provide resources to be effective with learning activities. It's frustrating that when we need supplies there is so much red tape that teachers are forced to use personal funds to buy the things they need. That is very unfair.

Most importantly, funding our schools will provide professional pay, which recognizes the hard work our educators are providing. In all my years of teaching, I can't believe how undervalued our teachers are. I used to do a lot as a culinary teacher, but with instructional time added, decided it wasn't worth doing anymore, because it took hours to do shopping for 180+ students every week. I even decided to give up advising our nationally-affiliated HOSA organization, because after doing that for so many years and no additional recognition or compensation, decided it wasn't worth it anymore. It's unfortunate, because we were taking home numerous national medals and top ten winners, along with having so many state officers and Hawaii's first national officer for any Career Technical Student Organization, many of which I poured personal resources so I could chaperone

my students for a week during my summer break. The raises have never made up for the strike, furloughs, loss of medical contributions taken away, or no increase in salary years.

More funding would also help teachers with medical coverage, after all, this is a high-stress job, and we catch infections the students pass along. At the high school level, it is even more stressful, as there are the difficult ones who even their parents don't know how to control.

We need additional funding for our public schools, because we are losing too many talented, dedicated, and promising educators due to the fact that our state simply is too cheap to pay us REAL professional salary. I have stuck with teaching, even though I have seen everyone burning out and having to work multiple jobs to make ends meet. Why? Because I just don't know who will teach our students anymore. It has never made sense to me that teachers are forced to work multiple jobs when they could have concentrated on preparing or revising lessons or doing the multitude of things required of teachers. It has also become very frustrating to many teachers that they have left the profession for better paying jobs. For example, we have lost some very talented people such as our graphics arts teacher, who is now earning more as a stevedore. When he was teaching, his students were consistently winning national awards. Also, it is discouraging to see many teachers leave today past ten years...sometimes only within a couple of years. Many teachers I speak with say they are burnt out and want to retire, and they only have about 10 years on average.

It's time to take this seriously, because I already see the frightening trend that many teachers are retiring as soon as they can just so they don't have to take all the crap being shoved down their throats. Funding should go to classroom teachers, not the bureaucrats who tell us what to do. We are the ones who work in the trenches for our youth and funding is key to making education a top priority. To deliver the schools our keiki deserve, please support these bills.

The lower pay considering the cost of living and lack of resources are really hampering our younger and newer teachers from staying and developing their teaching craft. It takes years to develop one's craft and it takes resources which are extremely limited to non-existent to be able to effectively teach to students of all abilities. Further, it costs the Department of Education even more money in lost training when you lose a teacher. It's a vicious cycle that could be solved with funding that can improve resources, class-size, classroom environment (sorry - our kids can't learn when it's really hot). With less college financial assistance being provided these days, too many of our teachers are coming out with huge loans. They may start in education but they quickly realize that when they take a long hard look at their finances, they really have to decide if they can fiscally remain teachers or should they move on to a better paying profession or a less expensive cost-of-living area? As college graduates, it's a difficult situation to encourage teachers to stay and develop their craft and relationships with their school community.

If you read the book <u>Hawaii Pono</u>, you will see that we have made little progress since 1911. In 1911, the problems with our educational system included too few teachers, teacher salaries that were distressingly low, buildings that were overcrowded, and thus the per capita cost of education was meager. The plantation owners sent their kids to private school and didn't want their plantation workers' keiki to receive more than a fourth-grade education. The optimal time for this to have been addressed was when our Hawaii State Constitution was written. Yet, no one made sure there was language that would make funding a quality public education a priority.

Almost every politician campaigns on the issue of education. But as this top priority has continually fallen to the wayside, maybe the reason why is many who have the power to change it send their kids to private school. Almost 40 percent of kids on Oahu attend private school, the largest proportion in the United States. The last two school years have started with over 1,600 teacher vacancies, largely because Hawaii pays the lowest salary of districts that have the same cost of living.

We have the lowest percentage of taxation to public education in the country. I appreciate Chair Kidani's leadership in addressing our educational funding crisis. Finally, we can improve the funding problems that has plagued Hawaii since 1911, with passage of this bill.

The way the school system in Hawaii was established during the plantation era, public schools weren't a priority. Plantation workers' children were not to be well educated so that they would stay in and work at the plantation. Thus, funding public education was not a priority. The upper class citizens sent their children to private schools and therefore had no interest in funding public education or using tax money dedicated to public education. This racist political view segregates children based on their family income and doesn't offer the same education to all keiki. This is no longer acceptable.

The lack of funding is especially apparent in my community where schools are overcrowded and more schools aren't being built. At Maui High school we share science classrooms because we don't have enough classrooms for teachers. We can't hire more teachers which drives our class sizes up and makes for a less than optimal learning environment. Even though Maui High School is the high school for children from Kihei, we are not seeing any funding to help out with our overfilled schools.

Money is being held for Kihei High School when we ARE the Kihei high school NOW. And the high school in Kihei hasn't even started to be built. Large class sizes and lack of proper science classrooms is hurting our students and it's not letting us teach to the standards we are tasked with. Some science classrooms don't even have running water, or 30+ small slanted desks crammed into a small room that you for obvious reasons can't put any science equipment on because it will slide off the desk. We are not going to get any improvement on next generation science classrooms any time soon since all money is being set aside for Kihei High School. As a science teacher tasked with the Next Generation Science Standards (NGSS) I find myself struggling to deliver to my students the curriculum I am tasked with with the scarce resources I'm given. Learning biology is experiencing it, not reading from a textbook. To learn science we must do science. And that requires a certain set of equipment and consumables. My students learn best when doing experiments and they want more! In conclusion, there just isn't enough money in the state budget to sustain high quality schools and education. It is time we solve this funding issue!

In combination with low pay, lowest in the country when adjusted for cost of living, many teachers at my school have left in the last few years. Teaching is driving teachers into bankruptcy forcing them to leave. Like most teachers I hold a second job when I should be able to concentrate on my students. I babysit at resorts and hotels, sometimes until midnight on weeknights, followed by driving home and not going to sleep until 1am only to get up at 6am and get ready to teach. Investing in our public schools and our teachers is an investment in our future.

My name is Kim Virtudazo. I am a teacher at James Campbell High School in Ewa Beach on Oahu. I am submitting testimony in support of SB 2922 to increase funding for public schools.

Today I am testifying not only as a teacher but as a parent to my six year old son, Logan and three year old daughter, Lily. I am writing in support of SB 2922 to increase funding in public schools. Logan is a kindergartner at Ewa Elementary. His teacher Mrs. Kris Tanioka is an outstanding educator who does so much despite the school's limited resources. With 22 five and six year olds in her classroom, Mrs. Tanioka manages to give all of her students the emotional attention they need, while teaching every child the benchmarks and standards, and showing them all their potential. Everyone knows twenty two kindergartners is way too many. She does an incredible job and I'm fortunate to have her as Logan's teacher. But to retain exceptional teachers like her, the state needs to fund schools better. Schools simply need more funding.

At Campbell I teach freshman English and I see first-hand daily the conditions and the lack of resources of our schools. Our school allots teachers between \$100 - \$150 a school year for supplies. This money is spent on expo markers, staplers, pencil sharpeners, hole punchers, tape dispensers, chart paper, post-it, index cards, tissue boxes and paper towel rolls. I try to stretch the money as much as I can but I'm never able to purchase everything I need. So everything else I purchase throughout the year comes out of pocket. I do this for my students...I do this for your constituents and their families. I gladly invite you into my classroom to see my termite infested room. When you're here, I would like you to meet my students and see their daily struggles. I would like you to see me as I feed them whatever snacks I have since some of them don't have food at home.

As a sixth year teacher, our family has struggled with whether or not to move to the mainland. I have a Master's degree in Secondary Education but I can't afford to purchase a home. Like many teachers, I think about moving to the mainland. We see this in the shortage of

qualified teachers and the number of long-term substitutes we have. This past year I picked up a second job, teaching night school at Waipahu Community Schools for Adults. Teaching night school, I have students from 16 to 60+ years old. Some of the students who I work with at night, could've benefitted from a loving, qualified teacher who was able to give them the one-on-one attention they deserved. But the state failed them. Schools simply need more funding.

So today, I ask that you support SB 2922, to deliver the schools our keiki deserve. I ask you this a parent of Logan and Lily, a freshman English teacher at James Campbell High School, a night school teachers at Waipahu Community Schools for Adults, a State of Hawaii registered voter, and just a citizen of Hawaii.

Higher taxes and fees harm our ability to compete. Last August, the Legislature raised the TAT, to the point where guests now pay a TAT of 10.25 percent. Coupled with the general excise tax, guests pay a 14.41 percent tax on the Neighbor Islands and 14.96 percent on O'ahu. Hawai'i has reached the point where high business costs and tax rates make it increasingly difficult for business to be profitable and competitive, in both the domestic and international markets.

Tourism already is the state's largest revenue producer. Tourism continues to be the largest single source of private capital for our economy. Recent reports have noted that (a) tourism accounted for 204,000 jobs; (b) visitor spending last year totaled \$16.8 billion, a new high; and (c) the state's tax take was \$1.96 billion. Of that sum, TAT revenues alone generated nearly \$508 million for the state's coffers last fiscal year.

More than half of TAT revenue now goes to the general fund. While the TAT was established to promote and market the visitor industry, it has since become a major source of revenue for purposes other than originally intended. We would surmise that public education may already be receiving a share of TAT revenue through its general fund budget allocations.

The state government is not collecting TAT and general excise taxes on transient vacation rentals. I support legislation that would ensure a level playing field for all visitor accommodations, from the traditional hospitality businesses to the alternative accommodations offered online. There are tens of thousands of alternative accommodations in the Hawaiian Islands competing with hotels, resorts, timeshares, and bed-and-breakfasts, except that the majority of them are most likely avoiding TAT and general excise taxes.

For these reasons, I continue to oppose raising taxes and extra fees on the visitor industry and we respectfully urge you to oppose the establishment of a transient vacation surcharge proposed in Senate Bill 2922.

Dear Chair Kidani, Vice-Chair Kahele and Members of the Education Committee:

Thank you for the opportunity to testify on the proposed Constitutional Amendment. On behalf of the American Resort Development Association (ARDA) Hawaii, the time share association, we respectfully **oppose** this bill.

While the discussion and policy decisions about the proper level of funding for public education is an important one that has been ongoing for several years, the approach taken in this bill seeks to have just two sectors of the economy bear that burden, one of which being the visitor accommodations. We believe this is an unfair targeting of one type of property owners and property users being taxed. While this does not mean ARDA-Hawaii necessarily supports a broad-based tax increase, we believe that would be a much more reasonable policy discussion for the entire general public to engage in. Moreover, these proposals single-out these areas to have them pay these fees for services and programs which do not have a direct nexus to the surcharge that is sought to be imposed. Finally, the transient accommodations tax was just recently raised in this fall in the special session in order to fund the Honolulu Rail Project, as such, we do not believe that adding additional tax increases so soon and quickly is prudent as it places an undue burden on these sectors.

Our tourism industry remains the number #1 economic driver. Unfortunately, our other important economic driver, the military support and spending, is also tenuous and uncertain due to changes at the federal level in the past few years including sequestration, no longer allowing specific appropriation or "pork-barrel" projects, and loss of congressional seniority, along with an uncertain and yet to be determined approach by the new federal Administration. As such, additional targeted fees or taxes on our visitor accommodations has the potential to drag down our tourism market momentum and inhibit Hawaii's continued cost-competitiveness as a sought-after tropical destination.

It is for these reasons that ARDA-Hawaii must respectfully oppose this bill. Thank you for the opportunity to testify.

Chair Kidani and Members of the Committee:

RBOAA must **OPPOSE** the bill.

This Bill proposes Constitutional amendments to authorize a "Surcharge on residential investment property and visitor accommodation to fund quality public education for all of Hawaii's children."

RBOAA takes no position as to the need or merit of additional funding for education.

RBOAA has great concern with the proposed method of payment for additional education funding as follows:

### 1. Residential investment property that cannot claim a homeowner's exemption.

Among the counties there is not a uniform definition of when a property owner can claim a homeowner's exemption. Each county has defined the duration of use differently, therefore, without a one definition of when a homeowner's exemption can be applied, the result will inherently be discriminatory.

Further, the <u>Privileges and Immunities Clause</u> protects against State Legislation that bears unequally on nonresidents and exempts nonresidents from any higher taxation or excises than are imposed by a State on its own citizens. It is hard to find the rational basis for taxing only certain properties to fund education which is a benefit to all children who reside in the State. While there are some resident owners who indeed do have residential investment property, as seen in last year's proposal, they are likely to receive benefits and

offsets that nonresidents will not. It is also noted that the Legislature has requested studies of nonresident property ownership, so it is well known to the legislature that the nonresident will be significantly more impacted by this Bill.

#### 2. Additional surcharge on visitor accommodations.

As everyone is aware, the legislature in special session last summer increased the transient accommodation tax to pay for funding for the Honolulu transit system. It is only a month ago that transient accommodation operators had an increase of 1% (total 10.25%). The increases over the past several years are significant already. It is unknown if there will be a negative impact with this newly implemented increase. With every increase in TAT there is an increased risk that the tourists will cut back on other expenditures that are vital to the economy.

RBOAA must also question the nexus to investment property and tourist operations and education. Generally, where there is a special tax imposed on only certain sectors there is a nexus to it which justifies having to bear the expense. There is not such connection here. Indeed, tourists do not send children to school, and investment property generally is not connected with sending children to a local school.

#### **3.** The Constitution of the United States

The U.S. Supreme Court has held that the Constitution guarantees equal treatment by government and the legislative process shall not make laws that harm a "politically unpopular group(s)" and that government "cannot justify disparate treatment of that group." During the past seven years, every year, there have been Bills introduced for taxation, regulation, and encumbrances on transient vacation rentals. There is even a Bill this session and in the past two sessions prescribing that failure of a transient accommodation operator to register with the Tax Department would be a Class C Felony - the same as involuntary manslaughter. And yet, failure to obtain a GE license for all other forms of business is a fine of \$500. (HRS 237-9). Compare: a Class C Felony with mandatory fines and prison versus a fine of \$500 for the same offense (conducting business without registering). There has clearly been established a hostility towards non-resident owners.

It is up to this legislative body to determine how they will enact Bills that uphold the protections afforded under the Constitution of the United States that provides for equal protection even for those groups that are "politically unpopular." There is ample case law that establishes the courts have consistently upheld these protections for decades.

We urge the legislature to consider the <u>U.S. Constitution's Equal Protection Clause</u> that provides for protection from discriminatory actions, the <u>Privileges and Immunities Clause</u> that protects against State Legislation that bears unequally on nonresidents and exempts nonresidents from any higher taxation or excises than are imposed by a State on its own citizens. It is hard to find the rational basis for taxing only one or two uses of property to fund education which is a benefit to all children who reside in the State.

Further, the additional surcharge imposed upon transient accommodations is discriminatory against one form of commerce. Hawaii has many different forms of commerce and it is unclear why one form would be responsible for education and not another. The <u>Commerce Clause</u> of the <u>United States Constitution</u> also provides for equal treatment in the laws established by a State. In the *Bacchus case*, the United State Supreme court held "the Commerce Clause stands as a limitation on the means by which a State can constitutionally seek to achieve its goals." The court further held that it is irrelevant to the Commerce Clause, and still in violation of its provisions, when the motivation of the legislature was the desire to aid in state interest rather that to harm out of state interests.

We ask you to please consider that money needed to fund "education for all of Hawaii's children" should be funded by all revenue sources rather than selecting only residential investment property and visitor accommodations to fund additional revenue for education.

Aloha Chair Kidani and Members of the Committee,

My name is Dylan Ramos and I am testifying as a product and proud supporter of Hawai'i public schools, as well as a member of the Hawai'i Democratic Party's Education Caucus. It has been a long time since I've sent in a written testimony, but SB 2922 caught my attention. There may be some opposed to this bill for fiscal or political reasons, but I would say to them that Hawai'i's keiki (and the 'āina they live on) should always be our first priority.

Residential investment property and visitor accommodations are big business in Hawai'i — there is no reason they shouldn't help fund the state's future. Public schools must be available and supportive of the large number of "high needs" students, helping to shape a generation that can fix Hawai'i's growing social and economic problems.

That said, the cost-of-living in Hawai'i is immense, contributing to both the causes and consequences of our struggling public education system. We must do our best when considering a bill like this not to harm already-struggling residents. This includes locally owned businesses and residential investors renting to other locals to live, as opposed to short-term vacation rentals. There should also be assurances that money will make its way to teachers, students, and a proportionate amount of administrators, faculty and staff (avoiding excessive hires and expensive bureaucracy).

Anybody opposed to these measures on fiscal grounds should consider different ways to address budgetary issues. Our keiki are not bargaining chips or political pawns for use, but rather our future innovators who deserve the best education we can provide. Our state's unique administration of public schools requires creative and resourceful thinking, and as the introduction to SB 2922 points out, there are many ways students and teachers can benefit from more funding.

Please consider passing this bill or something similar with strong support for funding sustainable, long-term programs for quality education.

Testimony for: Senate Education Committee SB 2922 - RELATING TO EDUCATION Hearing on Monday, February 5, 2018 3:15pm

Chair Kidani and Members of the Committee:

I am Andy Jones, a teacher at Radford High School. I have been at Radford for eleven years; previously I taught English as a Foreign Language in Taiwan 1993-2006. I am writing to ask that you please pass SB 2922 to increase funding for public schools.

Valid arguments for increased school funding are legion. The following are among the most exigent:

1. *Teacher retention and recruitment.* When cost of living is taken into account, the average public school teacher in Hawaii earns more than \$10,000 less per year than the next lowest-paying American states for teachers. That is to say, it is not just that we are ranked last, but that there is in addition a significant gap between Hawaii teacher salaries and salaries the other low-paying states. For many teachers, this gap spells non-affordability. This is the primary reason why the average Hi teacher spends less than five years in the classroom, and why we have the nation's most serious teacher shortage overall. Students suffer individually and collectively when too many of their teachers are inexperienced or underqualified, or when the doors to their classroom are constantly revolving. I believe that improving teacher retention and recruitment is beyond question the single most effective way of improving public education in our state.

2. Unfavorable teacher to student ratios. Teachers throughout the state are overburdened with too many students. Last year at my high school, one of my first-year Language Arts colleagues had over 210 students distributed among his six classes. That's almost 40 students per class. Not only are 40 students far too many for effective teaching and learning; the sheer number of students that this teacher was responsible for seriously limited how much time the teacher could spend devoting important individualized attention to particular students. In short, not only do teachers need to be paid more in order for them to stay beyond five years; more teachers need to be hired in order to effect more favorable teacher to student ratios.

3. Teachers need more preparation time. This third point is inextricably woven with the second point. The annual information gathered by the Organization for Economic Cooperation and Development (OECD) provides substantial evidence that, of approximately three dozen nations that participate in the extensive reports on education, teachers in the United States are the second-most overworked teachers in the world after Chile, spending an approximate 1100 hours in front of students per year in comparison to the international average of around 600. Most American teachers experience significant challenges in implementing educational "best practices" because they are given so little non-teaching time to developing the highest quality curriculum, instruction and assessment. Public education in Hawai'i as in the rest of the United States is unlikely to improve significantly until efforts are made to decrease the number of students teachers are responsible for each year and to build more non-teaching time into the teacher work day. Once again, this will require hiring far more teachers than we currently have.

A few final words about myself. I am currently 52 years of age, and I have been teaching since my 20s. I began my career teaching English to Chinese speakers in Taiwan for a dozen years. Since returning to the United States, I have centered my career on Advanced Placement. I teach the two AP English courses (AP Language and AP Literature), as well as AP Psychology. I am also an official AP Reader for the College Board, spending a week each year on the mainland scoring AP Language essays coming in from around the world.

I believe that, by all accounts, I am an excellent teacher. In addition to my wealth of AP experience and my quartercentury's commitment to studying and implementing the best and most current pedagogical practices in my classroom, I bring to my teaching at Radford a degree of knowledge pertaining to my teaching area (and to various subsidiary areas helpful in high school Language Arts teaching, including the arts, philosophy, world history, and Asian and European languages) that is seldom matched among high school teachers in the United States. In short, I am the sort of teacher that fills classrooms in top-performing educational cultures from Singapore to Finland, and the sort of teacher that has always been a rarity and is now becoming even more scarce in the United States, as fewer of the academically brightest students pursue college paths in education, opting instead for occupations that are both more financially attractive and less subject to the ups and downs characteristic of an profession which is so constantly subject to the arbitrary decisions of non-professionals as public education. To be sure, despite the fact that I love what I do to earn a living and have no desire at this point in my life to do anything else, I have a very hard time recommending to the many academically gifted and advanced students I work with each year that they pursue a profession in which, three and a half decades later, they may still find themselves working six or seven days a week as I do, and – if they end up teaching in Hawaii – struggling with chronic credit card debt to meet mortgage payments and college bills for their own children, as I do, together with my wife, who also teaches.

To attract teachers like me in the coming generation, and to deliver the schools that our keiki deserve, I ask you to please support this bill.
