#### **TESTIMONY ON SENATE BILL NO. 2931, RELATING TO DENTISTRY.**

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, THE HONORABLE BRIAN T. TANIGUCHI, CHAIR, AND MEMBERS OF THE COMMITTEES:

My name is Paul Guevara, D.M.D., M.D.S., and I am the Chairperson of the Board of Dental Examiners ("Board"). Thank you for the opportunity to testify on S.B. 2931, Relating to Dentistry. The Board supports this bill and suggests an amendment.

This measure amends the ethics training requirement for dentists in the continuing education program to be six hours of ethics training within the previous two years.

The Board suggests an amendment on page 1, line 14 to clarify the continuing education requirement reporting period: "two years <u>for each biennial renewal period</u>." This amendment would clarify that the licensee must complete at least six hours of ethics training in the previous two-year biennial period to comply with the continuing education requirements for renewal.
