Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee on Ways and Means.

The Hawaii Technology Development Corporation (HTDC) **supports the intent of** SB3000, SD1 that establishes the research and development program in the Hawaii Technology Development Corporation to help Hawaii-based small businesses collaborate with commercial partners to further refine and optimize research and development performed in Hawaii.

As part of HTDC's vision to create 80,000 new innovation jobs in Hawaii earning \$80,000 or more by 2030, HTDC supports initiatives aimed at growing the technology and innovation sector. Companies conducting R&D provide interesting, high wage jobs for our Hawaii workforce. Promoting R&D activities will spur innovation and job growth.

HTDC comments that SD1 clarifies that small businesses that claim the federal research and development tax credits are eligibile to apply for grants and that HTDC shall analyze each application to determine whether the item to be undertaken will be economically viable and beneficial to the State. HTDC agrees that grants programs should have an application process that considers which projects are most advantageous to the State.

HTDC defers to the Department regarding the establishment of a Special Fund.

We support this initiative as long as it does not replace our priorities requested in the Executive Budget. HTDC comments that this measure should be coordinated with HB2599 to avoid duplication. Thank you for the opportunity to offer these comments.

Makai Ocean Engineering, Inc. **STRONGLY SUPPORTS SB3000 SD1** that establishes the research and development program in the Hawaii technology development corporation.

Makai is a locally-owned and operated technology company based in Hawai'i for over 44 years. We are currently performing R&D on a variety of exciting ocean technology projects, including autonomous underwater vehicles, ocean thermal energy conversion (OTEC) and seawater air conditioning (SWAC) systems, submarine and subsea cable systems, and a Department of Energy project to grow and harvest macroalgae (limu) offshore in Hawaiian waters to produce a renewable biofuel alternative for transportation. Makai is not alone among Hawaii technology companies in bringing millions of federal R&D dollars to the state. There is a tech community here that has made a strong economic impact in terms of high paying jobs, and demonstrated success in commercializing federal R&D, which has increased taxable revenue for the state, and brought home kama'aina scientists and engineers to stay.

This bill would support high-paying, highly-skilled professional jobs for our keiki here at home.

This is why we **STRONGLY SUPPORTS SB3000 SD1** and respectfully request the following additions to clarify the administration of the program by HTDC:

- Page 3, Line 20: add "small" to a Hawaii-based small business
- Page 4, Line 2: replace "receive and amount" with "receive a grant in an amount"
- Page 4, Line 3: replace "past" with "prior" and add this definition:
 - o A Hawaii-based small business is defined as
 - Have been doing business in the state for not less than 10 years
 - Have Hawaii-based employees, subject to the taxes imposed under HRS 235.

We urge you to pass this bill and suggest the following additions to further clarify and ease the administration of the program by HTDC:

- Page 3, Line 20 --- add "small" to a Hawaii-based small business
- -Page 4,Lline 1 --- add after corporation. "Proof shall be in the form of copies of the small business Federal Form 6765 credit for Increasing Research Activities as filed.
- -Page 4, Line 2 --- then receive "a grant in " an amount
- -Page 4, Line 3 --- replace past with "prior". and ADD this definition:

A Hawaii-based small business is defined as

- -80% or more Hawaii resident owned. For purposes of this paragraph, "resident" shall have the same meaning as defined in Section 235-1, HRS.
- -Have been doing business in the state for not less than 10 years
- -Have Hawaii-based employees, subject to the taxes imposed under HRS 235.
