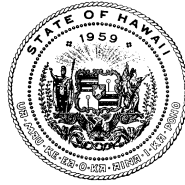

1 **Fiscal Implications:** None to the Department of Health. The Department defers to the
2 Department of Human Services on program and fiscal implications of S.B. 3010.

3 **Department Testimony:** The Department of Health appreciates the intent of this bill and offers
4 comments on S.B. 3010. Although we support the intent of this measure to improve dental access
5 to care and better oral health for children, the bill is not needed based on our conversations with
6 the Department of Human Services, MEDQUEST Division that address the issues in this
7 measure.

8 The virtual dental home is a new and innovative delivery-of-care system that has the
9 potential to significantly improve the oral health and access to dental care for the residents of
10 Hawaii. The Hawaii virtual dental home pilot project was developed and implemented to
11 improve access to dental care by using telehealth connected dental teams to provide dental
12 services in rural communities where people live, learn, and socialize.

13 The results of this pilot project indicate the virtual dental home system is adaptable in
14 Hawaii, and very effective in providing dental care and education to the underserved and
15 vulnerable populations in community settings, such as Head Start and Women, Infant and
16 Children (WIC) program sites. In addition to the focus on early preventive services, the virtual
17 dental home provides a positive dental experience for the children in a comfortable and familiar
18 community surroundings. This is also a cost-effective system in delivering dental care in

1 community settings. Since September 2016, a total of 487 teledentistry visits resulted in 364
2 children being treated in the community setting. Additionally, 66 children were referred to a
3 dentist for advanced treatment, with 42 of them being seen by the dentist, and 23 completing
4 treatment. The success of the Hawaii Island virtual dental home pilot project, in Kona, led to the
5 expansion of this pilot project to the island of Maui this year.

SB 3010 – RELATING TO DENTAL HEALTH

Chairs Baker and Green, Vice Chairs Tokuda and Chang, and members of the Senate Committee on Commerce, Consumer Protection, and Health and the Senate Committee on Human Services, thank you for this opportunity to provide testimony in support of SB 3010 relating to dental health.

This bill supports the sustainability of the Hawai'i virtual dental home pilot projects by ensuring providers who use certain telehealth procedures and apply caries arresting medications are reimbursed for doing so.

The University of Hawai'i at Mānoa School of Nursing and Dental Hygiene (SONDH) recognizes that increasing access to oral health services for underserved and Medicaid populations is a priority for action. Recognizing this need, the SONDH applied and received a competitive DHHS Health Resources and Services Administration (HRSA) grant, "Utilization of the Expanded Function Dental Hygienist (EFDH) to Improve Oral Health Outcomes for Children 0-5 Years of Age in Hawai'i", from 2017 to 2022. The project goal is to increase the dental workforce serving children 0-5 years of age in underserved areas by developing a post-baccalaureate EFDH certificate program for licensed dental hygienists, and to increase the bachelor's prepared student's knowledge and comfort in providing pediatric dental hygiene services to the community. However, this effort alone is not sufficient to meet state needs. Telehealth via the University of the Pacific's School of Dentistry project allows access to oral health and ensures that dental hygiene can practice in such settings.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of this measure and offers comments on this bill.

PURPOSE: The purpose of the bill is to support the sustainability of the Hawaii virtual dental home pilot projects by ensuring providers who use certain telehealth procedures and apply caries arresting medications are reimbursed for doing so, and clarifying that, for purposes of billing and payment, procedures performed using certain telehealth technologies are equivalent to those procedures performed in person.

The State's Medicaid program does provide coverage of telehealth for dental procedures that were issued and distributed to dental providers on or about May 2, 2017.

DHS has reservations regarding including specific procedure codes in statute. One primary reason is that the organization responsible for issuing procedure codes utilized by all medical and dental providers, adds and deletes procedure codes yearly. While some codes

remain the same other codes are deleted due to new treatments or procedures. Therefore to have specific procedure codes fixed in statute will make it more difficult to promptly modify codes if future changes require an act of the legislature.

DHS has been working and discussing tele-dentistry and the Federally Qualified Community Health (FQHC) prospective payment system (PPS) payments with the Centers for Medicare and Medicaid Services (CMS), and we have resolved this issue. We will be clarifying this shortly.

Finally, we have been in discussions with the Department of Health, the dental community, and CMS regarding both topics. Thus, we support the intent of this measure to improve dental care for children; however, DHS believes that the bill is not needed at this time as we are already working on the areas addressed by this bill.
