## TESTIMONY BEFORE THE SENATE COMMITTEE ON EDUCATION

Chair Kidani and Members of the Committee:

The Hawaii State Teachers Association supports SB 616, relating to education.

This bill will require that the DOE develop a plan that will ensure that each public school has a part-time or full-time library and appropriates the funds to do so.

Some of you may be shocked to learn that some of our public schools do not have libraries. It is a well-known fact that literacy is dramatically affected by the accessibility of books to read, especially for our youngest children, but even for our high school students, especially as they dive into research and problem solving required to be successful in our world today, libraries are needed.

Every time we find out that one of our public schools does not have a library, we are shocked too. One of our teachers on Molokai informed us that although they have one high school, one middle school, and four elementary schools on the island, they only have a library in one of their schools. They also have one very small public library that it is, shockingly, not open on weekends.

At the high school level, teachers are dismayed that when their students enter high school that many of their students have never stepped into a library. Many rural areas do not have access to libraries or even bookstores. We also cannot assume that every book is downloadable, nor can we assume that families have the funds needed to either purchase books whether digital or online or access to internet, for their children, especially in low-socioeconomic areas. Not having libraries in their

schools is a disservice to everyone and not having access to them is not providing the quality learning environment that our students need and deserve to thrive.

We will also add, that in the future, we hope not too far in the future, we also need to emphasize that certified librarians are also needed in these libraries. Librarians do so much more than just letting students check out books. In this digital age they also assist with helping students navigate online resources, they guide and support teachers with resources and lessons for their students, and they help connect with the community in supporting growth in literacy in our keiki. They are vital to a successful library as well.

Therefore, the Hawaii State Teachers Association asks your committee to <u>support</u> this bill to ensure that all of our keiki have access to a library in their public schools.
