Chairperson Lee and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 637 SD2, which allows for additional enforcement and regulatory action to address invasive pest species issues. The Department supports the intent of this bill.

The Department works closely with each island invasive species committee (ISC), often to address early post-entry invasive pest establishment. In working with the island invasive species committees, it is critically important to address a new invasive pest species as soon as it is detected. If the intent of this bill is to empower county ISCs, then the measure improves the odds of successful eradication of an invasive pest by leveraging enforcement resources. Recent serious invasive pest species outbreaks such as the little fire ant and coqui frog are excellent examples how the Department and the island invasive species committees can move quickly to eliminate newly established invasive pests as long as access to private property is secured.

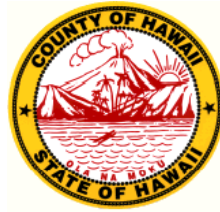

Senate Bill 637, Senate Draft 2 proposes to authorize counties to enter private property for invasive species control. **The Department of Land and Natural Resources (Department) supports this measure.**

The Department manages and is the administrative host of the Hawaii Invasive Species Council (HISC). The HISC is in the process of developing administrative rules to formally designate invasive species for eradication or control, pursuant to Section 194-5, Hawaii Revised Statutes (HRS). The ability of county governments to enter property to control invasive species pursuant to Section 194-5, HRS, or agricultural pests pursuant to Section 141-3.6, HRS, would assist in timely, thorough implementation of invasive species control efforts. If county agencies are not allowed to enter private property for invasive species control, that property may become a safe-haven for an invasive species if the owner does not take the initiative to control that species on their own. This may result in a harmful species becoming established when it could have been eradicated.

Thank you for the opportunity to comment on this measure.

Dear Chair Lee and members:

Thank you for this opportunity to testify in support of SB637, SD2.

The Council of Mayors has identified invasive species as a top-priority issue that deserves our attention. Even our best efforts are often inadequate to protect our islands from harmful pests, and limited resources make it imperative that we work together in pursuing solutions to what often seem intractable problems.

SB 637, SD2 would put the counties in a better position to fight against invasives. As the Mayor of Maui said in a prior hearing, it would give us a much-needed tool to supplement the ongoing efforts of State agencies and private organizations.

Staff has raised one question—if there is an emergency that warrants access in less than five days, is there a mechanism to address that? If not, could that issue also be addressed in SB 637?

Other than possibly also dealing with such an emergency (if the Committee thinks that is necessary), we ask that SB 637, SD2 be approved with an appropriate effective date.

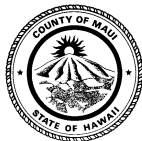

Thank you for the opportunity to testify in **support** of this measure. The purpose of this measure is to authorize counties to enter private property to control or eradicate invasive species and pests.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I **support** this measure for the following reasons:

1. The eradication of invasive species must be considered with a sense of urgency. Damage in property, our natural environment and other irreversible effects of mitigation delays would increase our costs. Reasonable proper notice must be provided to individuals in case access to their private property is required. However, a process too cumbersome may impede agencies from doing their job in a timely manner, and utilizing the court system to secure warrants to gain property access are costly and burdensome options.
2. Environmental protection through the eradication of invasive species is a statewide and intergovernmental effort. The County of Maui understands this partnership and works closely with agencies such as the Maui Invasive Species Committee (MISC) in the fight against invasive threats to our endangered species, native plants, fragile ecosystems and overall quality of life.
3. Currently, MISC's ability to implement its programs are hampered by their inability to access private property where invasive species are reported. This measure would solve this ongoing issue by allowing counties and its authorized agents, following necessary notice requirements, to enter private property for eradication efforts.

Mahalo for your consideration. For the foregoing reasons, I **support** this measure.

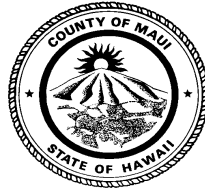

Thank you for this opportunity to testify in **SUPPORT** of SB637 SD2.

This bill will provide the counties a clear tool that is not currently available to us – the authority to enter private property, with the proper court authorization, in order to eradicate invasive species that could be harmful to public health and safety.

Maui County is currently fighting to stave off an infestation of many invasive species. Some of which include: Little Fire Ants (LFA), Coqui Frogs and Coffee Bean Borer beetle (CBB).

LFA has proven to be a threat to public health and safety. The Maui Invasive Species Committee (MISC) and the Hawaii Ant Lab (HAL) has had several property owners or lessees block access to their properties when they tried to address LFA eradication. The state department of Agriculture was able to obtain a court order, eventually, that allowed MISC and HAL to do their assigned duties. However, this is only one instance of many that are currently being faced by these agencies. There are people in Haiku and Nahiku still blocking access to their property to fight LFA and coqui frogs. We are currently getting CBB infestations in the Hana area and already getting resistance from one property owner. The DOA does not have the manpower or resources to get court orders to help these agencies work on the eradication of these pests on a timely basis.

I firmly believe that the counties can be effective where the DOA is not able to be due to their restrictions.

Therefore, I strongly urge the passage of this bill.

Chair Lee, Vice Chair Lowen, and Members of the Committee,

Aloha. The Conservation Council for Hawai'i supports SB 637 SD 2, which authorizes the counties through their employees or authorized agents to enter private property to control or eradicate invasive species and pests.

Destructive invasive species and dangerous pest harm humans, wildlife, the environment, and economy. In some situations, access to private property is needed to control or eradicate such species. The case of the little fire ant on private property on Maui is one such example.

Please also support increased funding to keep invasive species out of Hawai'i and controlling invasive species that are established on the islands. Experts recommend a minimum investment of \$50 million a year to, essentially, implement the Hawai'i Interagency Biosecurity Plan. The Nature Conservancy supports S.B. 637 SD2 authorizing the counties to enter private property to control or eradicate invasive species.

Invasive weeds, insects, diseases, snakes, and other pests are one of the greatest threats to Hawaii's economy, agriculture, natural environment, and the health and lifestyle of its people. With favorable conditions and limited competition, non-native species arrive in the Hawaiian Islands to find an easy environment in which to thrive.

The [Hawai'i Interagency Biosecurity Plan](#)—prepared by the Department of Agriculture with the support of its many government and non-government partners—addresses the full range of invasive species prevention, early detection, rapid response, control, research, and outreach priorities across the state. The Biosecurity Plan notes the ability to enforce biosecurity rules on private land as a critical issue. In many instances, private properties are adjacent to public lands and other private properties, including important natural and agricultural areas, where the efforts of public and private land managers to control invasive species may be frustrated or even negated if a neighboring private land owner cannot or will not take similar measures.



The ability of counties to enter onto private property under the same conditions required of state agencies would assist in the timely and effective containment and control of newly introduced and more established invasive species.

Aloha Chair Lee, Vice Chair Lowen, and Members of the Committee.

I am Myoung Oh, Director of Government Affairs, testifying on behalf of the Hawai'i Association of REALTORS® ("HAR"), the voice of real estate in Hawai'i, and its 9,200 members. HAR **supports** S.B. 637, S.D.2 which authorizes the counties through their employees or authorized agents to enter private property to control or eradicate invasive species and pests.

REALTORS® are vitally concerned about issues that affect the value of real property and the quality of life in our State. The introduction and infestation of detrimental invasive species is a growing concern that is increasingly impacting the very way of life for our friends and families in our communities. HAR would support efforts to empower the Counties to join the effort to eliminate this threat.



According to the recently released Hawaii Interagency Biosecurity Plan (2017-2027), Hawaii's ever increasing interconnectedness with the rest of the world has led to an onslaught of exotic species from around the world arriving in our harbors and airports and ultimately becoming established here.


The plan suggests that 10 percent of those invading species will prove to be harmful to our economy, our environment, and our very way of life. Seriously dangerous species like the Little Fire Ant (LFA) have established themselves in various locations in the State, and particularly on Hawaii Island. From there the State has continued to allow the shipment of material infested with LFA to other islands, spreading this potential environment disaster farther.

The Maui Invasive Species Committee (MISC) is estimating that Maui will experience the same level of LFA and coqui frog infestation that is now prevalent in

the Hilo and Puna Districts of the Big Island in the next 10 years if governmental agencies do not take a more proactive stance. The Biosecurity plan essentially says the same thing. A key part of the eradication effort is the need to address infestations wherever they occur. One major problem is that certain recalcitrant property owners refuse to manage the invasive species on their property and refuse access to State agents to do the work for them. The species then spread to surrounding properties making eradication impossible.

Currently, to enter such properties requires the active involvement of the State Attorney General's office, which does not have a full-time presence on the Neighbor Islands. If the Counties participate in this effort, then the Counties' attorneys can obtain the necessary warrants to enter private property.

HAR feels the current plan for managing detrimental invasive species is not working. Laws that must be amended to correct this situation and give our local communities a better chance at addressing this problem, including Chapter 46, which gives the Counties their powers, and Chapter 194 which makes the State Department of Agriculture the agency responsible for this function.

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

Hawaii Farm Bureau **strongly supports SB637 SD2**, allowing County ordinances relating to invasive species.

HFBF strongly supports a robust biosecurity program to manage invasive species in our environment. We strongly believe that an effective program is accomplished through cooperative efforts, Federal, State, County and private entities, each contributing their resources based on expertise and capacity.

Invasive species management is largely under the jurisdiction of the Hawaii Department of Agriculture. Federal expertise is used to identify new control measures while Invasive Species Councils at different counties and private entities participate with HDOA PQ in eradication and control measures. State entomologists and PQ officials work to enforce and implement quarantine requirements as well as identification and rapid response for control of new infestations. Most recently we saw this in action at Hana, Maui, where HDOA PQ personnel worked to eradicate an initial CBB population and are working to assess further infestations.

As written, the measure would authorize:

"Ordinances necessary to prevent, investigate, control, or eradicate invasive species on any public or private premises within the limits of the county."

Identification and development of control measures require technical expertise that come with significant cost. Collaborative efforts with existing state expertise would be a better use of resources. Counties can help by coordinating volunteer workforce crews in their various districts that could be trained to be emergency ready for action

when a new invasive species outbreak is identified. The local crew could include personnel from companies in the region who are already trained with pest management as well as others interested in assisting with invasive species control. People will be familiar with their own districts so can contribute insight on possible host locations, increasing the effectiveness of HDOA and ISCs.

Recently there was an individual who opposed entry by HDOA officials to control the LFA. However, HDOA stated during a Board meeting that they had the authority to obtain warrants as well as request the issuance of quarantine orders to the property. Procedures to facilitate the timely implementation of the warrant and quarantine orders may be justified.

Counties are already struggling to meet the increasing needs within their jurisdiction such as homelessness, traffic and infrastructure development. Their annual plea for greater share of TAT funds demonstrates the challenges associated with funding measures already within their jurisdiction.

HFBF respectfully requests your support of this measure. Thank you for this opportunity to provide comment on this important subject.

The Board of Directors of Hawaiian Paradise Park Owners Association is in support of SB 637 to authorize each county through its authorized agents to enter private property to control or eradicate pests and invasive species.

Hawaiian Paradise Park is a large subdivision in the County of Hawaii comprised of over 8,800 lots covering almost 12 square miles of area in the lower Puna district (Senate District 2).

Invasive species such as Albizia have cost our Association thousands of dollars to remove, as well as man power and damages to our private roadways. Close to a third of our lots remain unimproved with absentee lot owners unable to eradicate these invasive flora species themselves. This bill would provide support in keeping these lots free of impactful and unwanted species which are damaging our roadways.

We support the intent of this bill and only wish it would go into effect sooner than its proposed date of January 7, 2059.
