TESTIMONY TO THE SENATE COMMITTEES ON HUMAN SERVICES, ECONOMIC DEVELOPMENT AND TECHNOLOGY, AND GOVERNMENT OPERATIONS

Senate Concurrent Resolution 1/Senate Resolution 1 – Urging the State of Hawaii to Review and Update its Telecommunication Devices and Access for the Deaf, Individuals with Hearing Disabilities and Individuals with speech Disabilities

The Disability and Communication Access Board (DCAB) supports Senate Concurrent Resolution 1/ Senate Resolution 1 which requests the Office of Enterprise Technology Services, in consultation with the Public Utilities Commission and DCAB, to review existing and emerging telecommunications equipment, services, and policies to ensure continued accessibility and usability for individuals who are Deaf, hard of hearing or have a speech disability, and identifying any areas where technology can be improve communication and report back to the legislature with findings and recommendations, including any proposed legislation prior to the convening of the 2019 Hawaii State Legislature.

DCAB suggests amending the title of the resolutions to "Urging the State of Hawaii to Review and Update its Telecommunication Devices and Access for Individuals who are Deaf, Hard of Hearing or Have Speech Disabilities" to reflect "person-first" language when identifying people with specific types of disabilities, as well as including individuals who are Deaf, hard of hearing and have speech disabilities in reviewing and identifying areas where technology may be used to improve accessibility and usability in telecommunications. Having users of the technology participate in the discussion of emerging issues and technology will enhance the level of discussion and report to the Legislature.

People who are deaf, hard of hearing who use American Sign Language (ASL) as their primary means of communication prefer using communication devices which allow for real-time communication via the use of video technology currently available through videophones or cell phones that may be improved upon with development or new technologies that have not even be created yet to make communication easier for them as individuals who rely on ASL and visual cues to communicate effectively with each other and the public to obtain services and interact with the community at large.
