To the Honorable Donovan M. Dela Cruz, Chair; the Honorable Gilbert S.C. Keith-Agaran, Vice-Chair and the Members of the Committee on Ways and Means:

Good morning, my name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") on Legislative Priorities of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on SCR20 requesting the Department of Business, Economic Development, and Tourism to identify possible state-owned land to build a race track facility on the island of Oahu.

The OCC on Legislative Priorities is in favor of **SCR20** and supports its passage.

SCR20 requests Department of Business, Economic Development, and Tourism is requested to identify possible state-owned land to build a race track facility on the island of Oahu and to collaborate with racing enthusiasts and organizations to discuss racing needs and to enter into a public- private partnership by issuing a request for proposal to design, finance, and operate a race track facility on the identified state-owned land.

Specifically, the Platform of the DPH provides that "[w]e believe that government plays a vital role in nurturing and regulating our economic system. We believe that private and public employers, as responsible members of community, by providing good jobs and fair pay and benefits, are essential for economic expansion, diversification, innovation, and entrepreneurship. (Platform of the DPH, P. 2, Lines 56-59 (2016)).

Given that **SCR20** requests Department of Business, Economic Development, and Tourism is requested to identify possible state-owned land to build a race track facility on the island of Oahu and to collaborate with racing enthusiasts and organizations to discuss racing needs and to enter into a public- private partnership by

Support of SCR 120

I am writing to support the approval of SCR 120, which ultimately and hopefully will result in a racetrack on Oahu. I was actively involved with Hawaii Raceway Park before it closed. I am a car guy. Currently, I write car reviews for the Honolulu Star Advertiser and Hi Lux magazine, and I have a TV show on OC-16 called Island Driver TV. I am also on the board of the Hawaii Region of the Sports Car Club of America.

When Hawaii Raceway Park was open, it had drag racing, road racing, a dirt circle track, motorcycle racing on paved and dirt surfaces, autocross, drifting, and go cart racing, which resulted in every weekend being fully booked with racing plus many times lots of spectators. During the weekdays, tourists would attend a racing school to learn how to drive Formula Ford racecars, and then drive those care on the road course.

Needless to say, the automotive community on Oahu has been very disappointed that no new track has been developed on Oahu since 2006. As you may be aware, there are tracks on Kauai, Maui, and the Big Island, which I understand are on county land but operated by private entities. Consider this comparison... if there was only one golf course on Oahu, and it closed what would be the reaction.

Another concern is street racing and drifting occurring on public roads. With a track on Oahu, I believe

that illegal activity would be lessened because a lawful alternative would be available.

For all these reasons, I urge the Legislature to approve this resolution.
