FRIENDS OF OHIKILOLO - MISSION STATEMENT

To protect and preserve in perpetuity, the open space and wilderness of Kanehunamoku (Kea'au to Ka'ena) on the westernmost coast of O'ahu, Hawai'i.

GOALS:

Formalize and codify the prohibition of development from Kepuhi Point to Ka'ena Point.

Stop any planned development of luxury estates or similar development in Ohikilolo.

Obtain public or community ownership of privately-owned land in Kanehunamoku that is at risk of future for-profit development.

Support community-based low level sustainable agricultural /cultural / or educational uses of the land, which does not destruct its open spaces and wilderness.

Secure regular access to maintain and monitor the cultural landscape of Ohikilolo.

Current Challenge:

Purchase the 60 acres that is for sale.

Obtain formal agreement from owner of willingness to sell property.

Conduct fundraisers to begin raising funds to obtain an Appraisal of the 60 acres.

Research other means to raise funds for the Appraisal.

Seek increased community support for keeping Ohikilolo as open space/wilderness/ cultural landscape.

By – Laws Current Organization of Friends of Ohikilolo

Note: On September 21, 2017, the Core Group voted on a new name:
Na Ki'a'i no Kanehunamoku.

As the Articles of Incorporation as well as the Application for a federal 501C3 designation were made with the original name of Friends of Ohikilolo, these By-Laws are given the same title and the name Na Ki'a'I no Kanehunamoku will be aka.

Friends of Ohikilolo shall have a Board of 7 members which will also be called the Core Group. The Core Group will meet at least quarterly or more often as needed. Quorum at present, is 4 members. If the Board enlarges, the quorum will be a majority of the then Board membership.

The Board will also convene meetings open to the community in order to inform, educate and stimulate action in support of and towards accomplishing the mission of Friends of Ohikilolo.

President:

The President calls the meetings and presides over its proceedings. The President will also lead actions that the Board has decided to undertake unless a coordinator has been selected for the specific activity. The President is also responsible to maintain the organization's focus and actions towards accomplishing the mission of Friends of Ohikilolo. The President may call in cultural practitioners and other consultants to assist the organization to fully realize and meet its mission.

Vice President:

The Vice President will assist the President in all of his/her actions as stated above. The Vice President will step in to lead the group when the President is away or unable to attend meetings.

The Vice President will also perform other duties as requested by the President to achieve the mission of Friends of Ohikilolo.

Secretary:

The Secretary shall keep records of the meetings of the Core Group of Friends of Ohikilolo. These may be "minutes" or digital records of the actions that occurred in the meetings. The Secretary will also keep records of the dates and significant decisions /actions that occurred in Community Meetings. Included in these records will be a sign- in sheet of the attendees, and any speakers or presenters.

The Secretary will also act as historian re all significant communications between the organization and outside sources, as well as records of activities the organization engaged in. The Secretary may assist in communications with outside resources.

The Secretary may be the keeper of the important documents of the Organization or may share this responsibility with the Vice President.

Selection of Officers:

As this is a new and developing organization the Officers and Board members are volunteers and there is no term limits at this time. However, in the future, the organization may decide to review its organizational structure and make other decisions re election of officers, or staggering of elections to maintain continuity.

Fundraisers:

Any fundraiser sponsored by the Friends of Ohikilolo will be toward its mission. No funds or donations will be for the personal use of any Board member. However, compensation may be made to a person or person(s) who performs services for the organization in its fundraisers or other activities to build funds to meet its mission.

The mission of the Friends of Ohikilolo will promoted in advertisements for fundraisers or solicitations of the organization.

Dissolution:

Should the Friends of Ohikilolo dissolve, any funds it may have will be donated to another nonprofit.
