#### **Brief Description** of Request

Hawaii 3Rs (Repair, Remodel, Restore Our School) is a 501(c)(3) nonprofit organization that conducts repair and maintenance projects at public schools. The schools submit grant requests that are vetted by the Department of Education Facilities division personnel, as well as a Hawaii 3Rs Technical Review Committee, composed of active and retired construction industry individuals. Hawaii 3Rs hires the professional contractors to do the job and organizes volunteers to ensure community involvement.

Currently, the projects are funded by a combination of corporate donations and the revenue from a tax return checkoff for school repair. Because these sources do not generate large dollar amounts, the projects have necessarily been limited to 4-5 schools per year at about \$15-20,000 each. In the past when Federal funding was available, Hawaii 3Rs had a staff who were able to coordinate many more projects. Over the past 17 years, there were more than 500 projects completed at a cost savings of about \$40 million to the State.

Today, most of the smaller projects from the DoE backlog list have been completed, and the schools are now requesting slightly larger projects that are beyond the scope of the current 3Rs budget. An increase of \$5,000,000 will enable us to respond to requests such as purchase and installation of large industrial ceiling fans for cafeterias, improved playground equipment, painting of all buildings on the campus, roof repair, wiring for computer labs and specialized sink and lab space for science rooms.

With the 3Rs' years of experience in planning, contracting and executing work with the schools, we are confident our operation can be quickly and competently scaled up to accommodate more projects in size and quantity, as we have done in the past. We note that our original charter requires all of the projects we undertake to be taken from the backlog list.

A grant of \$5 million, which we hope to match with similar amounts from our private sector supporters, would allow us to tackle a significant number of items from the backlog list.

#### II. BACKGROUND AND SUMMARY

#### 1. A brief description

In 2001, two disparate events occurred -- one local and the other national -- which prompted Hawaii's senior senator, U.S. Senator Dan Inouye, to ask the question, "How can we help?" The two events, a a State report revealing a multi-million dollar repair and maintenance backlog at the Hawaii State Department of Education and the national launch of the America's Promise Alliance in all 50 states, led to the creation of Hawaii 3R's: Repair, Remodel, Restore Our Schools. Senator Inouye was both the champion and founder of this tax-exempt organization.

Since its formation in 2001, the program has touched nearly every DOE school in the state at least once and on every island. Work completed has spanned the gamut of the backlog list; from major overhaul of termite-ridden classrooms into science labs to replacement of dangerous electrical outlets near classroom sinks. Other projects have included campus beautification – planting grass sods, installing irrigation systems, re-striping parking lots and painting non-skid walkways between classes.

The underlying concept behind Hawaii 3Rs was the belief that schools would benefit and the backlog would be reduced if we could marry community volunteerism ("sweat equity") with professional expertise paid for with grant dollars from Hawaii 3Rs. It is a successful model that has resulted in more than \$40 million in cost savings to the state and the DOE while addressing critical needs at our public schools

From its inception, Hawaii 3Rs has an active partner with the Legislature in reducing the DOE backlog through its various projects. Legislative committees have provided a tax credit to vendors and donors for their services and provided a tax checkoff for school repair, which goes to Hawaii 3Rs to further its programs.

We note that in the past year, due in part to Hawaii 3Rs' proven track record of accomplishment, the DOE contracted 3Rs to manage the Mark Takai Transition Center program. The contract is for a four-year period to service DOE schools that have a high proportion of military dependents and other out-of-state transfer students and ethnic immigration students. These schools may receive grants to create "student transition centers," dedicated space devoted to helping new students become acclimated and acculturated into a new school environment, thereby avoiding potential disciplinary or withdrawal problems.

#### 2. Goals and Objectives Related to the Request

Although the lack of Federal funding in more recent years has caused the program to scale back on the number of projects undertaken annually, Hawaii 3R's has, over the years, perfected the

review and approval process to address repair and maintenance projects at DOE schools. We would like to use our experience to scale up the program again, especially in light of recent news reports that the DOE's backlog is now estimated to be in excess of \$800 million.

#### 3. Public Purpose and Need to be Served

The services and funding provided by Hawaii 3Rs benefit only the buildings, grounds, and facilities that are used by the public schools in Hawaii. The recent announcement that repair and maintenance needs exceed \$800 million clearly demonstrates that help is needed and long overdue.

#### 4. Target Population to be Served

Any and all of the approximately 180,000 students enrolled in the Hawaii public schools would be served by improved facilities.

#### 5. <u>Describe Geographic Coverage</u>

Hawaii 3R's is a 501(c)3 tax-exempt organization serving all major islands in the state of Hawaii where DOE schools exist.

#### III. SERVICE SUMMARY AND OUTCOMES

#### 1. Scope of Work

While the scope of work will vary by school and project, the general practice is to work closely with the school Principal or Vice Principal on the job requested, completing a detailed application and budget. We will ensure the project is on the backlog list, noting the cost estimate State provides and usually attempting to target 3Rs costs at about 50% of that, using volunteer "sweat equity" in the form of labor or reduced fees.

The project is reviewed by DOE to ensure it meets State standards and then is further reviewed by the 3Rs Technical Review Committee, composed of current and former construction industry individuals, for industry best practices.

Community volunteers and corporate donations are recruited and a budget is developed before a project date is determined. Because there are currently no paid staff for Hawaii 3Rs, the coordination is primarily accomplished through a volunteer 3Rs board and the staff of the DOE Auxilliary Services branch. Should the grant-in-aid request be approved, it is anticipated that paid staff would be hired.

#### 2. Projected annual timeline ...

It is expected that the work would be at least initiated and the funds encumbered within a year. Most schools attempt to schedule the projects during the summer or other extended holidays to avoid student traffic and disruption. Every effort would be made to finish the projects expeditiously, but much will depend on which ones are undertaken. In some cases the items required may have to be ordered from the Mainland or the particular contractor may not be readily available.

#### 3. Describe quality assurance and evaluation plans for the request.

The review and approval process of grant applications submitted to Hawaii 3R's has been refined over the past 17 years and now works exceptionally well. The process begins when a school submits an application to Hawaii 3R's for a specific R&M project on their campus. All requests for assistance must be on the state's backlog list. In other words, any R&M project that is not on the backlog list will be rejected. The application is vetted closely by personnel from the Facilities and Auxiliary Branch of the DOE to ensure that it is in compliance with the department's standards and policies. If the application is acceptable, the application is then reviewed and scored by the Hawaii 3R's Technical Committee which is comprised of working and retired experts: engineers and contractors. If the application does not pass the Facilities Branch, DOE personnel work closely with the school to address those areas on the application that were deficient. Once fully approved, the application is submitted to the full 3Rs board for approval.

To date, all of Hawaii 3R's projects over the past 17 years have been approved and accepted by the state DOE.

#### 4. List the measure of effectiveness that will be reported.

Typically, the metrics provided will include a spreadsheet covering: scope of project, estimated state cost to complete the project, grant funds provided by Hawaii 3Rs, value of sweat equity or in-kind contributions and cost savings of project to the State/DOE (based on the backlog estimate). In addition, we may also include a satisfaction evaluation and on-site inspection from the Principal and a DOE representative. Removal from the backlog list will be the ultimate mark of success.

#### V. EXPERIENCE AND CAPABILITY

- 1. Hawaii 3Rs has been successfully organizing, funding and completing R&M projects across the state of Hawaii and specifically for the state DOE for 17 years. More than 500 projects have been conducted over that period. A list of the projects over the last three years is attached.
- 2. Hawaii 3Rs has no facilities and does not plan to acquire any.

#### VI. PERSONNEL: PROJECT ORGANIZATION AND STAFFING

Proposed Staffing, Staff Qualifications, Supervision and Training
 Upon approval of the grant request, Hawaii 3Rs plans to recruit and hire a project
 manager. Preferably, this would be an independent contractor, since the period is
 for just one year, and we do not anticipate maintaining a long-term employee. The
 ideal candidate would have a working knowledge of general project management,
 including skills in organizing and collaborating, developing and implementing a

budget, good writing and speaking skills, basic computer knowledge and be able to juggle several major projects at once. While a knowledge of construction principles would be helpful, it is anticipated that such expertise can be contracted if needed, as we have done in the past. It is expected that the current team (Board President, Secretary/Treasurer, Executive Director, DOE staff) would continue to provide support and assistance. As necessary an assistant Project Manager may be hired.

#### 2. Organization

The Project Manager for this grant would have responsibility for implementing the various projects in consultation with the 3Rs Board and DOE Facilities division. The Project Manager reports to the Board, communicating directly with the Secretary/Treasurer.

Note that there is currently on staff a Project Manager for the Transition Centers who is likewise an independent contractor and reports to the Board with direct communication with the Secretary-Treasurer.

#### 3. Compensation

Annual salary range for the Project Manager is estimated to be \$80-90,000. The Assistant Project Manager, if needed, is estimated to be \$50-60,000. The Transition Center Project Manager will not be assigned to this grant and will not be paid from these funds. Additional compensation may be required for benefits if we are unable to recruit an independent contractor.
