

(2) The public purpose for the grant;

The Governor of the State of Hawaii has made one of his priorities to double food production by 2020. With Hawaii importing 85% of all the food it needs for consumption, food sustainability is of paramount importance. The most compelling use of ag land is for food crops. However, the transition from sugar and pineapple to food crops and diversified agriculture has been a challenge. This grant addresses the State's goals to improve food sustainability and food security in our islands.

As part of this grant, HAF will initiate: 1) partnerships with other ag-related organizations to develop a model that will help new farmers become self-sufficient and build capacity; 2) a pipeline of educational programs from K-12 that encourages careers in agriculture among our students; 3) lifelong learning among new consumers to become better informed food and agriculture in Hawaii; and 4) a conference for our State's leaders to host other leaders from rural communities to learn from each other about the challenges and opportunities in agriculture.

The target populations to be served are new farmers, K-12 school age students, ag leaders, and the community at large.

## II. Background and Summary

The Hawaii Agricultural Foundation (HAF) is a non-profit charitable organization created to promote agriculture and farming. Created in 2007 (initially as *The Hawaii Farm Bureau Foundation for Agriculture*, and renamed *The Hawaii Agricultural Foundation* in 2010), the mission of HAF is to support and sustain Hawaii's agricultural industry by addressing critical needs and services of farmers and the agricultural industry in Hawaii, and by better connecting the farmers with the community and vice-versa. This

involves educational and outreach programs in the community, as well as direct

marketing, technical, educational and in-the-field support for farmers.

2. The goals and objectives related to the request;

The goal of the HAF's Ag 2020 program supports Governor Ige's goal to make Hawaii more food self-sufficient and to double local food production by 2020. Furthermore, it supports the State Department of Agriculture's published mission to promote the conservation, development and utilization of agricultural resources in the State.

Furthermore, the grant supports the *Increased Food Security and Food Self-Sufficiency Strategy Plan* that was prepared by DBEDT Planning and DOA that identified a need to build the agricultural workforce and continue the "Green Jobs Initiative" which provides workforce development services for the agricultural, energy, natural resources and related industries in order to increase food production.

The Ag 2020 will (1) support new farmers with education and resources needed to help them build capacity and scale; (2) create ag education in our schools to promote careers in agriculture; (3) build capacity and leadership in agriculture and natural resources among Hawaii's state leaders; (4) develop partnerships between industry and academia to ensure a workforce that is prepared with relevant education and experience; (5) create forums for dialogue and meaningful discussion to address the ever changing landscape of agriculture in Hawaii.

### 3. The public purpose and need to be served;

With large developers and the State now committing land to agricultural production, there is no shortage of ag land available. The current issues are the lack of infrastructure, capital, and a workforce that can move the ag industry forward. With the average age of a farmer in Hawaii 60 years of age, it is critical we encourage our youth to look at careers in agriculture. The future of ag will be in the hands of new farmers who are versed in technology and new farming methods that make the business of agriculture viable.

With Hawaii importing 85% of all the food it needs for consumption, the most compelling use of ag land is for food crops. However, the transition to food crops and diversified agriculture has been a challenge. In the last several years, two premiere and well-known farms, Hamakua Springs and Nalo Farms, have closed.

As part of this grant, HAF will initiate: 1) partnerships with other ag-related organizations to develop a model that will help new farmers become self-sufficient and build capacity; 2) a pipeline of educational programs from K-12 that encourages careers in agriculture among our students; 3) lifelong learning among new consumers to become better informed about food and agriculture in Hawaii; and 4) a conference for our State's leaders to host other leaders from rural communities to learn from each other about the challenges and opportunities in agriculture.

## 4. Describe the target population to be served; and

The target populations to be served are new farmers, K-12 school age students, ag leaders, and the community at large.

## 5. Describe the geographic coverage.

## III. Service Summary and Outcomes

The grant will provide the needed funds for HAF to expand its programs that connect farmers to the community, and promote long-term food sustainability in our islands. Ag 2020 includes the following programs:

#### **Farmer Scalability**

HAF currently licenses lands on its 220-acre Ag Park in Kunia to 20 small and immigrant farmers (who were alleged victims of human trafficking). The original intent of the HAF Ag Park at Kunia was to provide small farmers with access to land and then to help them scale their farms. When the ag park opened in 2011, there were very few small farmers and HAF partnered with Pacific Gateway Center to help about 17 farmers who were alleged victims of human trafficking. Over the last 2 years, HAF has worked directly with these farmers and it is apparent that it will be near to impossible to help these farmers scale. They lack many basic skills such as the English language, math, writing, general business knowledge, as well as desire, to scale their operations. HAF will continue to work with these immigrant farmers to help them improve their farm skills to help them meet the needs for basic food safety food practices. However, in 2019, HAF will work with GoFarm Hawaii to identify one or two farmers that have graduated from the GoFarm program that show promise scaling their operation from a small one- to two- acre plot to 10 acres. The long-term goal is to work with them to develop a template for scaling these farmers as they move to a larger farm.

#### **Student Education**

During the past three years, HAF has developed and implemented an array of initiatives that were built one upon the other to create a continuum of educational K-12 programs in Hawaii's traditional and charter public schools. HAF proposes to use grant funds to continue, expand, and/or implement the following programs:

Where Would We Be Without Seeds: First implemented on Maui, Where Would We Be Without Seeds is a 3-unit, second grade STEM and Common Core standards-based curriculum that integrates multiple content areas to provide a hands-on seed-to-planting

agricultural experience. HAF, in partnership with the Maui County Farm Bureau, is working in 2018 to expand the program statewide. The program familiarizes students to where food comes from and indirectly introduces the concept of farming as a career option. All lessons are aligned to Common Core, Hawaii Content and Performance Standards III, Next Generation Science Standards, and General Learner Outcomes. Participating teachers are required to attend professional development workshops hosted by HAF. For the 2020 school year, 780 students will be served. Funding from this grant will cover 390 students.

<u>Veggie U</u>: First offered in 2014 to Grade 4 public schools, Veggie U uses curriculum aligned to Next Generation Science Standards; Hawaii Content and Performance Standards III in science, health and social studies; Common Core English language arts and mathematics standards; and General Learner Outcomes. Students gain knowledge of local agriculture, healthy food choices within the construct of hands-on lesson plans that work toward inspiring careers in agriculture. HAF executes Veggie U by training teachers to use the curriculum in the classroom. In the 2019-20 school year, 1,300 students statewide will be served with 650 served through this grant.

AquaPono Aquaponics: A secondary grade program, AquaPono Aquaponics employs a science-based curriculum to engage students in aquaponics. All curriculum is aligned with Common Core State Standards and Hawaii Content and Performance Standards, and is implemented through a partnership with AquaPono. AquaPono provides teacher training to both elementary and middle schools. In the 2019-20 school year, 500 students will be served with 250 students covered by this grant.

Kids Cooking Local (After School Middle School): Kids Cooking Local is a partnership project between After-School All-Stars (ASAS), Boys and Girls Club and Hawaii Agricultural Foundation. Kids Cooking Local was launched as a pilot at Waianae and Jarrett Intermediate Schools with cooking, gardening, and nutrition as topics and activities. The primary goal of Kids Cooking Local is to provide students (and their families) living in disadvantaged communities with healthy, nutritious food while also teaching them how to cook and how to make healthy food choices.

Because of its popularity, HAF will expand this program from four sites to five schools over the next year. The target is to serve 150 students (75 to be covered by this grant).

**Future Farmers of America:** Future Farmers of America (FFA) activities at the state and national levels build capacity and leadership in natural resource teachers and students. Working with the DOE, HAF will continue to support FFA activities and training as a professional development tool. For the 2019-2020 convention, HAF will provide funding for 14 teachers and 125 students to travel for pre-conference activities and to the FFA State convention.

**Plant to Product:** Plant to Product is implemented with Hawaii Agriculture Research Center (HARC) and is an extension of Veggie U. It takes fourth graders using the Veggie U curriculum from the classroom into the actual field at HARC in Kunia. Students take sprouted seedlings and plant them into the ground where they are

Rev 12/18/18 responsible to water, weed, determine if pesticides should be used, and harvest. In 2019-20, a total of 250 students will be served (10 classes). Of that total, 5 classes and 125 students will be served through this grant.

In The Fields: A partnership program with Hawaii's agriculture-related businesses, In The Fields provides school students with opportunities to experience the world of work. Started as a high school program, In the Fields has now expanded to elementary and middle schools. High schools are required to expose students to all different kinds of agriculture through guided field trips to conventional, organic, and bio-tech agricultural environments. Elementary students in the Veggie U and Where Would be Without Seeds have an opportunity to choose one farm as part of their learning experience. In 2019-20, 1,750 students will be served (700 elementary and middle schools and 1,050 high schools). Of that total, 875 students will be served by this grant (350 elementary and middle schools and 525 high schools). In addition, HAF will also place six high school students in ag-related business internships (3 will be covered by this grant).

Ag & Culinary Entrepreneurship Program: HAF will work with high school agricultural and culinary programs to incorporate real-life business experiences into their programs. Culinary and ag programs will take what they've learned in the classroom, create value-added product(s), create a business and take it to market. Teacher training, development of a structured curriculum, and start-up funding for each class business would be funded by this program. In the 2019-20 year, 22 classes will be served.

In 2020, HAF will work with the State Agriculture and Rural Leaders (SARL) to host the Ag Leaders Summit in 2021. The Ag Leaders Summit is organized to bring together 250 of our nations state and provincial legislators to discuss policy issues affecting agriculture in rural communities. State Agriculture and Rural Leaders is a nonprofit dedicated to promoting and fostering cooperation, leadership and educational opportunities among and for state and provincial legislators that are passionate about agriculture and rural communities.

The Ag Chairs Summit will be hosted on the Big Island – the breadbasket of Hawaii. In addition to workshops and policy presentations, the Ag Chairs Summit will provide attendees to visit Hawaii agricultural resources such as the CTAHR facility, OTEC Aquaculture facility, Ag Tourism activities, etc.

  - a. Monitor and Evaluation We will track the number of workshops and overall participation and also secure feedback from participants.
  - b. Improve Results We will ask participants and industry leaders to evaluate workshops to improve the program.

#### Denise Yamaguchi, Executive Director

Prior to working for the HAF, Yamaguchi was a consultant to the Hawaii Farm Bureau Federation where she helped craft the language, vision and mission of the Foundation. She has more than nineteen years working as a consultant and executive with non-profit organizations specializing in strategic planning, fund development, marketing, government affairs, public relations and community relations. Her past employers and clients include NCL America, Bishop Museum, Japanese Cultural Center, Hawaii Foodbank, U.S. Senator Daniel K. Inouye, 3Rs, Artisans' Farmers Alliance, Durrant Media Five, Hawaii Institute for Public Affairs, Hawaii Farm Bureau Federation, Coast Guard Foundation, Hawaii Forest Industry Association, U.S.S. Battleship Missouri Association, and the State of Hawaii Procurement Office.

#### Teri Matsukawa, Finance Advisor

Teri Matsukawa serves as the financial advisor for HAF and oversees all financial reporting and budgeting for the organization. She has more than 30 years in accounting and financial management with her last position as the CFO for Louis Vuitton. She is a graduate of the University of Hawaii and us a Certified Public Accountant

#### Lucy Ahn, Director of Development

Lucy Ahn currently oversees the day-to-day operations of the Hawaii Agricultural Foundation and manages the HAF's Localicious Hawaii campaign. She has worked in non-profit and government sectors, and was previously in charge of corporate support and grant management for PBS Hawaii, Hawaiian Educational Council, the *Grow Hawaii* program of the Hawaii Association of Independent Schools (HAIS), and Ronald McDonald House Charities. Along with Nainoa Thompson of the Polynesian Voyaging Society and HAIS president Robert Witt, Ahn also played a leadership role in the start-up of a new charter school serving the children and families of Waimanalo.

#### Iris Mizuguchi, Director of Educational Programs

Iris Mizuguchi currently oversees HAF's educational programs. She has more than 38 years working in the classroom and as an administrator for the Hawaii State Department of Education. Prior to her retirement in 2015, she held the position Education Specialist, Career and Technical Education where she oversaw all CTE activities inclusive of four student organizations (Family, Career and Community Leaders of America, National Future Farmers of America, Future Health Professionals and SkillsUSA). She was also responsible for managing CTE state budget and eight district resource teachers.

#### Kacey Robello, Kunia Ag Park / Local Inside Manager

Kacey Robello currently serves as HAF's Kunia Ag Park/Local Inside Manager. Previously employed by the Hawaii Farm Bureau for 8 years as Farmers Market General Manager, she was responsible for coordinating and managing seven Farmers' Markets on a weekly basis working with 150 vendors. Robello brings her coordinating and management skills as well as her background of working with over 50 producers that produce locally -grown, -caught, and -raised products. She also brings her relationships with restaurants and chefs as vendors, customers, and participants with farmers' market demos.

#### Elizabeth Stanton, Educational Manager

Elizabeth Stanton currently manages HAF's education programs, with a primary focus on after-school initiative Kids Cooking Local and In the Fields. She has a Masters degree from the University of Hawaii in Education Foundations and graduated from the George Washington University with a Bachelor of Arts degree in International Relations. Prior to her tenure with HAF, she spent four years working as the Educational Program Director for the Japan America Society. She is experienced in coordinating programs and volunteers, and has experience working directly with school administrators, teachers and students.


#### Allison Tong, Communications Manager
