#### Origins: The Native Hawaiian Community

The Hawaii Institute of Integrative Health (dba Hawaii Health Foundation) was founded in 1996 in response the the high rate of chronic disease and death of Native Hawaiians and the people of Hawaii from preventable diseases. Physician-Attorney-Traditional Hawaiian Healer, Dr. Terry Shintani had a mutual vision with former state Senator Kenny Brown (who at the time was the Chair of Queen's Hospital) of better health for Hawaii's people. The vision was to fix a broken health system by creating a Program based on traditional Hawaiian values and Integrative Medicine, incorporating traditional Hawaiian healing and healing modalities from the many cultures of Hawaii.

In 1996, The Hawaii Health Foundation (dba Hawaii Institute of Integrative Health) was founded by the late Kenneth Brown, Board Chair of the Queen's Medical Center, the largest hospital in Hawaii; the late Dr. Agnes "Auntie Aggie" Cope, (former Chair of Papa Ola Lokahi), Kamaki

Kanahele, founder of the Statewide Council of Hawaiian Homestead Associations (SCHHA); Hooipo DeCambra, Board Chair of the Waianae Coast Comprehensive Health Center, the largest community health center in Hawaii; Ronald Sakamoto, Esq., a prominent local attorney, and Terry Shintani, MD, JD, MPH, award-winning physician widely recognized in Hawaii for promoting health and integrative medicine among high-risk communities.

#### Mission: To Promote Better Health and Not Just "Medicine"

The Foundation was started in response to the most serious health problems faced by Hawaii and the U.S., and that is nutrition-related diseases (heart disease, cancer, diabetes, etc.) and obesity which kills over 67% of all Americans. The founders recognized that Nutrition, the cause of this problem, was being neglected by the health-care system in favor of the use of drugs and surgery. In 1989, Dr. Shintani started a nutrition and traditional values-based health program in Hawaii in a community with one of the highest risk populations with among the highest rates of obesity and poverty in the nation.

## National Award-Winning Program

Dr. Shintani's Whole-Person Program was so effective that in 1992 it won the highest national award from the U.S. Secretary of Health and Human Services. Since this program created great interest across the nation, the founders started the Hawaii Health Foundation as a vehicle to promote health using this innovative community-based strategy with a focus on nutrition, an integrative medicine approach and traditional values. The Hawaii Health Foundation uses this approach to positively influence the health of the people in Hawaii.

The Foundation has conducted numerous programs in Hawaii and elsewhere with over 1,000 community health presentations to all groups such as University of Hawaii School of Medicine, public and private schools at every level, physicians, nurses, dietitians, low-income housing community, homesteads, senior groups, lawyers, substance abuse treatment houses, prisons, government agencies and workplaces, to name a few. It has also conducted three-week diet programs and 10-Day Programs in conjunction with community health centers, community groups and schools. One of the most successful programs was the Hawaii Diet Program for the Governor's staff and another for the Papakolea Hawaiian Homestead community where both were featured on Dateline NBC in 1998.

#### 1) The goals and objectives related to the request:

- A. To help improve the health of Hawaii's people, especially where there are doctor shortages, by implementing a demonstration project reducing obesity and related diseases through an emphasis on traditional Hawaiian values, diet and lifestyle; and by creating an electronic means by which to market and distribute this information to rural areas and the neighbor islands.
- B. To help reverse spiraling health care costs (for state, and county workers; for Medicaid; and for veterans) by creating a model program to show a

reduction in the need for medication (including opioids) by improving health through diet and lifestyle.

- To operationalize the cost effectiveness of a diet and lifestyle management program by reducing the need for medication in patients who have chronic pain and reversible chronic nutritionrelated diseases.
- ii. To obtain Medicaid and Medicare approval for reimbursement for the Hawaii Diet and Lifestyle management program in the reduction of obesity, cholesterol, blood pressure, blood sugar and other nutrition-related diseases.
- C. To enhance Hawaii's position as a world center for health through the support of HHF's initiatives in the fields of Lifestyle Medicine, Integrative Medicine, and Native Hawaiian Health, and the development of an integrative medicine/wellness/Hawaiian health complex.
  - To continue to develop a model Lifestyle Medicine Program that provides intervention to reverse obesity and obesity-related diseases.
  - ii. To support efforts to preserve Native Hawaiian Healing Arts including curriculum development and the preservation/publication and/or recording of Traditional Hawaiian Healing knowledge.

#### 2) The public purpose and need to be served:

- a) IMPROVE THE HEALTH OF HAWAII. Dr. Shintani's Program has been proven to improve the health of its participants. Obesity related disease and nutrition related diseases are the leading causes of death in the U.S. In Hawaii, this problem is magnified in the Native Hawaiian population.
- b) IMPROVE OUTREACH TO NEIGHBOR ISLANDS AND AREAS OF PHYSICIAN SHORTAGE: A critically important need to fill is in areas of physician shortage. This program would serve the people of Hawaii and be a model program that could be implemented around the islands and eventually throughout the world. This grant would help disseminate and document its benefits to places where there is a physician shortage.
- c) REDUCE HEALTH CARE COSTS (AND OPIOD USE): Healthcare costs are soaring in Hawaii and there is no end in sight. The burden of health care costs are falling on the general public, hospitals, and physicians.
  - i) Health costs are bankrupting self-insured funds
  - ii) Physicians are simply leaving Hawaii because of low reimbursement and high costs

- d) POSITION HAWAII AS A WORLD-CENTER FOR HEALTH: Of strategic importance to Hawaii is establishing its position as a world-center for health. Health is not only an important factor in reducing morbidity and mortality. It is a factor in tourism, and it is also an industry in its own right which makes the most of Hawaii's unique location and cultural healing practices. Our medical school should also have a thriving department of Complementary and Integrative Medicine.
- e) PRESERVING TRADITIONAL HAWAIIAN HEALING ARTS is essential in perpetuating the uniqueness of Hawaii's tradition of cultural healing. If we don't preserve our healing arts soon, they will be lost forever and we will lose our unique identity, not to mention the richness and healing potential of our culture.

#### 3) Describe the target population to be served; and

- a. The primary target population will be high risk adults in Hawaii with an emphasis on obesity and chronic disease, and opiod use including neighbor islands and rural areas.
- b. The secondary target is the 63,000 Native Hawaiians on Hawaiian homesteads especially those who have difficulty accessing medical care.
- c. The tertiary target population will be Native Hawaiians who are interested in traditional Hawaiian healing, and integrative medicine practices, and all patients covered by insurance who may benefit by a reduction in premiums.

- a. The primary geographic target population to be served will be Honolulu, the Neighbor Islands and rural Oahu but all of Hawaii is included.
- b. A secondary geographic target population is the whole state, especially the Native Hawaiian homesteads, where a health program may be conducted through electronic means.
- c. A tertiary geographic target is anywhere in Hawaii that there is internet coverage.

- 3. Dr. Shintani is Assistant Professor of Complementary and Integrative Medicine at the John A Burns School of Medicine.
- 4. The Chair of our board is Kamaki Kanahele who is the Chair of the Kupuna Council (Council of Elders) of Traditional Hawaiian Healers and Dr. Shintani is a member of the Council.
- 5. Dr. Diane Nomura is a licensed podiatric physician who is the administrator of the Foundation.
- 6. Dr. Noelani Apau-Ludlum (MD, PhD) is an Assistant Professor of Complementary and Integrative Medicine at the John A Burns School of Medicine
- 7. We currently have a site for an integrative Medicine center affiliated with the Medical School.
- 8. Three of our Board members are members of the Kupuna Council of Traditional Hawaiian Healers, and the president of the Hawaii Health Foundation has been formally designated as "Living Treasures of Hawaii". The president won the "Integrative Medicine Award" from the Hawaii Wellness Institute and is now Chair of the International Holistic Therapy Association demonstrating his capabilities in the leadership of this effort.



The HIIH has been in operation for 23 years and is able to sustain itself through revenue from its Programs, grants, contracts, book sales and donations from supporters. The Foundation has used State grants in only two of those 23 years. If there is no further funding, we will continue with our baseline programs or, if we are able to obtain Medicaid/Medicare coverage, we will be able to sustain a much more robust program serving many more people.
