Vision statement: A community in which we live by the values of the Nisei veterans.

Mission statement: To preserve, perpetuate and share the legacy of Americans of Japanese Ancestry (AJA) who served in the U.S. armed forces in World War II: the 100th Infantry Battalion, 442nd Regimental Combat Team, Military Intelligence Service and 1399th Engineer Construction Battalion.

The Nisei Veterans Legacy Center (NVLC), incorporated in 2012, is a non-profit organization as defined under Section 501c3 of the U.S. Internal Revenue Code.

It is working in partnership with veterans and descendants of the 100th Infantry Battalion, 442nd Regimental Combat Team, Military Intelligence Service and the 1399 Engineer Construction Battalion.

The NVLC also has the support of the following veteran organizations: 100th Infantry Battalion Legacy Organization and the 442nd Regimental Combat Team Foundation.

2. The goals and objectives related to the request;

We are committed to ensuring that future generations learn Hawaii's story of the Nisei soldier legacy as we honor the four World War II units and the men who served in them from throughout our island state.

We are committed to sharing their remarkable life stories, from plantation villages to military service, their driving force behind Statehood and how they re-shaped the social, political and economic fabric of our islands into the vibrant state it is today.

3. The public purpose and need to be served;

It is the belief of the Nisei Veterans Legacy Center that the stories of the incredible sacrifices made by the AJA during the course of World War II as well as their significant contributions to our post war society need to be preserved and

promoted. It is also our hope that a greater sense of civic responsibility will transpire by promoting community awareness of the values of good citizenship, such as loyalty, gratitude and humility, exemplified by the Nisei veterans.

4. Describe the target population to be served; and

The Nisei Veterans Legacy Center, through our traveling exhibits and permanent airport exhibits had been primarily targeting Hawaii residents. We have expanded our outreach through a significant investment in a permanent airport exhibit located inside the Interisland Terminal of the Honolulu International Airport. Airport officials estimate that as many as 3 million travelers per year, walk through the area where our exhibit is located and this is one of the main reasons the State of Hawaii, Department of Transportation, Airports Division, partnered with the Nisei Veterans Legacy Center on this effort.

Military Intelligence Service (MIS) Travelling Exhibit - This project will produce a 12-panel exhibit on the Nisei soldiers of the MIS during and after World War II. Over 6,000 Americans of Japanese Ancestry (AJA) served in the MIS as interpreters and translators for the U.S. Military in the Pacific and Indo-Asian Theaters. During the War, they intercepted Japanese messages and gathered intelligence through interviews of Prisoners of War and translated captured Japanese military documents. After the War, they served in the U.S. Occupation Forces in Japan helping to create the new Japanese government and translating at war crime trials.

Maui Airport Exhibit - This project will create a permanent exhibit at the Maui Airport. A tentative location has been provided by the Department of Transportation Airports Division for this exhibit but a final decision on the location is still to be determined. This exhibit will be similar to the kiosk exhibit at the Daniel K. Inouye International Airport (near the Japan Air Lines gates).

Travelling Exhibit Expenses - The Nisei Veterans Legacy completed successful exhibitions in Japan and Hawaii during 2017 and 2018. The Hawaii Nikkei Legacy Exhibit has now toured over 10 cities in Japan and all four major islands in Hawaii as part of the Gannenmono celebration of the 150th anniversary commemoration of initial Japanese immigration to Hawaii. Several requests for further exhibitions are being received now that the exhibit has received extensive publicity including a NHK World news piece. These funds will be used to defray travel expenses as well and update and refresh portions of the exhibit.

We are also continuing to improve and develop our interactive website to allow even greater access to the tremendous stories of sacrifice of our Nisei Veterans. 5. Describe the geographic coverage.

While the majority of our past efforts have targeted geographic locations primarily within the State of Hawaii, with traveling exhibits on Oahu, Maui, Hawaii and Kauai, we have been increasingly looking at expanding our geographic outreach. As discussed above in the previous section, the Nisei · Veterans Legacy promoted the Hawaii Nikkei Legacy Exhibit in over 10 cities throughout Japan.

The Go For Broke Exhibit is currently undergoing some repair and updating to add recently acquired items and repair damaged frames.

- b. In the spring of 2015, the Nisei Veterans Legacy Center procured the "Unlikely Liberators" exhibit from Mr. Eric Saul. This very moving and emotional exhibit documents the encounters between Nazi concentration camp prisoners and the Nisei soldiers of the 522nd Field Artillery Battalion. The NVLC has been able to show this exhibit at the following venues:
 - i. Temple Emanu-El, Oahu, Hawaii August 20 September 6, 2015
 - ii. Kahala Mall, Oahu, Hawaii October 5 24, 2015
 - iii. Maui Nisei Veterans Memorial Center, Wailuku, Maui -November 10, 2015 - January 30, 2016
- c. Additionally, the Nisei Veterans Legacy Center has installed permanent exhibits at:
 - i. Central Pacific Bank, Downtown Branch, Honolulu, Hawaii;
 - ii. Honolulu International Airport Concourse to the International Gates;
 - iii. Honolulu International Airport Interisland Terminal The "Hawaii Nisei Veterans" Exhibit is located at the Honolulu International Airport, Interisland Terminal.

The design and construction of the exhibit was primarily funded by a grant from the Hawaii State Legislature in 2015. A blessing ceremony to open the exhibit was held on October 21, 2016. The permanent wall display has three sections and pays tribute to the Nisei (second generation Japanese Americans) who fought in World War II. The center section showcases a multitude of information. At the top is a world map which illustrates the Nisei's deployment during WWII. A video monitor adjacent to the map runs a special video, which portrays the story of the Nisei through the eyes of a few veterans and family members.

Information on the four Nisei units, the 100th Infantry Battalion, 442nd Regimental Combat Team, Military Intelligence Service and 1399th Engineer Combat Battalion, is also located in the center section.

Life-like figurines dressed in authentic uniforms, along with military medals and other memorabilia enhance the visual perception of the exhibit.

Large photo murals make up the left and right sections of the exhibit. On the left are black and white images of the Issei or first generation of Japanese American and the Nisei during the war. The photo mural on the right depicts the Nisei's contributions to Hawaii after the war. It also shows the continuation of their legacy by the Sansei, the next generation.

Connecting all sections is a timeline embedded in the glass display case. Running from left to right, the timeline identifies key dates in the history of Hawaii relevant to the Nisei veterans, beginning with the first immigration of the Issei from Japan in 1806 to the election of Sansei, Governor Ige in 2014. Photos are attached as Exhibit "A"





- e. Joint Memorial Service (JMS) The Nisei Veterans Legacy Center is the primary sponsor for the annual Joint Memorial Service, which serves to honor those deceased Americans of Japanese Ancestry who served in World War II. The NVLC has been successful in increasing the attendance at this annual ceremony as this past year's attendance increased by 15%. Those attending represented various military organizations, veterans groups and members of the general public. Following the Joint Memorial Service wreaths are then presented to the Brothers in Valor Monument at Fort DeRussy.
- f. The Nisei Veterans Legacy Center's comprehensive website is being continually upgraded as content is prepared. It is our belief that the continued development and upgrading of the website has the potential to have a significant impact on sharing the story of these tremendous Nisei citizens. The primary purpose of the website is to promote a wide ranging awareness of the Nisei legacy. Stories such as the Nisei's influence and the accomplishments and

the profound effect that they had on the United States after the war. In California, more than 500 laws related to civil rights discrimination against Japanese Americans were appealed. In 1954, US citizenship was granted for the Issei (first generation, Japanese immigrants). Executive Order 9066, which singled out Japanese American as "enemy aliens" rescinded by President Gerald Ford in 1976. The military success and war record resulted in the passage of the Civil Liberties Act of 1988, which resulted in reparations payments and a national apology, which was unprecedented in American history.

In Hawaii, the Nisei played an important part in the creation of the Democratic Party and eventual Statehood in 1959. Prominent Nisei leaders like Senator Matsunaga and Senator Inouye helped to shape the social, political and economic fabric of our islands.

It is important that future generations learn about the Nisei story and it is imperative that the Nisei Veterans Legacy Center create and maintain a formidable interactive website so that the story of our veterans can reach a significant audience.



Among the recent developments in the NVLC's website are the following projects:

-In 2018 a graphic video project, "The 522 Story", was initialed. This tells the story of the 522nd Field Artillery Battalion of the 442nd Regimental Combat Team, with the target audience middle school children. The graphically animated video uses this story to communicate the values that were core to the Nisei soldiers motivation and success in WWII combat. The video is 40 minutes in length, organized in six chapters. It will be available on the NVLHawaii.org website for teachers, parents and children nationwide for viewing on-line.

To date the screenplay has been written and the audio sound track completed. The Introduction and chapters one and two have been completed.

- Go For Broke Exhibit - Originally curated in 1981 by Eric Saul, Director of the U.S. Army museum at the Presidio in San Francisco, CA, this was the first major exhibit of the Nisei WWII soldier story. Consisting of about 300 large photo images, it was exhibited at the Smithsonian National Museum of American History in 1982. It has since been exhibited at other venues, and was donated by Eric Saul to the NVLC and exhibited in several venues in Hawaii.


As a transportable museum quality exhibit, it requires a large space to host it, a team of volunteers and significant time to install and de-install. Due to the size and weight of the exhibit crates, there are significant transportation requirements and costs. These considerations have limited the ability to conduct more showings of this historical exhibit of the Nisei WWII experience.

- Digital Unlikely Liberators Exhibit - Originally curated Eric Saul, Director of the U.S. Army museum at the Presidio in San Francisco, CA, this exhibit tells the story of the 522nd Field Artillery Battalion of the 442nd Regimental Combat Team. Consisting of about 96 large photo images, it was donated by Eric Saul to the NVLC in 2015, and has been exhibited in several venues in Hawaii.

As a transportable museum quality exhibit, it requires a large space to host it, a team of volunteers and significant time to install and de-install. Due to the size and weight of the exhibit crates, there are significant transportation requirements and costs. These considerations have limited the ability to conduct more showings of this historical exhibit of the Nisei WWII experience.

- NVLC Original Historical Timeline - Background - Prior NVL projects have produced the AJA Historical Timeline and Stories currently on the

NVLCHawaii.org website. This comprises 146 historical events and 29 multimedia stories. Objective- The objective of this project is to make the timeline and stories available on the NVLCHawaii.org website in the Japanese language.



2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

The NVL was incorporated in 2012 but has never developed a comprehensive blueprint to market itself to the larger community. It has relied on its products to drive its marketing strategy rather than the reverse.

A marketing plan will help the NVL identify its core product and status in the community, target affinity groups, specify promotional goals and measurements, describe strategies for achieving those goals, and maximize results by integrating efforts with other NVL elements including the Education, Membership, and Website Committees.

The multi-year marketing blueprint will be created based on an analysis of the "market" environment, historical data, and the NVL Strategic Plan. It will identify budget and resource needs, as well as, an implementation plan and schedule.

Awarded GIA funds will be used to develop and progressively execute the marketing plan.

The NVL Publicity Committee Chair is Ms. Carole Hayashino, outgoing Executive Director of the Japanese Cultural Center of Hawaii. NVL has appointed Committee Members.

Scholarship Award - The Nisei Veteran Legacy Center, in conjunction with the Sons and Daughters of the 442nd RCT would like to adopt the following scholarship program to promote the following goals:

- -To cherish, defend, and promote the bonds of citizenship, service, and common humanity forged by the actions and sacrifices of the soldiers of the 442nd Regimental Combat Team during World War II in order to build a better community
- -To educate the public concerning all aspects of the 442nd Regimental Combat Team and its soldiers
- -To promote a better community through patriotism and good citizenship as inspired by the actions

Candidates: Students in grades 10, 11, and 12 in public and private high schools of Hawaii. Must be a US citizen.

Award: Monetary grant that can be used to cover tuition, books, and fees at the college they attend following graduation. S&D will hold the prize money in escrow until the student has been enrolled in an accredited US college/university. (Internet-based schools do not qualify.)

1st \$1000

2nd \$750

3rd \$ 750

Total funding needed annually: \$2500

What the student has to do:

- 1. Write a paper, or write a screen play of 10 to 15 minutes, or design a series of at least ten short (1 to 2 min) video based pitches/ads, etc, that communicate, educate, and promote the values that were fundamental to the success of the 442nd soldiers during WWII, and their role in the development of Hawaii in the years following the War to Hawaii statehood.
- 2. Make submission to the 442S&D not later than 8 May 2019 (VE Day).

Criteria for selecting the winning submissions is TBD.

The 442S&D would recruit a panel of experts mostly outside of the S&D to evaluate and judge the submissions.

Announcement of Winners would be targeted for Hawaii Statehood Day (16 Aug 2019).
