II. Background and Summary

1. Description of Kauai Adult Day Health Center

The mission of Kauai Adult Day Health Center (KADH), a 501(c)(3) corporation, is Caring for Ohana, which includes all of KADH clients, their families, KADH staff, and community.

Kauai Adult Day Health Center, once known as, Wilcox Adult Day Health was founded in 1974 and located on hospital grounds. In 2000, Wilcox Adult Day Health relocated to Lihue Christian Church at 2943 Kress Street, 96766, and in 2009, it was acquired by the Ohana Pacific Foundation and renamed Kauai Adult Day Health Center (KADH). KADH remains the only Adult Day Health Center on the island of Kaua'i since 1974.

The KADH program is for kūpuna and/or disabled adults in the community and offers a well-rounded and stimulating program of recreational, social, creative, educational, and therapeutic activities. KADH is a safe and protective environment where memory and/or physically impaired kūpuna receive preventive, remedial, and restorative services. Additionally, caregivers receive respite while their family member is cared for in a supervised environment during the day.

KADH clients participate in educational, physical, social, and wellness activities, which enables them to maintain healthy, independent lifestyles and avoid costly premature institutionalization. The KADH program is designed with specialized and meaningful activities that focus individualized attention on clients with deteriorating mental and physical abilities. The program objective is, to keep kūpuna as independent as possible, by empowering them to maintain independance by doing as much for themselves as possible and choose activities that appeal to them.

KADH is staffed by trained health professionals and volunteers who are passionate about caring for kūpuna. We also have 2 registered nurses, who complete health assessments, manage medical emergencies, provide education to clients and families, and are available to kūpuna. KADH has 57 enrolled participants. More than 60% of enrollees are low income, and more than 75% receive government subsidies and/or tuition scholarships.

KADH has maintained its license to operate as a Freestanding Adult Day Health Center in the State of Hawaii for over 30 years, which is a testament to the quality of services delivered through diligent efforts to remain up-to-date and in compliance with regulations provided by the State of Hawaii, Department of Health, and the Office of Health Care Assurance.

2. The goals and objectives related to the request

Goals:

The goals of Kauai Adult Day Health Center's Capital Improvements are:

- 1) To complete renovations to the new KADH location, thereby conforming to physical plant construction requirements under Section 11-96-30, Hawaii Administrative Rules.
- 2) To install a fire sprinkler system as required by the Kaua'i County Planning Department.

Objectives:

KADH is relocating to 3-3367 Kūhiō Highway, Līhu'e, Hawai'i, 96766, approximately 1.4 miles away from its current location. This "new" location will need renovation before KADH can move into it. The master lease is held by the president of Ohana Pacific Management Company under RSK Holdings since 2011. The objectives of this request is to complete the following:

Building renovation: \$300,055.84.

- Design, Engineering and Permitting: Provide basic architectural, electrical, and mechanical drawing for permitting. Permitting process and permit fees. Structural engineering.
- Electrical: Remove wiring and demolish walls. Remove and replace damaged receptacles and check condition of existing wiring. Remove and replace switches and check for any damages. Remove and replace emergency battery pack lights.
- Flooring. Provide basic flooring replacement within the material and labor budget.
- Drop Ceiling. Provide drop ceiling repairs around demolished walls.
- Framing and Drywall: Repair drywall and framing damaged by demolition. Hang, mud and tape, and texture drywall to a light orange peel finish.
- Plumbing: Remove plumbing from demolished walls and provide infrastructure for new ADA bathrooms.
- Finish: Miscellaneous finishing work.
- Addition of two (2) Bathrooms: Provide basic bathrooms to meet ADA requirements. Addition includes, two (2) additional toilets and one (1) shower.
- Paint: provide one (1) coat of primer and two (2) coats of paint on all repaired areas.
- General Conditions: Mobilization, waste deposal, and equipment rental.
- HVAC/Mechanical: Install mechanical, ventilation, and fire alarm equipment.

 EA connection to mainline included. Chlroination from main to RPDA and asphalt trench repair of highway.

- Traffic Control: for work in highway.

3. The public purpose and need to be served

KADH provides programs to kūpuna and disabled adults, including health services, socialization, cognitive and physical stimulation in a protective environment. Services improve the quality of life for enrollees and their caregivers. It is the only adult day health center on the island of Kaua'i. In 2017, the average length of enrollment was 2.97 years, currently the average length of enrollment is 3.41 years. The longest duration of an enrollee is 12 years and the oldest enrollee is 101-years old and is currently in their ninth year in the KADH program. Through these programs, KADH has prevented premature institutionalization and/or provided respite for caregivers for 69 families in 2017 and 76 families in 2018. Based on the trend over the past 3 years, we anticipate about 20 new families being served each year.

Participants' ages range from 64 to 101 years and caregivers' ages range from 35 to 85 years. Caregivers are often young, work full-time, and frequently have children of their own to raise. Some caregivers are near to retirement, or retired, but are challenged due to their own physical health, and are possibly caring for their grandchildren, and/or are stressed from caring for a loved one with physical or cognitive problems.

KADH's current location at 2943 Kress Street, Līhu'e, Hawai'i, 96766 needs serious repair. The bathrooms, main social hall, and storage rooms all have major leaks during heavy rains. The building does not have temperature control. The unregulated temperature is a hindrance to Kūpuna, who have difficulties regulating their own body temperatures. The bathrooms are consistently out-of-order, leaving minimal facilities for the quantity of staff and Kūpuna. All issues were brought to the building's owner; who has and continues to be unresponsive. In addition to these issues, the center's entrance is at a gradual incline, and approximately 100-feet long, meaning kūpuna who are not wheelchair bound must maneuver the incline, which poses both a fall risk and a liability.

The proposed renovations to the new location are required by state law to operate a Free-Standing Adult Day Health Center. Once renovated, the new, up-to-code center will create a safer, healthier, and more accessible environment for the kūpuna KADH serves across the island of Kaua'i.

4. Describe the target population to be served

As the only Free-Standing Adult Daycare on Kaua'i, KADH's target population is Kauai's 60+ population who are frail and physically and/or memory impaired who need specialized care due to illnesses, such as Alzheimer's Disease, Parkinson's Disease, dementia, declining physical health, and other disorders. KADH also provides respite for families, spouses, and caregivers alike.

In partnership with the Kaua'i County's Agency on Elderly Affairs, The Kaua'i Bus, Department of Human Services, Senior Centers across the island, Kauai Economic Opportunity, Medicaid

Service Providers, Department of Veteran's Affairs, Kauai Community College, Kauai Independent Food Bank, and Hawaii Community Foundation, KADH serves the entire island of Kaua'i. According to the U.S. Census Bureau, in 2018 Kaua'i County's 65+ population is currently 18.6% and 10% have Alzheimer's dementia. This population, including their caregivers, benefit from supervised day care and health services.

According to The Department of Business, Economic Development & Tourism 2014 report, Kaua'i County's Resident Population 60+ was 24.9% or 17,563. By 2020, 25% of Hawai'i's population will be 60+ and at least 37.7% will require community-based services in order to age in place. Kaua'i County's Agency on Elderly Affairs summarized data from the U.S. Census information for the Administration on Aging and found that 37.7% of Kauai's older adults had a disability, which included sensory and physical disability, self-care disability, or disability with going outside of the home.

KADH is centrally located in the heart of Lihue at 2943 Kress Street and provides service to the entire island community of Kaua'i.

The Ohana Pacific Foundation (OPF) Board President and KADH Program Director will provide daily oversight to project operations and meet on a weekly basis with the project manager to monitor progress. Nathan Wood will visit the construction area weekly to monitor the quality of work during the construction project, and report any issues when

and if they arise. Any issues will be discussed throughly with the OPF Board President, KADH Program Director, Nathan Wood, and any additional professionals needed to fully understand the depth and impact of the issue. The team will continually assess whether the project is progressing according to, contract and timeline schedules, budgets are within parameters, and quality of work is meeting standards and codes. Standard best-practice processes will ensure work completed is in compliance including, a final inspection by appropriate licensed professionals and project management team members to assess project impact on the structural integrity of the building once all work is completed

V. Experience and Capability

Kauai Adult Day Health Center (KADH) is the only Adult Day Health Center on the island of Kaua'i. KADH has maintained its license to operate as a Freestanding Adult Day Health Center in the State of Hawaii for over 30 years. The project will be managed by a Project Management

Team, consisting of the Board President, Ohana Pacific Management Company (OPMC) Chief of Operations, OPMC Director of Operations and KADH Program Director. The Board President has over 20 years of experience in business and healthcare administration. In his current role as the Administrator of Garden Isle Rehabilitation and Healthcare Center, he oversaw the installation of the commercial kitchen and foodservice operation. He was also responsible for managing the majority of the work on Hale Kupuna Heritage Home's, a Kauai skilled and intermediate care facility, \$300,000 waste water project in 2017.

The OPMC Chief of Operations has been a manager/executive in various long-term care organizations for 25 years. She has managed up to 2,000 skilled beds over various states. Currently she manages the OPMC group with over 500 beds of skilled care as well as (2) Adult Day Health programs and one home health company. With previous organizations she has overseen the acquisition of various communities as well managed multimillion-dollar refurbishment projects for various skilled and assisted living communities. Currently OPMC is managing multimillion-dollar refurbishment projects for three communities and working on the expansion of another.

The Director of Operations has been with Ohana Pacific Management for 14 years. Serving in various capacities such as Social Services Manager and Administrator, in her current role she is responsible for planning, directing, implementing and evaluating overall development, management and successful administration of Post-Acute Services for Ohana Pacific Management.

The Program Director oversees and provides leadership of overall operation of the KADH facility and achieves facility objectives within planned budgets and schedules. Writes proposals for funding to meet the expense of the center; in addition to preparing and submitting monthly and annual activity and financial reports to appropriate funding agencies.

Nathan Wood is the Project Manager and will report to the Project Management Team on the timeliness of the project and work being completed in regard to the renovation and installation of the fire sprinkler system. The project management team consists of a professional and skilled team of healthcare administrators, an attorney, social worker and registered nurse. The Board President has over 20 years of experience in healthcare business which includes, building improvements and conforming to health codes and regulations. Nathan Wood owns and operates Nathan Wood General Contractor, LLC. Nathan Wood General Contractor is a Kaua'i owned and operated company. They are a state-licensed general contractor, solar power systems contractor, and electrical contractor. They also retain a state-licensed electrical engineer. They're a team of Kauai-based builders, engineers, and support staff represent some of the best talent in the industry working on private, state, federal, and industrial and commercial projects.

2. Facilities

The facility located at 3-3367 Kūhiō Highway, Līhu'e, Hawai'i, 96766 was previously the site for Veteran's Affairs Community Based Outpatient Clinic. The building in its current condition, 1) does not conform to physical plant construction requirements under Section 11-96-30, Hawaii Administrative Rules, and 2) does not conform to sprinkler requirements as required by the Kaua'i County Planning Department. RSK Holdings has held the master lease since 2011 and is responsible for the management, repair and improvement of the property and its building. The current 55-year lease expires in 2044. See also Section II. – Background & Summary, No. 3 Public Purpose and Need to be Served.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

The oversite of this project will be managed by Ohana Pacific Foundation. Ohana Pacific Foundation has a team of staff and board resources that has substantial experience planning and managing facilities projects including the finance and administration aspects of a project of the proposed size.

Ohana Pacific Foundation (OPF) Board Members consisting of healthcare professionals with skills including a healthcare administrator with over 20 years of healthcare management experience, a CFO with significant experience with financial management, and president of OPMC, the largest post-acute healthcare company in Hawai'i. OPF's Board and management team are well suited to continue steering the organization toward a sustainable future.

Daily Staffing, Staff Qualifications, Supervision and Training

The major elements of our program are to provide socialization, education, health maintenance, and supportive services for our clients. The KADH provides specialized and meaningful activities throughout the day that emphasize the type of individualized attention, which is required by clients with deteriorating mental abilities and physical skills. The staff involved in the daily care of program participants include the Administrator, Program Director, Day Health Specialist, Activity Coordinator, and Activity Assistants.

- The Administrator provides leadership to formulate operational strategies and achieve facility objectives within planned budgets and schedules.
- The Program Director oversees and provides leadership of daily operation of the facility and
 facility objectives within planned budgets and schedules. Writes proposals for funding to
 meet the expense of the center; in addition to preparing and submitting monthly and annual
 activity and financial reports to appropriate funding agencies. The Program Director
 schedules and leads monthly support group meetings held at the center to support clients'
 family caregivers.
- The Activity Coordinator organizes and oversees the daily operations of the center, helping to
 assure that a variety of programs are offered, and appropriate services are provided to clients.
 Assess clients upon admission for group and individual activity based upon the client's
 preferences, abilities, and/or social needs to promote the highest practicable level of
 independence and self-esteem. Completes the monthly calendar and develops activity
 schedules with staff input.
- Nursing services are available for clients who require medication administration, direct medical supervision, and other related health maintenance services with direct supervision by a registered nurse. The Day Health Specialist (registered nurse) provides professional nursing care to the clients, coordinates the health component of the program to meet the needs of the clients. Collaborates with the interdisciplinary team members (i.e., primary care physician, social worker, dietician, and activity coordinator) to coordinate all care for clients. Develops client care plan and monitors clients to help them achieve their goals. Performs assessments upon admission, monthly, quarterly and as needed.
- Activity assistants assist in planning, organizing, conducting, and documenting the daily
 activities offered to clients. Provides personal care assistance to clients according to their
 individual needs to help assure optimal level of care and provide supervision and cueing with
 activities of daily living and program activities.


