II. Background and Summary

St. Francis Healthcare System of Hawaii (St. Francis) has and continues to be at the forefront of preparing to meet the needs of Hawaii's growing elder population. St. Francis is sponsored by the Sisters of St. Francis of the Neumann Communities of Syracuse, New York. Since their arrival 135 years ago, the Sisters have remained committed to following the example of Christ's healing ministry and the teachings of

St. Francis of Assisi, caring for all with kindness, respect, and concern. Since 1883, the Sisters of St. Francis and their staff have been reaching out to those at the margins of society, including the sick, homeless, and abandoned, hoping to bring peace, comfort, and friendship to those who need it.

The Sisters of St. Francis have administered several hospitals including Malulani Hospital (now Maui Memorial Medical Center) and Hilo Hospital (now Hilo Medical Center) and are most known for founding St. Francis Hospital in 1927 to care for the poor and needy. In addition, they have led the health care industry with the introduction of numerous health care services that include: home health services on Oahu (1962) and on Kauai (1977); renal dialysis (1965); kidney transplants (1969); cancer rehabilitation (1973); hospice care (1978); heart transplants (1987); a bone marrow donor registry (1989); intergenerational adult day care (1996); outpatient palliative care (2008); and telehealth monitoring on Kauai (2008) and on Oahu (2009). The Sisters' continuum of care model achieves excellent health outcomes for those who entrust their care to them.

St. Francis continues to be a recognized leader in home- and community-based care, a sector of the healthcare continuum that has emerged as the single most important area of growth to meet the needs of older adults. In 1984, St. Francis Healthcare Foundation of Hawaii was established as an entity of St. Francis responsible for coordinating all fund development efforts.

2. The goals and objectives related to the request;

With an aging senior population and the highest life expectancy in the nation at over 82 years of age, St. Francis recognizes the urgent need to offer kupuna preventive services that enable them to maintain fitness, remain healthy, live independently, and age in place without premature institutionalization. Seniors must have access to a range of community-based support services, including fitness classes, nutrition education, adult day care, and caregiver support and training, all of which will be offered through the Kupuna Village and its Quality of Life Center located at the Liliha campus and complementing the recently completed 119-bed Skilled Nursing Facility.

By co-locating services at its Liliha campus within the convenience of a bus line, seniors will have access to physicians or outpatient ancillary services, such as x-rays or lab tests, in conjunction with scheduled wellness activities all within a centralized location. Not only will the Quality of Life Center address the need for programs leading to healthy aging in place, it will provide access to nonmedical services for older adults in conjunction with medical care, including fall prevention, nutrition education, exercise, and caregiver support and training. Once constructed, the Quality of Life Center will collaborate with Hawaii's acute care hospitals, primary care physicians, and specialists in the field of aging to continually assess which programs best support active aging and enhance overall health and wellness of our kupuna.

The objective of this request is to begin the design development of the integration of the remaining portions of the campus by creating walkable and safe access for all who use the campus. With the addition of the Assisted Living Facility and the Quality of Life Center, along with our existing services it has become more apparent that St. Francis needs to create safer and more user friendly pedestrian and vehicular access to the campus. The Liliha Campus is a neighborhood within a neighborhood. St. Francis would like to create walkable neighborhoods on the campus to allow seniors the freedom to interact socially on the campus knowing that they can safely walk from one area to another. St. Francis would also like to create safer vehicular access to the campus by creating drop off and pick up areas that allow for continuous traffic flow and safe pedestrian mobility. As St. Francis Healthcare System continues to find opportunities to better service the community, there is a need to ensure safe passage for those on and off the campus.

3. The public purpose and need to be served;

In less than 20 years, the population over age 60 in Hawaii will have increased by 310% since 1980, requiring a critical shift in services from sick care and long-term support to active aging. During this same 55-year period, Hawaii's seniors over 85 years will experience a hyper-growth rate of 1,158%. According to Hawaii's 2020 Vision (2013), the state must shift its focus to support active aging as resources for long-term support will be unable to keep pace with demand given shortages in healthcare workers and limited long-term facilities.

By 2029, the youngest of the Baby Boomer generation will reach retirement age, but Hawaii will experience a more pronounced "boomer effect" according HDBET (2012). By 2030, nearly 25% of the state's population will be age 65 and older. Although boomers are expected to enjoy long life expectancies, the Journal of American Medicine (2013) predicts that they will have higher rates of chronic medical conditions, resulting in an estimated 4 million additional emergency visits. Physician visits are expected to double, with boomers representing 4 in 10 visits. One in two boomers is anticipated to be living with arthritis, the number of knee replacements is forecasted to escalate, and the amount of diagnostic interventions, lab tests, and preventive screening measures will soar.

Unfortunately, older adults are not engaging in the type of active lifestyles that lead to health and wellness. The Surgeon General's Report on Older Adults contends that one-third of men, and one-half of women engage in no physical activity by the age of 75, even though loss of strength and stamina is partially attributed to a decrease in physical activity. The Surgeon General maintains that physical activity significantly impacts the health of older adults by enhancing their ability to live independently, while reducing risk of falling or fracturing bones. Regular exercise lowers the risk of death from coronary heart disease, and leads to a decreased incidence of high blood pressure, colon cancer, and diabetes. Physical activity reduces blood pressure among seniors suffering from hypertension, improves stamina and muscle strength for older adults with chronic, disabling conditions, controls joint swelling and pain from arthritis, and supports healthy bones, muscles and joints.

Not only do the majority of seniors prefer to age in place safely and as independently as possible, home health care and institutionalization are cost prohibitive for many in Hawaii. AARP Hawaii indicates that private nursing homes are 50% more than national averages, with in-home health care costing thousands more than mainland services. Hawaii only has 4,400 available beds in nursing homes and 7,000 spaces in residential facilities – a grave situation for the 70% of projected kupuna needing long-term care who will be forced to seek other alternatives.

Hawaii is experiencing a crisis, given the state's exponential growth in an aging population and working family members or seniors themselves being thrust into the role as caregiver, often with little to no training or experience. According to a 2018 AARP conference on "Caring for Family, Caring for Yourself," approximately 154,000 family members provide care for loved ones in Hawaii, with about 6 potential family caregivers for every senior 80 and older in 2010. Unfortunately, this ratio is expected to drop to 3:1 by 2030. One way to mitigate the stress associated with challenges of daily care is through education and skills training (Families Caring for an Aging America, 2016).

Amidst this seemingly bleak forecast, St. Francis is poised to offer a viable solution to Hawaii's need for programs that focus on successful and active aging in place. With the opening of Kupuna Village and the Quality of Life Center, St. Francis will be well-equipped to meet the demand for programs and services to satisfy Hawaii's growing senior population and their caregivers.

The Liliha community and contiguous neighborhoods have experienced substantial rainfall in the past few years, from light precipitation to occasional downpours. Seniors, their caregivers, and residents need a safe, protected area for drop-off and pick-up when accessing services, particularly since older adults have weaker body responses and are more prone to falls, often resulting in lasting damage despite using a cane or walker. The Center for Disease Control estimates that seniors age 65 and older have a 25% greater chance of falling due to a weaker sense of balance, diminished eyesight, decreasing strength, and loss of flexibility.

The design development of the integration of the remaining portions of the campus will offer all of residents, visitors, employees and specifically seniors and their caregivers an extra measure of protection that minimizes the risk of falling as they access health and wellness programs at the new Quality of Life Center.

4. Describe the target population to be served; and

The Quality of Life Center will directly benefit one of Oahu's most vulnerable populations – seniors age 62 and older and their caregivers at or below median income level for Honolulu County. The initial target population will be seniors residing in the Liliha area, however will serve contiguous communities on Oahu. Liliha is a community where nearly 1 in 3 residents is age 60 and above and 48% of households include at least one family member age 65 years and over. According to the U.S. Census Bureau, over 75% of all households in Liliha and surrounding communities are living below the

median household income level for Honolulu County, with about 40% living on fixed incomes. In addition, nearly 1 in 4 households are receiving cash public assistance and/or Food Stamps/Supplemental Nutrition Assistance Program (SNAP) benefits.

The Quality of Life Center will serve seniors residing in the Liliha area, however, transportation services will provide pick up and drop off services targeted to low income senior housing facilities such as Manoa Gardens, Kulana Hale and Wisteria Vistas to enable a greater number of seniors from Oahu's urban core to be able to participate in our programs.

Lauri Rasmussen serves as Vice President of Operations for St. Francis Healthcare
Systems of Hawaii. Lauri oversees asset management and construction of Kupuna
Village Quality of Life Center to ensure that all projects are completed on time and
according to specifications. Most recently, Lauri oversaw the successful completion of
the 119-bed skilled nursing facility, which was opened in 2015. As Vice President of
Operations, Lauri is responsible for the administrative functions that include information
technology and communications, facilities and grounds maintenance, risk management,
and safety for the organization.

Grant-in-Aid funds will be used toward design development, site work, demolition, construction and other related costs to create safer vehicular access to the campus by creating drop off and pick up areas that allow for continuous traffic flow and safe pedestrian mobility.

V. Experience and Capability

1. Necessary Skills and Experience

Following the legacy of Saint Marianne Cope, the Sisters of St. Francis have been dedicated to meeting the health needs of Hawaii's people for more than 130 years. The sisters are known for pioneering new services in Hawaii, and have focused recent efforts on meeting the needs of Hawaii's aging senior population.

St. Francis has been the recipient of federal funds for two projects. In 2013, St. Francis completed construction of an \$8 million, 15,000-square-foot, single level intergenerational center in Ewa Villages to address the needs for services for both the elderly and preschool populations living in West Oahu. The St. Francis Intergenerational Center enables families in the sandwich generation to drop off their

aging parents who need assistance during the day and their young children in one convenient location.

- St. Francis also has the experience of overseeing the management and operations of a vibrant, affordable senior independent living community. Franciscan Vistas Ewa, a 149-unit complex that is 100 percent leased, features amenities typically found only in luxury living centers. St. Francis will leverage its experience from these two facilities in Ewa Villages to build on this success at the Liliha campus.
- St. Francis has already celebrated completion of its 119-bed skilled nursing facility to provide quality rehabilitative care to older adults until they are ready to return home. With the opening of the Quality of Life Center, St. Francis will be able to offer a range of wellness and fitness activities designed to keep seniors healthy and fit.
- St. Francis successfully operates adult day care programs at three sites that focus on client health and well-being through structured activities and social interaction to low-to moderate-income seniors in a safe group setting, while providing needed respite to family and caregivers. Opened in 1996, Franciscan Adult Day Center in Manoa was Hawaii's first adult day center to bring young and old together for shared activities based on the vision of Sister Maureen Keleher. In July 2018, St. Francis was approached by Special Education Center of Hawaii (SECOH) to take over adult day care operations at its Diamond Head facility because of a proven track-record in providing for the needs of Hawaii's seniors.
- St. Francis has received previous grants through Hawaii Community Foundation and the City and County of Honolulu's Elderly Affairs Division to operate programs at its Manoa and Ewa Villages sites. St. Francis adult day care was voted best program in the state for the past two consecutive years by over 500,000 Honolulu Star-Advertiser readers. Over 80% of beneficiaries attending programs improved in areas of fall prevention, nutrition, and social engagement, with between $\frac{2}{3}$ $\frac{3}{4}$ of beneficiaries able to remain in their home at year-end.

2. Facilities

St. Francis recently opened a 50,000 sf 119-bed skilled nursing facility by upgrading three floors of the 40-year-old Sullivan Building and bringing it to code. Seventy percent of the rooms in the skilled nursing facility are private, many which offer panoramic views of the Honolulu skyline and serene views of Nuuanu Valley.

Each floor is designed to create a vibrant healing environment that encourages interaction, activity, and connection with the community. In addition, St. Francis modernized and renovated its 40-year-old commercial kitchen.

St. Francis is currently completing renovations to a portion of the Liliha campus to establish Kupuna Village Quality of Life Center, a one-stop health and wellness center that complements the Skilled Nursing Facility and provides a continuum of services to meet the needs of Hawaii's growing senior population and their caregivers.

- St. Francis Healthcare System's qualified staff have extensive experience in implementing, managing, and bringing similar, major capital projects from conception to completion.
- St. Francis Healthcare Foundation of Hawaii is led by *President Jerry Correa*, who provides oversight of day-to-day operations covering a broad range of programs and services. Correa also leads the proposed transformation of the Liliha campus into St. Francis Kupuna Village, a one-stop health and wellness center for seniors and caregivers which includes the recently opened skilled nursing facility and Quality of Life Center. Prior to being named President, Correa served as Chief Operating Officer from 2007 through 2012, where he oversaw operational and financial performance of the different health services and programs.

Leslie Lam serves as Vice President of St. Francis Healthcare Foundation of Hawaii, where she is responsible for managing investments, as well as coordinating all fundraising efforts of St. Francis Healthcare System, its entities and programs. Prior to joining the Foundation in 2016, Leslie was Executive Director of American Diabetes Association, where she was instrumental in increasing fundraising net revenues by 14% through a donor cultivation plan that resulted in the establishment of multiple funding streams.

Fees-for-service, annual fund raising efforts, and the generous donations of individuals and friends of St. Francis will ensure the sustainability of the programs and services at the Quality of Life Center beyond grant funding.

As with all properties, St. Francis has an ongoing maintenance plan to ensure that facilities and vehicles are well maintained in the future, further eliminating the need for funding beyond the grant period. In addition, annual fund raising efforts, volunteer assistance, and the generous donations of individuals and friends of St. Francis will ensure the longevity of programs and services at the Quality of Life Center.


