**Annual report to the Hawaii Legislature on the Transportation Improvement
Special Fund**

Introduction:

Act 370, Session Laws of Hawaii 1997, established a transportation improvement special fund to fund qualified transportation projects and to receive reimbursements from private developers who have been advanced public funds to fulfill the conditions of land use development relating to transportation. This Act also requires that the Department of Transportation (DOT) submit an annual report to the Legislature on the use of the transportation improvements special fund including, but not limited to, the fund balance and expenses for the immediately preceding fiscal year and proposed appropriations from the fund for the next fiscal year.

Revenues:

Pursuant to transportation development agreements (TDA) concerning DOT improvements to the Makakilo, Mililani, and Kunia Interchanges, developers have reimbursed a total of \$10,595,124.69 of DOT expenditures and the revenues have been deposited to the transportation improvement special fund.

Repayment for the Makakilo Interchange improvements has been completed. (Aug 2011)

Repayment for the Mililani Interchange improvements has been completed. (Mar 2014)

Repayment for the Kunia Interchange improvements has been completed. (11/5/14)

Expenditures:

No other expenses were incurred during FY 2017-2018 and no appropriations are requested for FY 2018-2019.

A final payment for the Kunia Interchange improvement was collected on 11/5/14. This payment closed out all innovative financing projects for the DOT. The DOT does not intend to pursue any further Highway TDAs in the foreseeable future. No further expenditures are planned for the remaining funds in the immediate future.

It is recommended that reporting on these funds be deferred until another TDA is executed or there are further expenditures on the remaining money in the Special Fund.
