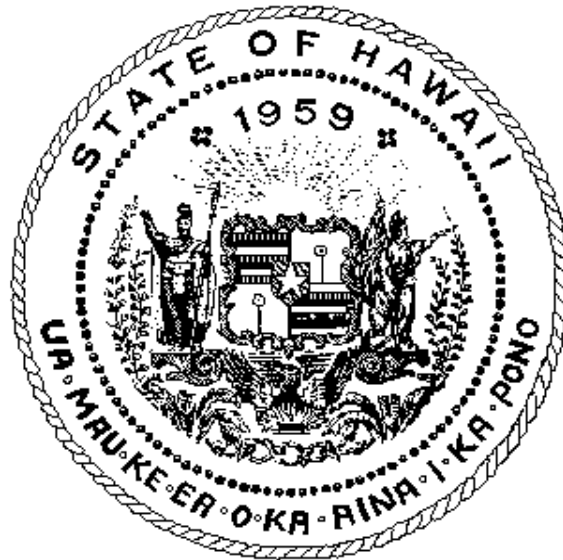

Annual Report on the Status of the Federal Reimbursement Maximization Special Fund
Fiscal Year 2018

Section 353C-7, Hawaii Revised Statutes, established the Federal Reimbursement Maximization Special Fund (FRMSF) under the purview of the Department of Public Safety (PSD). The following are the uses allowed for this special funds:

1. To meet the state match requirement for federal grants and costs associated with federal grant reporting requirements, including administrative expenses such as the hiring of temporary staff;
2. For any other purpose deemed necessary by the department for maintaining existing federal grants as well as pursuing federal grants;
3. To hire consultants to provide training for corrections officers;
4. To hire consultants to conduct facility or program evaluations;
5. To rent or purchase vehicles to transport inmates;
6. To provide pre-release and reentry programs;
7. To improve technology; and
8. To develop a plan for workforce recruitment and retention.

For fiscal year 2018, the total expenditure was \$232,401.15. The details of the expenditure are as follows:

\$149,350.83 for Purchasing Replacement Vehicles

The funds were used to purchase replacement vehicles (handicap van as well) to transport inmates from the Correctional facility to the courts, medical facilities, and other destinations. A priority vehicle listing was provided by each facility based on the vehicle's age, mileage, and working condition. Correctional facilities were provided replacement vehicles based on the vehicle's condition and amount of available funding.

\$8,276.83 for State Match for the Violence Against Women Grant (VAWA)

The purpose of this grant is to implement comprehensive strategies addressing violence against women that are sensitive to the needs and safety of victims and holding offenders accountable for their crimes.

\$33,928.73 for State Match for the Bridge Programs

The purpose of this grant is to continue building on PSD's success in operating the substance abuse treatment and reentry programs for inmates.

\$40,844.76 for Miscellaneous Expenses
