A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ON 1. (a) The university of Hawaii shall annually						
2	collect da	ata by utilizing surveys, focus groups, and other						
3	appropriat	te feedback mechanisms to assess the effectiveness of						
4	the Hawaii	i community college promise program. The data						
5	collected	shall provide information on the Hawaii community						
6	college p	romise program generally and the scholarship recipients						
7	specifically, including but not limited to:							
8	(1)	How many scholarship recipients would have enrolled in						
9		the university of Hawaii community college system						
10		without the benefit of the program;						
11	(2)	How many scholarship recipients begin a degree program						
12		but are unable to complete the program, despite						
13		receiving the benefit of a Hawaii community college						
14		promise program scholarship; and						
15	(3)	The degree to which receipt of a Hawaii community						
16		college promise program scholarship directly increases						

1		the	likelihood	that	a recipient	completes	а	degree
2		prog	gram.					

- 3 (b) The university of Hawaii shall submit an annual report
- 4 to the legislature of its findings and recommendations,
- 5 including any proposed legislation, no later than thirty days
- 6 prior to the convening of the regular session of 2021 and each
- 7 regular session thereafter.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$700,000 or so much
- 10 thereof as may be necessary for fiscal year 2019-2020 and the
- 11 same sum or so much thereof as may be necessary for fiscal year
- 12 2020-2021 for additional funds for the Hawaii community college
- 13 promise program.
- 14 The sums appropriated shall be expended by the university
- 15 of Hawaii for the purposes of this Act.
- 16 SECTION 3. This Act shall take effect on July 1, 2019.
