A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness is one
- 2 of the most pressing problems in Hawai'i, which requires a
- 3 robust, comprehensive, long-term solution to address Hawai'i's
- 4 affordable housing and homelessness crisis.
- 5 Over the last fifty years in Hawai'i, the number of cost-
- 6 burdened renters, those paying more than thirty per cent of
- 7 their income for rent, went from less than a quarter of the
- 8 population to over half. High housing costs have driven more
- 9 and more Hawai'i residents into homelessness. Hawai'i has the
- 10 highest homelessness rate in the nation.
- 11 The legislature further finds that by making smart
- 12 investments in homelessness and housing, using data-driven
- 13 practices, and improving coordination, Hawai'i has gradually
- 14 begun to turn the tide in the homelessness crisis. In 2017,
- 15 Hawai'i's homelessness rate went down for the first time in
- 16 years, a trend that continued in 2018. During the regular
- 17 session of 2018, the legislature made unprecedented levels of

- 1 investment in low-income housing and homelessness, appropriating
- 2 \$200,000,000 for the rental housing revolving fund, \$30,000,000
- 3 for ohana zones, and \$13,500,000 for proven-effective and
- 4 promising homelessness programs.
- 5 To turn back the fifty years of growth in Hawai'i's housing
- 6 and homelessness crisis, investments of this scale must be made
- 7 consistently in the coming years. Hawai'i must prioritize
- 8 programs that are the most cost-effective and target the most
- 9 vulnerable populations, such as outreach, rapid re-housing,
- 10 housing first, and family assessment centers.
- 11 The purpose of this Act is to fund core homelessness
- 12 services.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$10,800,000 or so
- 15 much thereof as may be necessary for fiscal year 2019-2020 and
- 16 the same sum or so much thereof as may be necessary for fiscal
- 17 year 2020-2021 for the department of human services to fund and
- 18 administer core homelessness services; provided that the sums
- 19 appropriated shall be expended as follows:
- 20 (1) \$3,750,000 for the housing first program;
- 21 (2) \$3,750,000 for the rapid re-housing program;

- 1 (3) \$1,550,000 for the family assessment centers; and
- 2 (4) \$1,750,000 for homeless outreach and civil legal
- 3 services.
- 4 The sums appropriated shall be expended by the Department
- 5 of Human Services for the purposes of this Act.
- 6 SECTION 3. (a) There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$3,000,000 or so much
- 8 thereof as may be necessary for fiscal year 2019-2020 for the
- 9 department of human services to fund stored property and debris
- 10 removal services.
- 11 The sum appropriated shall be expended by the department of
- 12 human services for the purposes of this Act.
- 13 (b) The department of human services may contract the
- 14 services of another entity to perform any related services that
- 15 may be required pursuant to this section. Any contract for
- 16 services executed pursuant to this section shall be exempt from
- 17 chapter 103D, Hawaii Revised Statutes.
- 18 SECTION 4. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 20 thereof as may be necessary for fiscal year 2019-2020 for the

- 1 state rent supplement program established pursuant to section
- 2 356D-151, Hawaii Revised Statutes.
- 3 The sum appropriated shall be expended by the Hawaii public
- 4 housing authority for the purposes of this Act.
- 5 SECTION 5. This Act shall take effect on July 1, 2019.
