A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that an increasing number
2 of Hawaii voters are submitting their votes by mail. The 2014
3 Hawaii primary election was the first election in which more
4 ballots were submitted before primary election day than on that
5 day. Fifty-six per cent of Hawaii voters chose to vote early
6 during the 2014 primary, and approximately eighty-three per cent
7 of those voters did so through a mail-in absentee ballot. In
8 2016, the number of votes cast before election day exceeded the
9 number of votes cast at polling places on election day, except
10 in one county.

11 The legislature further finds that Act 182, Session Laws of
12 Hawaii 2018, established a pilot program for the 2020 primary
13 and general elections in any county with a population of less
14 than one hundred thousand to be conducted by mail. Expanding
15 this program throughout the State would significantly reduce the
16 logistical issues related to conducting elections at polling
17 places. It is the intent of the legislature that the resulting



1 savings in state funds due to implementation of statewide mail-
2 in absentee voting be directed, whenever practicable, into the
3 Hawaii election campaign fund to be used for public financing of
4 elections.

5 Accordingly, the purpose of this Act is to:

- 6 (1) Require all elections statewide to be conducted by
7 mail beginning with the 2020 primary election;
- 8 (2) Establish a limited number of voter service centers
9 that would remain open from the tenth business day
10 preceding an election through the day of the election
11 to receive personal delivery of mail-in ballots,
12 accommodate voters with special needs, offer same day
13 registration and voting, and provide other election
14 services;
- 15 (3) Allow for additional places of deposit for personal
16 delivery of mail-in ballots;
- 17 (4) Appropriate funds for the implementation and
18 administration of the election by mail system; and
- 19 (5) Require the office of elections to submit a report to
20 the legislature before the convening of each regular



1 session from 2020 through 2025, regarding the
2 implementation of the election by mail system.

3 SECTION 2. Chapter 11, Hawaii Revised Statutes, is amended
4 by adding a new part to be appropriately designated and to read
5 as follows:

6 "PART . ELECTIONS BY MAIL

7 §11-A Elections eligible to be conducted by mail.

8 Beginning with the 2020 primary election, all elections shall be
9 conducted by mail in accordance with this title.

10 §11-B Procedures for conducting elections by mail. (a)

11 Ballot packages for elections by mail shall include:

- 12 (1) An official ballot;
13 (2) A return identification envelope with postage prepaid;
14 (3) A secrecy envelope or secrecy sleeve; and
15 (4) Instructions.

16 (b) To the extent practicable, the clerk shall mail a
17 ballot package by non-forwardable mail to each registered voter
18 in the county so as to enable voters to receive the ballot
19 package approximately eighteen days before the election. The
20 clerk shall continue mailing ballot packages to voters who
21 update their voter registration address no later than fourteen



1 days before the date of the election. In determining the
2 initial mailing date of the ballot packages, the clerk shall
3 consider the mailing place of origin and the most recent postal
4 service delivery standards. The clerk shall not mail a ballot
5 package to any voter in the county register who is identified as
6 having an outdated or non-deliverable mailing address. Nothing
7 in this part shall be construed to change the responsibilities
8 of the clerk or chief election officer under chapter 15D with
9 respect to uniform military and overseas voters.

10 (c) The clerks shall determine and provide for voter
11 service centers and places of deposit pursuant to this part and
12 section 11-92.1.

13 §11-C Public notice of mailing. Public notice of the date
14 or dates on which the initial ballot packages are to be mailed
15 shall be given by the clerks before the ballot packages are made
16 available to voters.

17 §11-D Ballot instructions; ballot return. (a) After a
18 voter receives a ballot package, the voter shall comply with the
19 instructions included in the ballot package in order to cast a
20 valid vote. The instructions shall include directions for:

21 (1) Marking the ballot;



- 1 (2) Inserting the marked ballot in the secrecy envelope or
2 secrecy sleeve;
- 3 (3) Inserting the secrecy envelope or secrecy sleeve with
4 the marked ballot in the return identification
5 envelope; and
- 6 (4) Signing the return identification envelope before
7 mailing or delivering the return identification
8 envelope containing the secrecy envelope or secrecy
9 sleeve with the marked ballot.
- 10 (b) The instructions shall include information on election
11 fraud and voter fraud, as provided in sections 19-3(5) and
12 19-3.5, and notice that violation of either section may subject
13 the voter, upon conviction, to imprisonment, a fine, or both.
- 14 (c) To cast a valid ballot, the voter shall return the
15 return identification envelope containing the secrecy envelope
16 or secrecy sleeve with the marked ballot:
- 17 (1) By mail so that the return identification envelope is
18 received at the office of the clerk no later than the
19 closing time provided in section 11-131 on the date of
20 the election;



1 (2) By personal delivery at any place of deposit no later
2 than 7:00 p.m. on the date of the election; provided
3 that any voter who is standing in line at a place of
4 deposit at 7:00 p.m. on the date of the election with
5 the intent of returning a ballot and casting a vote
6 shall be allowed to vote; or

7 (3) By personal delivery to any voter service center no
8 later than the closing time provided in section 11-131
9 on the date of the election; provided that any voter
10 who is standing in line at a voter service center at
11 the closing time provided in section 11-131 on the
12 date of the election with the intent of returning a
13 ballot and casting a vote shall be allowed to vote.

14 (d) Once a voter has returned a return identification
15 envelope containing the secrecy envelope or secrecy sleeve with
16 the marked ballot, that voter's ballot shall be deemed cast and
17 may not be recast in the election.

18 §11-E Replacement ballots. (a) A voter may obtain a
19 replacement ballot if the ballot was destroyed, spoiled, or lost
20 by contacting the clerk. The chief election officer may
21 prescribe a replacement ballot application form that shall



1 include information that allows the clerk to verify the
2 registration of the voter and ensure that another ballot has not
3 been returned by the voter.

4 (b) Upon receipt of a completed replacement ballot
5 application form, the clerk shall:

6 (1) Verify the registration of the voter and ensure that
7 another ballot has not been returned by the voter;

8 (2) Record that the voter has requested a replacement
9 ballot;

10 (3) Mark the return identification envelope as containing
11 a replacement ballot; and

12 (4) Issue the replacement ballot package by mail or make
13 the ballot package available for pick-up by the voter.

14 (c) Voters who obtain a replacement ballot shall return
15 the return identification envelope containing the secrecy
16 envelope or secrecy sleeve with the marked replacement ballot:

17 (1) By mail so that the return identification envelope is
18 received at the office of the clerk no later than the
19 closing time provided in section 11-131 on the date of
20 the election;



1 (2) By personal delivery to any place of deposit no later
2 than 7:00 p.m. on the date of the election; provided
3 that any voter who is standing in line at a place of
4 deposit at 7:00 p.m. on the date of the election with
5 the intent of returning a ballot and casting a vote
6 shall be allowed to vote; or

7 (3) By personal delivery to any voter service center no
8 later than the closing time provided in section 11-131
9 on the date of the election; provided that any voter
10 who is standing in line at a voter service center at
11 the closing time provided in section 11-131 on the
12 date of the election with the intent of returning a
13 ballot and casting a vote shall be allowed to vote.

14 **§11-F Deficient return identification envelopes. If:**

- 15 (1) A return identification envelope is returned with an
16 unsigned affirmation;
- 17 (2) The affirmation signature does not match a reference
18 signature image; or
- 19 (3) A return identification envelope contains another
20 condition that would not allow the counting of the
21 ballot,



1 the clerk shall make an attempt to notify the voter by first
2 class mail, telephone, or electronic mail to inform the voter of
3 the procedure to correct the deficiency. The voter shall have
4 five business days after the date of the election to cure the
5 deficiency. The chief election officer may adopt rules
6 regarding requirements and procedures for correcting deficient
7 return identification envelopes. The counting of ballots and
8 disclosure of subsequent election results may continue during
9 the time period permitted to cure a deficiency under this
10 section. The clerk's inability to contact voters under this
11 section shall not be grounds for a contest for cause under
12 section 11-172.

13 **§11-G Electronic transmission under certain circumstances.**

14 (a) If a ballot package is not received by a voter by the fifth
15 day before the date of the election or a voter otherwise
16 requires a replacement ballot within five days of an election,
17 the voter may request that a ballot be forwarded by electronic
18 transmission; provided that a voter with special needs may
19 request that a ballot be forwarded by electronic transmission at
20 any time. Upon receipt of such a request and confirmation that
21 proper application was made, the clerk may transmit the



1 appropriate ballot, together with a form containing the
2 affirmations, information, and a waiver of the right to secrecy
3 under section 11-137.

4 (b) The voter may return the completed replacement ballot
5 and executed forms:

6 (1) By electronic transmission so that the completed
7 replacement ballot and executed forms are received at
8 the office of the clerk no later than the closing time
9 provided in section 11-131 on the date of the
10 election;

11 (2) By mail so that the completed replacement ballot and
12 executed forms are received at the office of the clerk
13 no later than the closing time provided in section
14 11-131 on the date of the election;

15 (3) By personal delivery to any place of deposit no later
16 than 7:00 p.m. on the date of the election; provided
17 that any voter who is standing in line at a place of
18 deposit at 7:00 p.m. on the date of the election with
19 the intent of returning a ballot and casting a vote
20 shall be allowed to vote; or



1 (4) By personal delivery to a voter service center no
2 later than the closing time provided in section 11-131
3 on the date of the election; provided that any voter
4 who is standing in line at a voter service center at
5 the closing time provided in section 11-131 on the
6 date of the election with the intent of returning a
7 ballot and casting a vote shall be allowed to vote.

8 (c) Upon receipt, the clerk shall verify compliance with
9 the requirements of this part; provided that if the voter
10 returns multiple voted ballots for the same election, the clerk
11 shall prepare only the first ballot returned that is not
12 spoiled.

13 **§11-H Counting of mail-in ballots; validity; ballots**
14 **included in recounts; certification of final tabulation. (a)**
15 Ballot processing for tabulation may begin no sooner than the
16 tenth day before the election. In the presence of official
17 observers, counting center employees may open the return
18 identification envelopes and count the ballots; provided that
19 any tabulation of the number of votes cast for a candidate or
20 question appearing on the ballot, including a counting center
21 printout or other disclosure, shall be kept confidential and



1 shall not be disclosed to the public until after 7:00 p.m. on
2 the date of the election or after the last person in line at a
3 voter service center desiring to vote at 7:00 p.m. on the date
4 of the election has voted, as provided in section 11-131,
5 whichever is later. All handling and counting of ballots shall
6 be conducted in accordance with procedures established by the
7 chief election officer.

8 (b) The initial tabulation of ballots shall be completed
9 no later than 6:00 a.m. on the day following an election day.

10 (c) Any ballot the validity of which cannot be established
11 upon receipt shall be retained by the clerk and shall not be
12 commingled with ballots for which validity has been established
13 until the validity of the ballot in question can be verified by
14 the clerk. No ballot shall be included in an initial tabulation
15 until the clerk has determined its validity. The clerk shall
16 make reasonable efforts to determine the validity of ballots
17 within seven days following an election day.

18 (d) Any initial recount provided by law shall include only
19 ballots verified for the purpose of the initial tabulation. In
20 no event shall a recount of an initial tabulation include



1 ballots the validity of which could not be verified by 6:00 a.m.
2 on the day following an election day.

3 (e) No election result shall be certified pursuant to
4 section 11-155 unless all ballots verified as valid by the clerk
5 within seven days following an election day have been added to
6 the final tabulation. Recount of a final tabulation shall be as
7 provided by law.

8 **§11-I Voter service centers; places of deposit. (a)**
9 Voter service centers shall be established at the office of the
10 clerk, and may be established at additional locations within a
11 county as may be designated by a clerk to service the particular
12 needs of a county's voters.

13 (b) Voter service centers shall be open from the tenth
14 business day preceding the day of the election during regular
15 business hours until the time provided in section 11-131 on the
16 date of the election and at the same times statewide.

17 (c) Each voter service center shall provide the services
18 specified in section 11-1 under the definition of "voter service
19 center".

20 (d) The clerks may designate and provide for places of
21 deposit to be open five business days before the election until



1 7:00 p.m. on the day of the election; provided that the
2 locations and apparatus for receiving voted ballots can be
3 securely maintained during the period of use for each election,
4 and as may be permitted by the operational hours.

5 **§11-J Election expenses and responsibilities for elections**
6 **by mail.** (a) Election expenses in an election by mail shall be
7 as follows:

8 (1) All expenses related to elections by mail involving
9 both state and county offices, or involving both
10 federal and county offices, unrelated to voter
11 registration, shall be divided in half between the
12 State and the counties. To the extent that a
13 particular expense is shared statewide, each county
14 shall pay a proration of expenses as a proportion of
15 the registered voters at the time of the general
16 election. The counties shall separately be
17 responsible for expenses associated with voter
18 registration;

19 (2) All expenses for county elections by mail, which do
20 not involve state or federal offices, shall be borne



1 by the counties and paid out of appropriations as may
2 be made by the county councils; and

3 (3) All expenses for state or federal elections by mail,
4 which do not involve county offices, shall be borne by
5 the State and paid out of appropriations as may be
6 made by the legislature. Expenses attributable to
7 registration of voters by the clerk for state or
8 federal elections that do not involve county offices
9 shall be borne by the State and paid out of
10 appropriations as may be made by the legislature.

11 (b) Election responsibilities for elections by mail shall
12 be as follows:

13 (1) For elections by mail involving both state and county
14 offices, or involving both federal and county offices:

15 (A) The counties shall be responsible for voter
16 registration, absentee voting, voter service
17 centers, places of deposit, and the mailing and
18 receipt of ballots;

19 (B) The State shall be responsible for the printing
20 and counting of ballots;



1 (C) The State and counties may otherwise agree to the
2 delegation of these responsibilities to each
3 other; and

4 (D) Any responsibilities not specified in this
5 paragraph may be assigned to the counties or the
6 State by the chief election officer;

7 (2) For elections by mail involving only county offices,
8 the respective county shall be solely responsible; and

9 (3) For elections by mail involving only state or federal
10 offices:

11 (A) The counties shall be responsible for voter
12 registration, absentee voting, voter service
13 centers, and places of deposit;

14 (B) The State shall be responsible for the printing,
15 mailing, receipt, and counting of ballots; and

16 (C) Any responsibilities not specified in this
17 paragraph may be assigned to the counties or the
18 State by the chief election officer."

19 SECTION 3. Chapter 11, Hawaii Revised Statutes, is amended
20 by amending the title of part VI to read as follows:



1 "PART VI. [~~PRECINCT OFFICIALS AND~~] VOTER SERVICE CENTER
2 WATCHERS"

3 SECTION 4. Section 11-1, Hawaii Revised Statutes, is
4 amended as follows:

5 1. By adding five new definitions to be appropriately
6 inserted and to read:

7 "Business day" means any day excluding Saturdays, Sundays,
8 and state or federal holidays.

9 "District" means, unless otherwise specified, the district
10 of political representation with the fewest eligible voters in a
11 particular election.

12 "Electronic transmission" means the transmission of a blank
13 or voted ballot by facsimile or electronic mail delivery, or the
14 use of an online absentee ballot delivery and return system,
15 which may include the ability to mark the ballot.

16 "Place of deposit" means a site within the county of the
17 voter's registration address designated pursuant to section 11-1
18 for the purpose of receiving return identification envelopes in
19 an election conducted by mail pursuant to part .



1 "Voter service center" means a location within the county
2 of the voter's registration address established pursuant to
3 section 11-I to serve all of the following purposes:

- 4 (1) Receive return envelopes for absentee ballots pursuant
5 to chapter 15;
6 (2) Receive return identification envelopes in an election
7 by mail conducted pursuant to part ;
8 (3) Provide voting machine services for persons with
9 disabilities pursuant to the Help America Vote Act of
10 2002, P.L. 107-252, as amended, and any other federal
11 or state law relating to persons with disabilities;
12 (4) Provide any other voting services as provided by law;
13 and
14 (5) Any other purposes the chief election officer or clerk
15 may deem necessary if a natural disaster or other
16 exigent circumstance occurs before an election."

17 2. By amending the definition of "ballot" to read:

18 "Ballot" [7] means a ballot, including an absentee ballot,
19 that is a written or printed, or partly written and partly
20 printed paper or papers containing the names of persons to be
21 voted for, the office to be filled, and the questions or issues



1 to be voted on. "Ballot" includes a ballot used in an election
 2 by mail pursuant to part , including a ballot approved for
 3 electronic transmission. A ballot may consist of one or more
 4 cards or pieces of paper, or one face of a card or piece of
 5 paper, or a portion of the face of a card or piece of paper,
 6 depending on the number of offices, candidates to be elected
 7 thereto, questions or issues to be voted on, and the voting
 8 system in use. ~~[It shall also include the face of the~~
 9 ~~mechanical voting machine when arranged with cardboard or other~~
 10 ~~material within the ballot frames, containing the names of the~~
 11 ~~candidates and questions to be voted on.] "~~

12 3. By amending the definition of "election officials" to
 13 read:

14 "Election officials" ~~[, precinct officials and other]~~ means
 15 persons designated as officials by the chief election officer."

16 4. By amending the definition of "voting system" to read:

17 "Voting system" ~~[,]~~ means the use of paper ballots,
 18 electronic ~~[ballot cards,]~~ transmission, voting machines,
 19 elections by mail pursuant to part , absentee voting pursuant
 20 to chapter 15, or any system by which votes are cast and
 21 counted."



1 5. By deleting the definition of "precinct".

2 ["Precinct", ~~the smallest political subdivision~~
3 ~~established by law.~~"]

4 SECTION 5. Section 11-4, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "§11-4 Rules [~~and regulations~~]. The chief election
7 officer may make, amend, and repeal [~~such~~] rules [~~and~~
8 ~~regulations~~] governing elections held under this title, election
9 procedures, and the selection, establishment, use, and operation
10 of all voting systems now in use or to be adopted in the State,
11 and all other similar matters relating thereto as in the chief
12 election officer's judgment shall be necessary to carry out this
13 title.

14 In making, amending, and repealing rules [~~and regulations~~]
15 for voters who cannot vote [~~at the polls~~] in person or receive
16 or return ballots by mail, and all other voters, the chief
17 election officer shall provide for voting by [~~such~~] these
18 persons in [~~such~~] a manner [~~as to insure~~] that ensures secrecy
19 of the ballot and [~~to preclude~~] precludes tampering with the
20 ballots of these voters and other election frauds. [~~Such~~] The
21 rules [~~and regulations~~], when adopted in conformity with chapter



1 91 and upon approval by the governor, shall have the force and
2 effect of law."

3 SECTION 6. Section 11-15.2, Hawaii Revised Statutes, is
4 amended as follows:

5 1. By amending subsections (a), (b), and (c) to read:

6 "(a) Notwithstanding the closing of the general county
7 register pursuant to section 11-24, a person who is eligible to
8 vote but is not registered to vote may register by appearing in
9 person[+]

10 ~~(1) Prior to the day of the election, at any absentee~~
11 ~~polling place established pursuant to section 15-7 in~~
12 ~~the county associated with the person's residence, or~~
13 ~~(2) On the day of the election, at the polling place in~~
14 ~~the precinct associated with the person's residence.]~~
15 at any voter service center on or before election day.

16 (b) The [county] clerk shall designate a registration
17 clerk, who may be an election official, at each [of the absentee
18 polling places in the county established pursuant to section
19 15-7, prior to the day of the election and at each of the
20 polling places in the county on the day of the election.] voter
21 service center.



1 (c) The registration clerk shall process applications for
2 any person not registered to vote who submits a signed affidavit
3 in accordance with section 11-15, which shall include a sworn
4 affirmation:

5 (1) Of the person's qualification to vote;

6 (2) Acknowledging that the person has not voted and will
7 not attempt to vote [~~at any other polling place for~~]
8 again in that election, and has not cast and will not
9 cast any absentee ballot pursuant to chapter 15 [~~for~~]
10 in that election; and

11 (3) Acknowledging that providing false information may
12 result in a class C felony, punishable by a fine not
13 exceeding \$1,000 or imprisonment not exceeding five
14 years, or both."

15 2. By amending subsections (f) and (g) to read:

16 "(f) Notwithstanding subsection (a), registration pursuant
17 to this section may also be used by a person who is registered
18 to vote but whose name cannot be found on the [~~precinct list for~~
19 ~~the polling place associated with the person's residence.~~]
20 county register.



1 (g) The clerk of each county shall add persons who
2 properly register under this section to the respective general
3 county register. Within thirty days of registration [~~at the~~
4 ~~polling place~~], the [~~county~~] clerk shall mail to the person a
5 notice including the person's name, current street address,
6 district [~~and precinct~~], and date of registration. A notice
7 mailed pursuant to this subsection shall serve as prima facie
8 evidence that the person is a registered voter as of the date of
9 registration."

10 SECTION 7. Section 11-17, Hawaii Revised Statutes, is
11 amended by amending subsections (a) and (b) to read as follows:

12 "(a) The clerk, [~~not~~] no later than 4:30 p.m. on the
13 sixtieth day after every general election, shall remove the name
14 of any registered voter who did not vote in that general
15 election, and also did not vote in the primary election
16 preceding that general election, and also did not vote in the
17 previous general election, and also did not vote in the primary
18 election preceding that general election, and also did not vote
19 in the regularly scheduled special elections held in conjunction
20 with those primary and general elections, if any, with the
21 exception of:



1 (1) Those who submitted written requests for absentee
2 ballots as provided in section 15-4; or
3 (2) Anyone who preregistered pursuant to section 11-12(b).
4 If a person voted, at least once, in any of the above-mentioned
5 elections, the person's name shall remain on the list of
6 registered voters. For this purpose, "vote" means the
7 depositing of the ballot in the ballot box regardless of whether
8 the ballot is blank or later rejected for any reason. In the
9 case of voting machines, "vote" means the voter has activated
10 the proper mechanism and fed the ~~[vote]~~ ballot into the machine.
11 In the case of an election by mail pursuant to part , "vote"
12 means the voter has returned the ballot to the chief election
13 officer or clerk by the United States Postal Service, by
14 personal delivery of the ballot to a place of deposit or voter
15 service center, or by electronic transmission under certain
16 circumstances pursuant to part .
17 (b) The clerk shall also identify or remove the name of
18 any registered voter~~[7]~~ if the clerk, after mailing a notice or
19 other correspondence, properly addressed, with postage prepaid,
20 receives the notice or other correspondence as return mail with
21 a postal notation that the notice or other correspondence was



1 not deliverable. On election day, any person identified or
2 removed shall have the person's name corrected or restored in
3 the register and shall be allowed to vote if the person
4 completes an affidavit or other form prescribed by the chief
5 election officer affirming that the person: [~~claims~~]

6 (1) Claims the person's legal residence at the address
7 listed on the register; [~~changed~~]

8 (2) Changed the person's legal residence after the closing
9 of the register for that election; or [~~, moved~~]

10 (3) Moved to a new residence within the same [~~precinct~~]
11 district as the person's residence as listed on the
12 register."

13 SECTION 8. Section 11-21, Hawaii Revised Statutes, is
14 amended to read as follows:

15 "§11-21 Change of name, transfer on election day. (a)

16 The [~~county~~] clerk may designate a registration clerk, who may
17 be an election official, at [~~any of the polling places~~] a voter
18 service center in the county on the day of the election.

19 (b) These registration clerks shall take applications for
20 change of name from voters who have been married or who have had
21 their names changed since the last election.



1 (c) Any person whose name appears on the registered voters
2 list whose residence has changed since the last election, and
3 whom the [~~county~~] clerk has not transferred under section 11-20,
4 may apply on a form prescribed by the chief [~~elections~~] election
5 officer [~~at the person's new polling place~~] on the day of the
6 election for transfer of registration to the [~~precinct~~] district
7 of the new residence. Any person so transferring voter
8 registration shall be immediately added to the register of the

10 each county shall be in proportion to its respective percentage
11 of registered voters.

12 The sums appropriated shall be expended by the department
13 of budget and finance for the purposes of this Act.

14 SECTION 59. No later than sixty days before the convening
15 of each of the regular sessions of 2020, 2021, 2022, 2023, 2024,
16 and 2025, the office of elections shall submit a report to the
17 legislature that includes:

- 18 (1) The office's progress in implementing this Act;
19 (2) A summary of the office's discussions with the county
20 clerks to determine areas of joint implementation of
21 this Act;



- 1 (3) A summary of the expenditures required to implement
2 this Act and a comparison of those expenditures with
3 the expenditures required to conduct elections or
4 election-related activities before the enactment of
5 this Act;
- 6 (4) Any additional resources the county clerks or the
7 office may require to implement this Act;
- 8 (5) Any developments in assistive technology that may be
9 implemented by the State, the counties, or nonprofit
10 associations to ensure that persons with disabilities
11 are not, on the whole, disadvantaged by implementation
12 of this Act, including the costs associated with such
13 technology;
- 14 (6) Any difficulties encountered in the implementation of
15 this Act;
- 16 (7) Specific steps taken and recommendations necessary to
17 prevent fraud and ensure the integrity of the election
18 process; and
- 19 (8) Any other findings and recommendations, including any
20 proposed legislation necessary to clarify and make
21 consistent chapters 11, 12, 15, 15D, 16, and 19,



1 Hawaii Revised Statutes, in light of the transition to
2 statewide elections by mail.

3 The counties shall coordinate with the office of elections in
4 providing information necessary for the preparation of the
5 reports required by this section.

6 SECTION 60. In codifying the new sections added by section
7 2 of this Act, the revisor of statutes shall substitute
8 appropriate section numbers for the letters used in designating
9 the new sections in this Act.

10 SECTION 61. If any provision of this Act, or the
11 application thereof to any person or circumstance, is held
12 invalid, the invalidity does not affect other provisions or
13 applications of the Act that can be given effect without the
14 invalid provision or application, and to this end the provisions
15 of this Act are severable.

16 SECTION 62. Statutory material to be repealed is bracketed
17 and stricken. New statutory material is underscored.

18 SECTION 63. This Act shall take effect on July 1, 2019.




